## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of

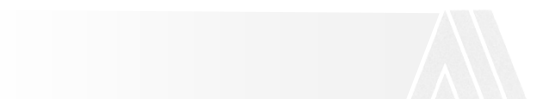

1. DESCRIPTION OF PLAN

The following description of The Employees' 401(k) Plan of the North Carolina Farm Bureau Mutual Insurance Company, Inc. ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 1998 by the North Carolina Farm Bureau Mutual Insurance Company (NCFB) and is a defined contribution 401(k) plan covering all employees of NCFB. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In addition, the Plan complies with the provisions of subsequent tax reform.

Contributions

Participants may elect to defer eligible compensation on a pre-tax basis, and after tax (Roth) basis, or a combination of both. The Plan permits participants to reduce their compensation in amounts from 1% up to the maximum deductible contribution allowed by the Internal Revenue Code. For 2024 and 2023, participant contributions for participants under the age of 50 may not exceed \$23,000 and \$22,500, respectively, or for any participant who is 50 years old or older, \$30,500 and \$30,000, respectively.

Under the terms of the Plan, the employer may make discretionary contributions to be allocated to employees who have met the eligibility requirements for participation and who are not highly-compensated employees for that Plan year. The discretionary contribution is allocated based upon the participant's share of the total compensation paid during that plan year to all participants eligible for the allocation. No such contributions were made in 2024 or 2023.

The Plan also permits eligible employees to make rollover contributions as permitted under Section 402 of the Internal Revenue Code.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participation and Vesting

Each employee who has completed 90 days of service at NCFB or its related company is eligible to participate in the Plan. The determination of service completed includes service completed prior to joining NCFB at North Carolina Farm Bureau Federation, Inc. and its related company which are affiliated with NCFB. An employee can become a participant on the first day of the month immediately following the date the employee satisfies the Plan eligibility requirements. Participation in salary deferral is elective; however, all eligible employees participate in the employer's discretionary contribution. Participant salary deferral contributions and employer discretionary contributions are fully vested and nonforfeitable at all times.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The participant may only have two loans outstanding at a given time. The loans are secured by the balance in the participant's account and bear interest ranging from 4.25% to 9.50%, which is based on the rates available for similar loans from commercial lending institutions at the time of issuance of the loan. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

Upon termination, death, disability, or retirement at age 65, the participant or beneficiary is entitled to distribution of the basic account and the employer discretionary contributions account as they exist at the end of the valuation period in which the distributable event occurs. The participant or beneficiary may elect to receive the distribution in a lump sum, in equal installments (annually, quarterly, or monthly), or in a partial lump sum, with the remainder distributed in equal installments.

Investment Options

The Plan provides that the trustee may permit participants to direct the trustee with respect to the investment or reinvestment of the assets comprising the participant's individual account. The Plan maintains various investment funds held by a bank-administered trust fund. Each participant shares in the value and earnings of each fund based on his or her pro rata share of ownership of fund shares..

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Operating Expenses

Fees paid to the Trustee in connection with the administration of the Plan are paid from the Plan's assets. All other administrative fees of the Plan are paid by the Company. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (participant loans and distributions) are charged directly to the participant's account.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for the Plan's investment in the fully benefit-responsive contract which is reported at contract value. Fair value, as defined under GAAP, is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-day basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

3. RELATED PARTY TRANSACTIONS

The Plan invests in a investment contract managed by Principal, who is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administration amounted to \$72,685 and \$66,152 for the years ended December 31, 2024 and 2023, respectively.

4. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

5. FAIR VALUE MEASUREMENTS

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1: Observable inputs such as quoted prices in active markets.
- Level 2: Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3: Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of assets and liabilities and their placement within the fair value hierarchy levels

5. FAIR VALUE MEASUREMENTS (CONTINUED)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

When quoted prices are available in active markets for identical instruments, investment securities are classified within Level 1 of the fair value hierarchy. Level 1 investments include mutual funds and collective investment trusts. The fair value is based on quoted net asset values (NAV) of the shares held by the Plan at year-end.

There are no Level 2 or 3 investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In 2024, the Plan changed the classification of collective investment trusts from NAV (used as a practical expedient to estimate fair value) to Level 1 investments as provided by the trustee. The 2023 disclosure related to fair value measurement has been changed to better allow for comparison. This change has no effect on the financial statements.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. FULLY BENEFIT-RESPONSIVE CONTRACT

In 2024, the Plan entered into a traditional benefit-responsive investment contract with the trustee through shares in Principal Life Insurance Company-Principal Fixed Income Guaranteed Option. Because this investment contract is considered fully benefit-responsive, contract value is the relevant measurement attribute. Contract value, as reported by the Plan, represents contributions made under the contract, plus accrued interest, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value without restrictions. Termination of the Plan's interest is subject to either a 12-month advance notice or a 5% surrender charge.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on the formula agreed upon by the issuer. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semi-annual basis for resetting but may not be less than 1%. There are no unfunded commitments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

8. TAX STATUS

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator and the Plan's tax council believe that the Plan has been designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

11. PLAN AMENDMENT

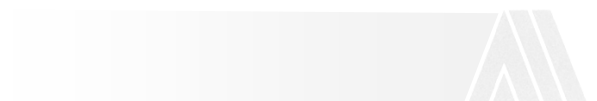
Effective January 1, 2023, the Company amended its Plan in order to allow for Roth deferrals and In-Plan Roth rollovers.
