NOTE 1 - DESCRIPTION OF THE PLAN AND NATURE OF OPERATIONS

The following description of the Canon Employee Savings and Retirement Plan (the “Plan”) provides general information about the Plan’s provisions. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution profit sharing and 401(k) savings plan sponsored and administered by Canon U.S.A., Inc. (the “Company”). The Company and several subsidiaries and affiliates (“Employer”) have adopted the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

An employee who is classified as a regular employee is eligible to participate in the Plan upon completion of 30 days of service, with no age requirement. An employee who is classified as a temporary employee shall be eligible to participate in the Plan if they have attained age 21 and have been credited with at least three (3) consecutive eligibility computation periods beginning after December 31, 2020, with at least 500 but less than 1,000 hours in each computation period. Eligible employees may make 401(k) contributions by voluntary payroll deductions. These payroll deductions are matched by the Employer based on specified percentages of employee contributions as described in the Plan document. The Plan also provides that the Employer may contribute amounts to the Plan from its annual profits at the discretion of the Board of Directors. One year of service eligibility is required to participate in the profit-sharing component of the Plan. The Plan provides growth in savings through contributions and income from its investments.

Management of the Plan

The Plan’s investment assets are managed by Vanguard Fiduciary Trust Company (“Vanguard”). Vanguard provides recordkeeping services, investment management, and investment options for the Plan, and serves as the Plan’s trustee. The Plan’s sponsor has also appointed a Policy Committee, Administrative Committee and an Investment Committee to assist in carrying out the provisions of the Plan.

Contributions and Vesting

All participants, upon entry into the Plan, elect the type of investment fund or funds into which their contributions will be invested. Participants may amend elections daily. The participants may contribute to the Plan, on a pre-tax basis, Roth (after-tax) basis, and on an after-tax basis (after-tax contributions), with specified percentages from 1% to 75% of eligible compensation, as defined in the Plan document. The Plan maintains a safe harbor plan design, which includes an auto enrollment provision whereby all newly eligible participants who have been employed for 30 days will be enrolled with a 3% pre-tax contribution rate of eligible pay unless they voluntarily enroll or opt out before then. Their contributions will be invested in the Vanguard Target Retirement Trust I with the target date closest to the year the participant will reach age 65. In addition, the Plan will provide for an automatic annual 1% increase in the contribution rate of participants automatically enrolled in the Plan up to a maximum contribution rate of 10% of eligible compensation as defined in the Plan document. The annual auto increase maximum is 15% of eligible compensation.

Participants are eligible to receive Employer matching contributions upon their eligibility to contribute to the Plan. The maximum matching contribution is 3.5% of participants’ eligible compensation. Employer contributions match 100% on the first 1% of participants’ eligible earnings that are contributed on a pre-tax or Roth (after-tax) basis and 50% on the next 5% of eligible earnings that the employee contributes on a pre-tax or Roth (after-tax) basis. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Additionally, the Employer may, at their discretion, make a profit-sharing contribution to employees' individual profit-sharing accounts based on a specified percentage of employees' eligible compensation. Profit sharing contributions are invested in the various funds at the discretion of the participant. Profit sharing contributions amounted to \$14,082 and \$13,602 in 2024 and 2023, respectively, and were included in Employer contribution receivable. Participants are not allowed to contribute to the profit-sharing component of the Plan.

Participants are vested immediately in their contributions plus actual earnings thereon. Participants fully vest in their Employer matching contribution and related earnings using a two-year cliff vesting schedule and are fully vested in their matching contributions when they reach their two-year anniversary with the Employer. For profit sharing contributions and related earnings thereon, participants become vested in accordance with the following schedule:

Participant Accounts

Each participant's account is credited with the participant's contributions and Employer matching contributions, as well as allocations of the Employer's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan.

Payment of Benefits

Participants are entitled to receive a distribution of their vested account balance in the Plan upon retirement, death, disability or separation from service. The forms of distribution are lump sum, partial payments and installments. The Plan allows for early withdrawals from 401(k) accounts by participants provided the participant has attained age 59½ or the participant is able to prove financial hardship, as defined by the Plan. Participants may take qualified birth or adoption distributions of up to \$5 of their vested account balance.

Forfeitures

A participant that terminates employment before becoming 100% vested forfeits the unvested portion of his or her account. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$858 and \$875, respectively. Forfeited balances of terminated participants' nonvested accounts are used for various purposes, including to reduce future Employer contributions or to pay plan expenses. In 2024, forfeited nonvested accounts of \$867 was used to reduce Employer contributions.

Notes Receivable From Participants

Participants may take loans against their vested 401(k) account balance. The repayment period varies depending on the type of loan. General purpose loans must be repaid within a five-year period with longer repayment terms permitted for primary residence loans. The loans may not exceed the lesser of \$50 or 50% of the participant's vested account balance, less the highest outstanding loan balance in the last 12 months. Participants are permitted to have no more than two loans outstanding at any one time. The interest rate on any loan shall be equal to the prime rate as reported by Reuters on the first business day

of the calendar month in which the participant requests a loan from the Plan plus 1%. Interest rates range from 4.25% to 10.50% for loans outstanding as of December 31, 2024, with maturities in varying amounts through 2049. Principal and interest are generally paid through weekly, bi-weekly or semi-monthly payroll deductions.

Termination of the Plan

The Company reserves the right, by action of its Board of Directors, to discontinue or amend the Plan in whole or in part; provided, however, that no amendment shall be made at any time pursuant to which the trust fund or any part thereof may be used for or diverted to purposes other than for the exclusive benefit of participants and their beneficiaries. Although the Company has not expressed any intent to do so, in the event the Plan is terminated, the participants would immediately become fully vested in all Employer contributions.

Plan Conversion

Effective December 31, 2024, BriefCam Inc. employee's assets were transferred to a qualified 401(k) Plan of an affiliate. As part of this transfer, participant account balances totaling \$2,536 were removed from the Plan as of December 31, 2024. In addition, \$61 was transferred to an affiliate plan effective September 13, 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan maintains its accounting records and prepares the accompanying financial statements on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan document.

Investments Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 3 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Adoption of Recently Issued Accounting Standards

The Company evaluated all recently issued accounting pronouncements applicable to the Plan's financial statements. No new accounting pronouncement issued or effective has had, or is expected to have, a material impact on the Plan's financial statements.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Money Market Funds: Valued at the daily closing price as reported by the fund.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trusts: Valued at the daily closing price as reported by the administrator of the fund. These funds are required to publish their daily NAV and to transact at that price. The collective trusts held by the Plan are deemed to have a readily determinable fair value.

The collective trusts generally provide for daily redemptions by the Plan at reported NAV per unit, without restriction. For Vanguard collective trusts, advance notice is required for large transactions, as defined on a fund or trust-specific basis. For Vanguard Retirement Savings Trust III, Vanguard requires a written notice of at least 12 months prior to the withdrawal. The Plan is permitted to withdraw from the trust with 30 days' notice, but the amounts received may be less than the book value, depending on the investment contracts held by the trust. There are no unfunded commitments for the collective trusts as of December 31, 2024 or 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

The Plan holds units of collective trusts and mutual funds managed by Vanguard, the trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

NEPC are investment consultants and fiduciaries to the Plan. Fees for services provided are paid by the Plan sponsor and are exempt from the prohibited transactions rules under ERISA.

Notes receivable from participants qualify as exempt party-in-interest transactions.

NOTE 5 - INCOME TAX STATUS

The Plan has received a determination letter from the IRS dated March 17, 2014, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the "Code"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 - SUBSEQUENT EVENTS

The Plan has evaluated events subsequent to December 31, 2024 through October 7, 2025, the date the financial statements were available to be issued. Effective October 1, 2025, the Plan changed its third party administrator from Vanguard to Empower.
