Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## **DR. PRAEGER'S SENSIBLE FOODS 401(k) PLAN NOTES TO FINANCIAL STATEMENTS**

### **NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Dr. Praeger's Sensible Foods 401(k) Plan (the "Plan"), sponsored by Dr. Praeger's Sensible Foods, LLC, provides general information only. The Plan includes participants from Sensible Foods, LLC (together with Dr. Praeger's Sensible Foods, LLC, the "Company"), which is a related party through common ownership. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all employees of the Company who have attained the age of 21. Eligible employees may enter the plan on the first business day of the Plan month after meeting the eligibility requirement. Eligibility for employer safe harbor contribution is based on the employee attaining age 21 and completing 1,000 hours worked over a consecutive 12 month period. The Plan was established by the Company as of October 1, 2003. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions** - The Company makes a safe-harbor contribution equal to 100 percent of an employee's contribution up to 4 percent of the employee's compensation.

Additionally, eligible participants who elect to participate can make pre-tax and after-tax "Roth" contributions to the Plan in an amount up to 90 percent of their compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Total participant contributions are subject to limitations imposed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined contributions plans (rollover).

The Company may, in its sole discretion, make profit-sharing contributions to the Plan on behalf of participants. Participants must complete 1,000 hours of service and be employed on the last day of the Plan year in order to receive profit-sharing contributions. No profit-sharing contributions were made by the Company for the plan year ended December 6, 2024.

**Participant Accounts** - Each eligible participant's account is credited with the participant's contributions and Company Safe Harbor matching contributions, as well as allocations of (a) the Company's profit sharing contribution, if any, and (b) Plan earnings; (c) charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - The Plan provides that participants shall be fully vested in their contributions and safe harbor match plus actual earnings thereon at all times. Employer non-safe harbor contributions are subject to a graded vesting schedule in which the participant is fully vested after 6 years of service or immediately upon disability.

**NOTE 1 - DESCRIPTION OF THE PLAN (Continued)**

*Payment of Benefits* - Participants or their beneficiaries are entitled to receive the entire amount of their interest in the Plan upon retirement, death, disability, employment termination, reaching age 59 ½ or qualifying for a "Hardship Distribution" as defined in the Plan. A terminated employee may elect to receive the balance in his/her account in the form of a single lump-sum payment or a direct rollover. For accounts with less than \$7,000, the Company can pay the participant in a lump sum at any time after the participant leaves the Company if the balance is \$1,000 or less. For balances between \$1,000 and \$7,000, amounts will be distributed to an IRA or annuity for the participant's benefit.

*Hardship Withdrawals* - The Plan allows for "hardship" withdrawals in accordance with the Internal Revenue Service regulations as specified within the Plan.

*Investment Options* - Upon enrollment in the Plan, a participant may elect a number of various investment options consisting mainly of mutual funds. All investment transactions are participant directed. As such, participants may make transfers among investment funds at their discretion in whole percentages. In addition, participants may elect to change their investment options daily.

*Notes Receivables from Participants* - Participants may borrow from their fund accounts up to an amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. The maximum payment term for any loan is five years. The minimum loan is \$1,000. A participant may have no more than 2 loans outstanding at a time. The loans bear interest at rates commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions. The loans are collateralized by the balance in the participant's account.

*Plan Expenses* - All costs and expenses with regard to the purchase or sale of investments are paid by the Plan. Investment related expenses are included in net appreciation of fair value of investments. The Company pays administrative expenses which are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's individual accounts are included in administrative expenses. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting* - The financial statements are presented on the accrual basis of accounting.

*Use of Estimates* - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

***Investment Valuation and Income Recognition*** - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits*** - Benefits are recorded when paid.

***Notes Receivable from Participants*** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 6, 2024 and December 31, 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Risks and Uncertainties*** - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

***Fair Value Measurements*** - ASC Topic 820 *Fair Value Measurements* defines fair value, establishes guidelines for measuring fair value, and expands disclosure regarding fair value measurements.

***Disclosure of Subsequent Events*** - Plan management has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

**NOTE 3 - INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, the Custodian for the Plan, has certified as to the completeness and accuracy of the investments and investment transactions of the Plan as of December 6, 2024 and December 31, 2023 and for the plan year ended December 6, 2024. The following information included in the accompanying financial statements and ERISA-required supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the Custodian:

**NOTE 4 - FAIR VALUE MEASUREMENTS**

ASC Topic 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 6, 2024 and December 31, 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust:* Valued at the NAV of units of a bank collective trust. The NAV as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

During 2024 and 2023, there were transactions involving the investment of Plan assets in accounts maintained by American Funds, a party-in-interest, as defined under Section 3(14) of ERISA.

American Funds receives revenue from mutual fund service providers for services American Funds provides to the funds. This revenue is used to offset certain amounts owed to American Funds for its administrative services to the Plan.

American Funds shares a portion of the revenue generated from such mutual fund service providers with the Plan. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, the Plan received \$7,457 in administrative fee credit.

**NOTE 6 - TERMINATION PRIORITIES**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE 7 - TAX STATUS**

The Plan sponsor has adopted a standardized prototype plan which received a favorable opinion letter dated June 30, 2020 from the Internal Revenue Service. The Plan itself has not received a determination letter from the IRS.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examination for years prior to 2021.

**NOTE 8 - PLAN TRANSFER**

On December 6, 2024, \$8,303,022 of Plan assets, representing all Plan assets as of that date, were transferred to Premier 401(k) Pooled Employer Plan ("PPEP") in a merger of the Plan with the PPEP.
