Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule (Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For



information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The certified investment information in the supplemental schedule agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

General

The following description of the Kogok Corporation 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established on January 1, 1998, under Section 401(k) of the Internal Revenue Code (IRC) and was most recently restated January 1, 2021. The Plan covers substantially all employees of Kogok Corporation (the Employer), who have completed 6 months of service and are at least 18 years of age. Entry date into the Plan is the first day of the quarter coinciding with or next following the date the employee has met the eligibility requirements. There is no age or service requirement for participants eligible to receive prevailing wage contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Custodian and Administration of the Plan

Capital Group Retirement Plan Services has been engaged to serve as the recordkeeper of the Plan and Capital Bank and Trust Company has been engaged to serve as the custodian of the Plan. Senior management serves as the Plan Administrator and trustees and are responsible for the day-to-day operations and oversight of the Plan.

Participant Contributions

Participants may elect to contribute a percentage of their eligible pre-tax compensation up to the amount allowable under current income tax regulations. Roth contributions are also permitted. A Roth deferral is an elective deferral the participant irrevocably designates as a Roth deferral and is subject to income tax when contributed to the Plan. Participants who elect to contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to limitations imposed by the Internal Revenue Code (IRC). Participants are permitted to make rollover contributions of amounts received from other tax-qualified employer sponsored retirement plans. Such rollover contributions are deposited in the appropriate investment funds in accordance with the participant's elections and the Plan's provisions.

Employer Contributions

The Employer may make discretionary matching contributions to all eligible employees. During 2024, the Employer matched \$0.50 for each dollar contributed by participants up to \$1,000. Employer discretionary matching contributions for the year ended December 31, 2024 totaled \$124,182. Additionally, the Employer may make discretionary profit-sharing contributions to the Plan. To be eligible for the discretionary matching and profit-sharing contributions, participants must have completed 6 months of service. There were no discretionary profit-sharing contributions for the year ended December 31, 2024. The Employer provides prevailing wage contributions for participants as required by certain government contracts. Prevailing wage contributions for the year ended December 31, 2024 totaled \$1,620,139.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer discretionary matching contributions, Employer prevailing wage contributions, as well as allocations of any Employer discretionary profit-sharing contributions and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their salary deferrals, employer prevailing wage contributions, rollover contributions, and related earnings thereon. Employer discretionary matching and profit-sharing contributions, and earnings thereon, are subject to the following vesting schedule:

Participants become fully vested in the event of retirement, death, and disability, as defined by the Plan.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Employer makes the respective payroll deduction from the participant's compensation. Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 and up to the lesser of \$50,000 less the highest outstanding note balance in the prior twelve-month period, or 50% of their vested account balance. The notes are secured by the participant's vested account balance and no more than one outstanding note is permitted at any time. Such notes bear interest at the prime rate published in the Wall Street Journal on the first business day of each month, plus 1% and must be repaid to the Plan within a five-year period, unless the note is used to purchase a principal residence. The specific terms and conditions of such notes are established by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Benefit payments are available to participants upon retirement (age 65), termination of employment, death, attainment of age 59 ½, or disability. Upon proof, to the satisfaction of the Plan Administrator,

of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for a hardship purpose. Participants are entitled to a benefit equal to the vested portion of their account balance, which will be distributed in the form of a lump sum payment, unless the participant elects another option provided by the Plan. Distributions are subject to the applicable provisions of the Plan agreement. In addition, upon termination, the Plan allows for automatic lump sum distributions to participant vested account balances that do not exceed \$5,000. Certain income taxes and penalties may apply to withdrawals or distributions prior to age 59 ½.

Forfeitures

Forfeited non-vested amounts may be used to pay plan administrative expenses or reduce Employer discretionary contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$27,096 and \$12,557, respectively. The Employer did not use any forfeitures during 2024 to pay administrative expenses or reduce employer discretionary contributions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements have been prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make note repayments and the Plan Administrator deems the note to be in default, the note balance is reduced, and a benefit payment is recorded based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Plan administration and recordkeeping fees are paid by the Plan and are included in administrative expenses. Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to specific participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust

Valued at the NAV of units of the trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Capital Bank and Trust Company or their subsidiaries and affiliates. The Plan made direct payments of approximately \$31,320 to Capital Group Retirement Plan Services for recordkeeper services, \$32,637 to The Pinnacle Financial Group for investment advisory services, and \$18,095 to United Benefit Pensions Inc. for third-party administrator services. Participant loan and distribution processing fees are paid to Capital Group Retirement Plan Services by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participant accounts will become fully vested and non-forfeitable.

7. Tax Status

The Plan uses a preapproved plan document sponsored by United Benefit Pensions Inc. United Benefit Pensions Inc received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the preapproved document, as then designed, satisfies the applicable

provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

9. Subsequent Events

Management has evaluated events and transactions for potential recognition or disclosure through, October 9, 2025, the date the financial statements were available to be issued.
