### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE A - DESCRIPTION OF PLAN

The following description of the Rescar Companies Profit Sharing and 401(k) Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan maintained for the benefit of eligible employees of Rescar Companies and subsidiary (together, the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

##### **Eligibility**

All employees aged 18 or older can participate in the Plan upon completion of three months of service. The employee must complete 1,000 hours of service from the employee's employment commencement date to be eligible for the Employer matching and profit-sharing contributions and must be actively employed on December 31 of the Plan year.

##### **Contributions**

Participants may elect to contribute an amount from 1% to 100% of compensation. Participants direct the investment of their account balances and future contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Profit-sharing and matching contributions by the Employer are made in discretionary amounts determined by their board of directors. Employer discretionary matching contributions were made to participants as of the end of 2024 for the amount equal to 26.20% of participants' contributions to the Plan, excluding catch-up contributions and net of forfeitures used. The Employer discretionary matching contribution before the use of forfeitures for the year ended December 31, 2024 was \$447,871.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of (1) the Employer's contributions and (2) Plan earnings and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, as defined, except expenses related to loans or distributions that are charged directly to the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Employer's discretionary matching and profit-sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service, becoming 20% vested after two years of service, with vesting increasing 20% for each additional year of service to a maximum of 100% after six years.

##### **Benefit Payments**

Upon termination of service, death, disability or retirement, a participant may elect to receive a lump-sum payment equal to the value of the participant's vested interest in his or her account. The Plan allows for withdrawals such as required minimum distributions, hardships, and in-service distributions for those who have reached the age of 59½ years old, subject to limitations and eligibility requirements as defined by the Plan.

***Notes Receivable From Participants***

Participants may borrow from their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of one half of their vested account balance or \$50,000, reduced by any outstanding loan balance in their accounts. Loan terms range up to five years, unless for the purchase of a principal residence, which may be repaid over a term of up to 30 years. Participants are only permitted to have two outstanding loans at a given time. The loans are secured by the balance in their participant accounts and bear interest at a fixed rate based on prime determined at the first business of the month when the loan originated, which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled to \$55,200 and \$55,023, respectively. These amounts were used to offset future Employer contributions. The 2024 Employer contribution, which was funded in 2025, was net of forfeited non-vested accounts totaling \$27,871.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements are prepared under the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Notes Receivable From Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on terms of the Plan document.

***Excess Contribution Payable***

Excess contributions payable are amounts due back to plan participants after consideration of regulatory contribution limitations of certain participants.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments and includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Expenses incurred in the administration of the Plan are paid by the Plan if not paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements.

#### **NOTE C - RISKS AND UNCERTAINTIES**

The Plan provides for investments that, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **NOTE D - FAIR VALUE MEASUREMENTS**

The Financial Standards Accounting Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds***

Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end as quoted on an active market.

**Collective Trust Funds**

Collective trust funds are valued at the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV's unit price is quoted on a private market. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The funds allow for daily liquidity with no additional days' notice required for redemption for participant-directed transactions. There are no unfunded commitments for the collective trust funds.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Participant loans are considered party-in-interest transactions and are exempt from the “prohibited transaction” provisions of ERISA and the Internal Revenue Code (IRC).

**NOTE F - TAX STATUS**

The Plan is a non-standardized prototype plan sponsored by Great-West Life & Annuity Insurance Company that has been adopted by the Employer. The prototype plan obtained its latest opinion letter on March 31, 2008, in which the Internal Revenue Service (IRS) stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan Administrator believes that the Plan is currently designed and being operated in all material respects with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G - INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE I - SUBSEQUENT EVENTS: PLAN TERMINATION**

Plan management evaluated the Plan's December 31, 2024 financial statements for subsequent events through October 10, 2025, the date the financial statements were available to be issued. Plan management is not aware of any subsequent events that would require recognition or disclosure in the financial statements, apart from below.

On July 13, 2025, the Plan Sponsor approved the termination of the Rescar Companies Profit Sharing and 401(k) Plan & Trust, effective June 12, 2025. The termination was initiated in accordance with the provisions of the plan document and applicable regulatory requirements.

As of the termination date, all participant account balances became fully vested. The Plan Sponsor has commenced the process of distributing plan assets to participants or transferring them to eligible rollover accounts. Final distributions to participants are expected to be completed before July 13, 2026.

The termination is considered a subsequent event and does not impact the financial position of the Plan as of December 31, 2024. However, it may affect future operations and disclosures in subsequent reporting periods.
