Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Gastro Health 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Gastro Health 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We are required to be independent of Gastro Health 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Gastro Health 401(k) Retirement Plan Notes to Financial Statements

1. Description of Plan

The following description of Gastro Health (“the Company”) 401 (k) Retirement Plan (“the Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan covering substantially all full-time employees of the Company who have completed one year of service, worked at least 1,000 hours and are age 19 or older. Date of eligible participation occurs immediately upon meeting all eligibility requirements. John Hancock Life Insurance Company serves as the custodian of the Plan. Various other entities serve as custodians of self-directed brokerage accounts.

The Plan was established on January 1, 2007, under Section 401(k) of the Internal Revenue Code, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Each year, participants may contribute up to 75% of pre-tax annual compensation or up to 75% after-tax to a Roth, as defined in the Plan, subject to a maximum of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. During the 2020 plan year, the Plan was amended to offer Roth 401K to provide an after tax option with retirement tax free withdrawals. The Company makes safe harbor contributions equal to 3% of the eligible employees’ salary to the Plan. The Company may also make discretionary contributions to the Plan.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contributions is based on years of continuous service. A participant is 100% vested after six years of credited service for the Company’s contributions plus actual earnings thereon.

Notes Receivable From Participants. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Under the CARES Act, plan participants were allowed to borrow up to 100% of the vested balance or \$100,000, whichever was less. The loans are secured by the balance in the participant’s account and bear interest at rates ranging from 4.25% to 6.75%. Principal and interest is paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investment Options. Upon enrollment in the Plan, a participant may direct their contributions into any of the investment options offered under the terms of the investment contract. There are several different mutual funds and investment options available to the participants, which includes pooled separate accounts and a self-directed brokerage account which can include mutual funds and common stock. Participants may change their investment options at their discretion.

Payment of Benefits. On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum payment paid directly to the participant or rolled over to an IRA, a partial “ad-hoc” distribution, or installment distributions but only with respect to the participant’s required minimum distributions. In the event of death or total and permanent disability, a participant’s account becomes fully vested.

1. Description of Plan (Cont'd.)

Payment of Benefits (Cont'd.). The non-vested portion of a terminated participant's account is forfeited and allocated to the employer contribution account of all participants who have not had a one-year break in service during the Plan year and who are employees as of the end of the Plan year. The forfeited amounts are allocated to a participant's account based on the proportion that each participant's basic compensation bears to the total basic compensation of all active participants. In addition, a participant can elect to receive all or part of their vested account at any time after reaching the age of 59 ½ or if the participant rolled over funds into this Plan from another qualified retirement plan.

Administrative Services. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Administrative expenses for the trustee are paid directly by the Company.

2. Summary of Significant Accounting Policies

Basis of Accounting. The financial statements are prepared using the modified cash basis of accounting. Contributions and interest income are recognized when collected and administrative expenses and benefits are recognized when paid.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. The Statements of Net Assets Available for Plan Benefits presents the fair value of the investment contracts. The Statements of Changes in Net Assets Available for Plan Benefits are prepared on a contract value basis.

Estimates. The plan administrator uses estimates and assumptions in preparing those financial statements in accordance with the modified cash basis of accounting. Those estimates and assumptions affect the reported amounts and disclosures. Actual results could vary from the estimates that were used.

Investment Valuation and Income Recognition. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Forfeited Accounts. At December 31, 2024 and 2023, there were \$50,254 and \$11,866 of forfeited non-vested accounts, respectively. These accounts can be used to reduce future employer contributions and fees. Also during the years ended December 31, 2024 and 2023, there was \$-0- and \$85,065, respectively, of forfeitures used to reduce contributions and fees.

Subsequent Events. The Company has evaluated subsequent events through October 3, 2025, the date these financial statements were available to be issued.

3. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

4. Income Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”).

Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

5. Risks and Uncertainties

The Plan provides for various investment options in any combination of stocks, bonds, fixed income securities, mutual funds, and other investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits and the Statements of Changes in Net Assets Available for Plan Benefits. The Company manages the Plan’s credit risk by offering participants diversified investment options.

6. Information Prepared and Certified by the Trustee

John Hancock Life Insurance Company (U.S.A.), the Trustee, holds all of the Plan’s investment assets and executes transactions in the assets.

8. Fair Value Measurements

The applicable guidance provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under the applicable guidance are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Investment Accounts: Valued at the observable net asset values (“NAVPE”) of the underlying mutual funds as obtained from the fund house or investment provider.

Self-Directed Brokerage Accounts: Self-directed brokerage accounts primarily consist primarily of cash equivalents, mutual funds, exchange traded stocks, common stocks, and limited partnerships.

8. Fair Value Measurements (Cont'd.)

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Stocks and Exchange Traded Stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Limited Partnerships: Valued as determined by the investment managers based on the estimated value of the various underlying holdings of the fund, partnership or private investment fund portfolio.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
