Note 1 - Description of Plan

A general description of the Essick Air Products, Inc. 401(k) Profit Sharing Plan & Trust (the Plan) is provided in the following paragraphs. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The following entities are herein referred to as the "Participating Companies": Essick Air Products, Inc. and other companies under common control.

General - The Plan is a defined contribution plan covering substantially all employees, except as noted in the plan documents, of the Participating Companies who are age eighteen or older. Employees are eligible to participate regarding employee 401(k) and employer safe harbor matching contributions on their hire date. The Plan also contains a profit-sharing feature which allows the Participating Companies to make discretionary contributions to the Plan. Employees are eligible to participate in the profit-sharing feature if they are employed on the last day of the Plan year or have completed 500 hours of service, as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants may contribute through payroll deductions and eligible rollover contributions. Subject to certain limitations under the Internal Revenue Code, participants may contribute up to 100% of eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Participating Companies make safe harbor matching contributions equal to 100 percent of the first three percent and 50 percent of the next two percent of a participant's compensation that a participant contributes to the Plan. Additional profit-sharing amounts may be contributed at the option of the Board of Directors of each Participating Company.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of the appropriate Participating Company's contributions and Plan earnings, and charged with the participant's withdrawals, Plan losses, and an allocation of administrative expenses. Allocations are based on participant contributions, account balances, or compensation, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their salary deferral contributions, rollover contributions, and safe harbor matching contributions made by Participating Companies', plus actual earnings thereon. Vesting in any Participating Companies' discretionary profit-sharing contributions, and any earnings thereon is based on years of credited service. Under the Plan's graded vesting schedule, a participant is 100 percent vested after six years of credited service, or upon the occurrence of certain events as defined in the Plan document.

Investment Options - Plan investments are participant directed. Upon enrollment in the Plan, a participant may direct contributions to several investment fund options. Participants may change or transfer their investment options at any time via telephone or a secure internet website.

Payment of Benefits - Following termination of service due to death, disability, or retirement, or other reasons, a participant will be eligible to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum payment or a direct transfer. The payment is available to the participant as soon as administratively feasible under the terms of the Plan. If a terminated participant's account balance is equal to or less than \$5,000, the account can be automatically distributed in a lump sum payment. In-service withdrawals from specified accounts may be permitted upon attainment of age 59½.

Forfeited Accounts - Forfeitures can be added to the employer safe harbor matching or profit-sharing contributions, used to restore forfeitures, or to pay reasonable Plan expenses. During the years ended December 31, 2024 and 2023, forfeitures in the amounts of \$674 and \$575, respectively, were used to pay Plan expenses. There were \$227 and \$673 forfeited non-vested accounts available for future use as of December 31, 2024 and 2023, respectively.

Note 1 - Description of Plan (Continued)

Administrative Expenses - The Plan is responsible for paying all Plan expenses unless the Participating Companies determine to pay them. Administrative expenses consist primarily of fees charged by third-party service providers.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting generally accepted in the United States.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes gains and losses on investments bought and sold, as well as held during the year.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Note 3 - Tax Status

The Plan and trust established under the Plan to hold the Plan's assets obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. The plan administrator believes that the Plan and trust are designed and being operated in compliance with the applicable requirements of the IRC. Accounting principles generally accepted in the United States require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS for plan years subsequent to 2020. However, there are currently no audits in process for any open tax period.

Note 4 - Plan Termination

Although they have not expressed any intent to do so, the Participating Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 5 - Risks and Uncertainties

The Plan invests in money market mutual funds and bank common trust funds. Such investments, in general, are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 - Fair Value Measurement

The Plan utilizes an accounting standard for fair value measurement, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about fair value measurements.

The standard defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The standard also establishes a fair value hierarchy that requires the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

- Level 1 Inputs - Quoted prices in active markets for individual assets or liabilities.
- Level 2 Inputs - Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets; quoted prices for similar assets or liabilities in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 Inputs - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The inputs used for valuing assets are not an indication of the risk associated with investing in those assets. The Plan has no assets that use level 3 inputs to measure fair value.

Financial assets and liabilities measured at fair value on a recurring basis include the following:

Mutual Funds - Valued at the closing price reported on the active market on which the individual securities are traded.

Fixed Annuities - Values are reported daily and based on the method disclosed in the annuity contract, as calculated by the annuity provider.

Note 8 - Party-in-Interest Transactions

Arvest Bank, investment advisor of the Plan and former investment custodian, is owned by Arvest Bank Group, Inc., whose majority owners include owners of Essick Air Products, Inc. Therefore, administration and investment expenses paid to the investment advisor qualify as party-in-interest transactions. Investment expenses paid by the Plan to Arvest Bank were \$24,374 in 2024 and \$23,742 in 2023. Administration expenses paid to Empower Annuity Insurance Company of America were \$28,182 in 2024 and \$31,125 in 2023. In 2024, the Plan changed third-party administrators from Retirement, LLC to Definiti, LLC. The plan paid \$9,719 to Definiti, LLC in 2024, and paid \$60 and \$14,611 to Retirement, LLC in 2024 and 2023, respectively.
