Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Classic Coal Sales, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Plan Description

The following description of the Classic Coal Sales, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan covering all eligible employees of Classic Coal Sales, Inc. (the “Company”), the employer of a controlled group made up of Baystar Coal Company, Inc., Raw Coal Mining Company, Inc., Sally Ann Coal Company, Inc., Shane Coal Company, Inc., Skyway Strip, Inc., Squeeze Security Group, Inc., Superior Processing, Inc., Timco Energy, Inc., Tramlane, Inc., Triple G Coal Company, Inc., and Twin City Motor Exchange, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All employees, as defined, are eligible to participate in the Plan. No age or service requirement is required for elective deferrals and participants must reach the age of twenty-one (21) and have completed one (1) year of service to be eligible for non-elective safe harbor and discretionary profit-sharing contributions.

Contributions

Each year, participants may contribute a portion of their eligible compensation, as defined in the Plan, up to the maximum allowed by the *Internal Revenue Code (IRC)* as pre-tax deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contribution into various investment options offered by the Plan. For 2024 the Company made a contribution to eligible participants of 4% of eligible compensation.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions as well as in the Company’s safe harbor and profit-sharing contributions plus actual earnings thereon.

Payment of Benefits

Upon attainment of normal retirement age of sixty (60), termination of service due to disability, or in the case of death, a participant or their beneficiary will receive the vested portion of the amount credited to the participant’s account. The participant receives periodic payments over a time period, as defined, chosen by the participant or in a lump sum. If the participant’s balance is under \$7,000 upon termination, the participant’s vested interest in his or her account may be automatically distributed. Participants age 60 or older may receive in-service withdrawals from their deferral and

employer funded accounts. Hardship withdrawals are also permitted, subject to the provisions described in the Plan document.

Administration

The Company administers the Plan through an agreement with Benefit Plan Administrative Services, LLC (“BPAS”). The Plan’s assets are held by the custodian, Hand Benefits & Trust Company (“HB&T”). Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan.

Administrative Costs

Certain administrative expenses are paid by the Plan and remaining expenses are paid by the Plan’s sponsor and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefits are recorded when paid.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Mutual funds are public investment vehicles valued using the Net Asset Value ("NAV") provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The cash managed fund is valued at cost which approximates fair value.

Note 4 – Related Party Transactions and Parties-in-Interest

HB&T is the custodian and BPAS is the third-party administrator as defined by the Plan. The Plan paid \$31,467 in custodial and administrative fees in 2024. Employees of the Plan Sponsor perform administrative duties and provide bookkeeping services to the Plan without additional compensation from the Plan. The Plan Sponsor absorbs the significant costs of the Plan.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions anytime and to terminate the Plan subject to the provisions of ERISA.

Note 6 – Tax Status

The Plan was adopted under a pre-approved profit-sharing plan arrangement with BPAS. BPAS received a letter from the Internal Revenue Service dated June 30, 2020, stating that its non-standardized pre-approved profit-sharing 401(k) plan is designed in accordance with applicable sections of the *IRC*. The Plan Administrator and the Plan's tax counsel believe the Plan is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
