The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1. Description of the Plan

The following description of the Novares US LLC 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution and 401(k) plan established to provide employees of Novares US LLC (the Company) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA). The Company is the plan sponsor. Fidelity Management Trust Company (the Trustee) serves as the trustee and third-party administrator of the Plan. All investments are self-directed by Plan participants. The Plan was established on July 1, 1966, and amended and restated effective October 22, 2021.

Eligibility

Active employees who are age 18 or older, except members of a collective bargaining group, become eligible to enter the Plan on the first day of the month following their month of hire. On the date an employee becomes eligible to participate, they are automatically enrolled with a 3% wage deferral unless the employee specifically waives participation.

Contributions

Employees may contribute through payroll deductions up to 20% of their annual compensation, but not more than the Internal Revenue Code ("IRC") imposed limit established each year. Participants who have attained age 50 or older before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified plans.

The Company, at its discretion, may make matching contributions for eligible participants as further defined in the plan document. For the years ended December 31, 2024 and 2023, no discretionary matching contributions were made. To be eligible for employer matching and profit sharing contributions, participants must have a minimum of six months of service and be employed by the Plan Sponsor on the last day of the contribution period. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a stable value common collective trust as investment options for participants. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

During 2024 and 2023, the company matched 50% of each participant's contributions, up to a maximum of 4% of eligible compensation for a maximum match of 2% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching and discretionary contributions and allocations of plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based upon participant earnings or losses or account balances, as defined by the plan document. Participants who initiate a loan or certain benefit payments are charged a fee for that transaction. The benefit to which a participant is entitled is the vested portion of the participant's account. Contributions to the Plan are invested by the trustee as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Vesting

Participants are immediately vested in their 401(k) voluntary contributions plus actual earnings thereon. Vesting in the Company discretionary matching and profit sharing contributions is based on years of continuous service. Participants begin vesting in Company discretionary matching and profit sharing contributions after one year of credited services and become 100% vested after four years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at any time. Principal and interest is paid ratably through payroll deductions. Loan terms range from 1 to 5 years or longer if the proceeds are used for the purchase of a primary residence. The loans are collateralized by the balance in the participant's account and bear interest at a rate commensurate with the local prevailing rates as determined by the Plan Administrator. Loans are measured at their unpaid principal balance plus any accrued, but unpaid interest. As of December 31, 2024, the interest rates on the outstanding loans ranged from 4.25% to 9.50% per annum. Principal and interest are paid ratably through payroll deductions.

Withdrawals

In the event of retirement (as defined), death, permanent disability, termination of employment, or financial hardship (as defined), the vested balances in a participant's account may be distributed to the participant or the participant's beneficiaries in a lump sum or through payments in such other forms as may be available under the Plan.

For termination of service or for other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. If the participant's account balance is \$1,000 or less, payment will be made in an immediate lump-sum without the participant's consent. If the account balance is greater than \$1,000 but less than \$5,000, payment will be made to an individual retirement account at the trustee, or such other provider as the Company designates in accordance with Department of Labor ("DOL") guidelines, unless the participant requests a different disposition of his or her account balance within the applicable election period.

In-service withdrawals of vested balances may be elected by participants who have reached 59½ years of age. The Plan also permits withdrawals of active participants' elective contributions, only in amounts necessary to satisfy financial hardship as defined by the Plan agreement.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,841 and \$44,323, respectively. The account is available to be used to pay Plan expenses and to reduce future employer contributions. During the year ended December 31, 2024, \$73,451 of forfeitures were used to pay administrative expenses. There were \$35,853 in new forfeitures added to the forfeited non-vested accounts during the year-ended December 31, 2024. During the year ended December 31, 2023, \$96,394 of forfeitures were used to pay administrative expenses. There were \$35,013 in new forfeitures added to the forfeited non-vested accounts during the year-ended December 31, 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices. Investments in the common or collective trust stable value fund are valued at the net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liability. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Plan recordkeeping, administrative, and consulting fees are allocated to participant accounts based on account balances. Participant-specific fees such as loan processing fees are charged directly to the appropriate participant account. All other expenses are paid by the Company.

Note 3. Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements, that was prepared by or derived from information provided by Fidelity Management Trust Company, the trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained a certification from the trustee that such information is complete and accurate.

Note 4. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) *Topic 820 Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Recurring Measurements

Following is a description of the valuation methodologies used for assets measured at fair value:

- Shares of mutual funds are valued using quoted market prices in an active market.
- Common collective trust funds are stated at fair value, which is determined by the trustee of the common collective trust based on the underlying assets, which represent the net asset value of units held by the trust. The common collective trust fund invests primarily in fixed income securities and shares of money market funds. The common collective trusts do not have unfunded commitments relating to its investments, or any significant restrictions or redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6. Income Tax Status

Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by FMR LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in funds that invest in investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investments securities, could occur in the near term and that such changes could materiality affect participant account balances and the amounts reported in the financial statements.

Note 8. Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and common/collective trust managed or issued by Fidelity Management Trust Company (“the Trustee”) and administrative expenses are paid by the Plan to Fidelity. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for trustee and recordkeeping amounted to \$15,050 and \$16,632 for 2024 and 2023, respectively. Fees paid by the Plan for advisory services amounted to \$69,841 and \$92,291 for 2024 and 2023, respectively. Fees paid by the Plan to Strategic Advisors, Inc. amounted to \$5,268 and \$7,444 for 2024 and 2023, respectively.
