Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Genesis Employer Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate to the best of their knowledge and belief.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matters

As discussed in Note 1 to the financial statements, the Board of Directors of Trinity Health, the Plan Sponsor, voted on September 25, 2024, to freeze the Plan effective December 31, 2024.

As discussed in Note 2 of the financial statements, effective July 1, 2025, the Plan merged into the Trinity Health 401(k) Retirement Savings Plan (the Trinity 401(k) Plan).

Our opinion is not modified with respect to these matters.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

Note 1. Plan Description

The following description of the Genesis Employer Contribution Plan (the Plan) provides only general information. Participants should refer to the plan document for more complete information.

General: The Plan is a contributory defined contribution plan. Eligible employees of GenVentures, Inc. (a wholly owned subsidiary of Genesis Health System, Employer) could participate in the Plan for the purposes of elective deferral contributions and employer match contributions as described in the Eligibility section and Contribution section below. Genesis Health System employees, who were also participants in the Genesis Health System Retirement Savings Plan (Genesis RSP), were eligible for employer match and discretionary contributions as described below. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA). The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. Effective October 1, 2024, the Plan was amended to transfer sponsorship of the Plan from Genesis Health System to Trinity Health (Plan Sponsor).

Eligibility: Employees of GenVentures, Inc. were immediately eligible to participate in the Plan for purposes of elective deferral contributions and became a participant effective the first day of the pay period coinciding with or immediately following their date of hire. GenVentures, Inc. employees who had completed a year of service (1,000 hours of service) and were age 18 or older were eligible to participate in the Plan for purposes of the employer match contributions. A GenVentures, Inc. employee who became eligible for employer match contributions became a participant with respect to such contributions effective on the first day of the plan year during which the employee met eligibility requirements. Participants of the Genesis Health System Retirement Savings Plan were eligible for matching contributions in the Plan if they were age 18 or older and had completed 1,000 hours of service. Participants were eligible for discretionary contributions, if any, if they were age 18 or older, had completed 1,000 hours of service and were employed on the last day of the Plan year. The Plan was amended effective December 31, 2024, to freeze the Plan. No current or former employees of the Employer and no inactive participants of the Plan can become an active participant after this date.

Contributions: All employees of GenVentures, Inc. were automatically enrolled in the Plan when they became eligible with a deferral contribution rate of 4% of eligible compensation, unless they made another election or specifically opted out. Employees who were automatically enrolled had the option to opt out of automatic deferrals at any time. Deferral percentages for those employees who were automatically enrolled would increase by 1% annually until their deferral rate reached 6%, unless they opted out of the increase. Participants could contribute up to the maximum percentage of compensation of dollar amount permissible under Section 402(g) of the Internal Revenue Code (the Code), not to exceed certain limits of other Code Sections. Participants could also contribute amounts representing distributions from other qualified defined contribution plans (rollovers).

GenVentures, Inc. made employer safe harbor matching contributions in an amount equal to 100% of the first 3% of employee salary deferral contributions, plus 50% of the next 2% of employee salary deferral contributions (maximum employer match contribution is 4% of eligible compensation). Employer match contributions for GenVentures, Inc. employees was approximately \$293,000 for the year ended December 31, 2024.

The Plan also provided employer match and discretionary contributions for eligible participants of the Genesis RSP. Employer match contributions were equal to 25% of the first 10% of employee salary deferral contributions, up to a maximum of 2.5% of eligible compensation. The Plan also had a discretionary contribution for eligible participants of the Genesis RSP. Participants must be employed on the last day of the plan year to receive the discretionary contribution. Employer match contributions for eligible participants of the Genesis RSP totaled approximately \$4,320,000 for the year ended December 31, 2024. There were no employer discretionary contributions for the eligible participants of the Genesis RSP for the year ended December 31, 2024.

Note 1. Plan Description (Continued)

Effective December 31, 2024, the Plan was amended to freeze the Plan to future contributions.

Participant accounts: Each participant's account was credited with the participant's contributions, if any, the applicable employer match and discretionary contributions and allocations of plan earnings and charged with an allocation of plan administrative expenses. Allocations of plan administrative expenses and earnings are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows each participant to choose their own investment mix for salary deferrals and employer contributions. Participants can change their investment mix daily.

Vesting: Employees were immediately vested in their contributions plus actual earnings thereon. Vesting of employer match contributions and safe harbor matching contributions received from Gen Ventures, Inc. and earnings thereon was 0% for less than two years of service and 100% after two years of service.

Vesting of employer match and discretionary contributions deposited to the Plan for eligible participants of the Genesis RSP and earnings thereon was based on a five-year graded schedule with vesting as follows:

Forfeitures and revenue sharing: Forfeitures of terminated participant accounts and amounts received from revenue sharing contracts were used to pay plan expenses and reduce future employer contributions. Forfeitures and revenue sharing of \$2,866 were used to pay plan expenses and \$432,000 were used to reduce employer contributions to the Plan for the year ended December 31, 2024. Unallocated forfeitures and revenue sharing of \$33,501 and \$183,261 are included in net assets as of December 31, 2024 and 2023, respectively.

Notes receivable from participants: Participants were allowed to borrow up to the lesser of 50% of their vested account balance or \$50,000. The loans are secured with the participant's vested account balance and bear interest at a rate commensurate with the prime daily rate plus 1%. Principal and interest are paid directly to the third-party administrator, Transamerica Retirement Solutions, LLC, over a maximum five-year period for personal loans and a 10-year period for primary home purchases.

Payment of benefits: Upon termination of service, a participant may elect to receive an amount equal to the value of their vested account balance in a lump-sum payment, installments or a combination of lump sum and installments. If the participant's vested account balance does not exceed \$1,000, then the participant will receive their benefit in a lump-sum payment. In the event of a mandatory distribution for participants with vested account balances greater than \$1,000, but less than \$5,000, their benefit will be rolled over to an individual retirement account (IRA).

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee through September 30, 2024 and the Trinity Health Benefits Committee effective October 1, 2024, determines the Plan's valuation policies utilizing information provided by the custodians. See Note 6 for discussion of fair value measurements.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Delinquent loans are treated as distributions based upon the terms of the plan document. Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, part IV, line 4i—schedule of assets (held at end of year).

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain expenses related to plan investments are paid from the assets of the Plan and are netted with investment income on the statement of changes in net assets available for benefits. The Plan also pays third-party administrator, investment consultant and annual audit fees. All other plan expenses are paid by Genesis Health System.

Note 2. Summary of Significant Accounting Policies (Continued)

Allowance for credit losses: The measurement of expected credit losses under the current expected credit loss (CECL) methodology is applicable to financial assets measured at amortized cost, which include employer and participant contributions receivable. An allowance for credit losses under the CECL methodology is determined using the loss-rate approach and measured on a collective (pool) basis when similar risk characteristics exist. Where financial instruments do not share risk characteristics, they are evaluated on an individual basis. The CECL allowance is based on relevant available information, from internal and external sources, related to past events, current conditions and reasonable supportable forecasts. Management provided for no allowance for credit losses as of December 31, 2024 and 2023, as all amounts were determined to be fully collectible.

Plan termination: Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

Effective July 1, 2025, the Plan was merged into the Trinity Health 401(k) Retirement Savings Plan.

In connection with the Plan merger, the Transamerica Guaranteed Investment Option (GIO) was frozen to new investments as of July 1, 2025 and the 3-year payout method was selected under the GIO contract so that participant balances in the GIO are automatically transferred out of the GIO to the Vanguard Treasury Money Market fund. Transition out of the GIO during this 3-year period will be made in 4 annual installments with the first having occurred July 1, 2025. The GIO will be benefit-responsive during the 3-year period, (e.g., typical participant transactions will be permitted, such as, eligible distributions, balance transfers out, etc.).

Note 3. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document, however; the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4. Benefit-Responsive Investment Contract

The Plan holds a traditional investment contract with Transamerica Life Insurance Company (TLIC). TLIC maintains the contributions in a general account. The account is created with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Note 4. Benefit-Responsive Investment Contract (Continued)

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than 1.20%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan's ability to receive amounts due in accordance with a fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its contractual obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

Note 6. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued based on quoted prices in the active markets on which they are traded.

Personal choice retirement account: Self-directed brokerage accounts primarily consisting of mutual funds that are valued based on quoted prices in the active markets on which they are traded.

Common collective trusts: Valued at net asset value (NAV) of shares held by the Plan based on the market value of its underlying investments as determined by the custodians. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7. Risks and Uncertainties

The Plan invests in various investments securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Note 8. Related-Party and Party-In-Interest Transactions

Plan investments in a fixed fund and certain mutual funds, common collective trust funds and personal choice retirement accounts are managed by TLIC and SSBTC, the Plan custodians; therefore, transactions within these investments qualify as party-in-interest transactions.
