**SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT**

We performed audits of the accompanying financial statements of the Klein's ShopRite of Maryland 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **NOTE 1**    **DESCRIPTION OF PLAN**

The following description of the Klein's ShopRite of Maryland 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering all full-time employees of Klein's ShopRite of Maryland; Klein's Tower Plaza, Inc.; Klein's of Bel Air, Inc.; Klein's of Aberdeen, Inc.; Klein's Festival at Bel Air; Klein's at Riverside, Inc.; Klein's of Cardiff, Inc.; Klein's of Jacksonville, Inc.; Forest Hill Lanes, Inc.; Beards Hill Plaza Liquors; ShopRite of Perring Parkway, LLC; and ShopRite of Liberty Heights, LLC (collectively referred to as the Company), who are at least 21 years old and who complete at least one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Participants may voluntarily contribute a percentage of total compensation for any Plan year, not to exceed the maximum amount permitted under the Internal Revenue Code. All eligible participants are automatically enrolled to make a 5% deferral unless the participant requests otherwise.

The Company, at its option, makes matching contributions equal to 50% of the participant's contributions not to exceed 5% of a participant's compensation.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of the Company's matching contributions and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in Company contributions is based on years of service. A participant is 100% vested after six years of service. A participant becomes fully vested upon death, disability (as defined by the Plan), or retirement.

***Investment Options***

Upon enrollment in the Plan, participants may direct their contributions into various investment options offered by the Plan. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

*(See Independent Auditors' Report)*

***Notes Receivable From Participants***

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable mature within five years or a period to be determined by the Company for the purchase of a primary residence. The notes receivable are collateralized by the balance in the participant's account and bear interest at prevailing market rates. Notes receivable are repaid through payroll deductions and may be repaid in full at any time.

***Payment of Benefits***

Benefits are payable following normal retirement at age 65, death, disability, or termination of employment, subject to the specific benefits payment requirements in the Plan Agreement.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$38,910 and \$17,362, respectively. These accounts will be used to reduce future Company contributions in accordance with the Plan Agreement. During the year ended December 31, 2024, Plan expenses were reduced by \$38,713, and employer contributions were reduced by \$9,719 from forfeited non-vested accounts.

***Plan Termination***

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all interests of the participants not previously vested would become vested and non-forfeitable, and the net assets of the Plan would be distributed to participants based upon individual equities in the Plan.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Company. In addition, the Company provides services to the Plan without charge.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Accounting Standards Codification***

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

*(See Independent Auditors' Report)*

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

***Valuation of Investments***

Investments are stated at fair value, except for fully benefit responsive investment contracts which are reported at contract value. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Risk and Uncertainties***

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

***Notes Receivable From Participants***

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Agreement.

***Payment of Benefits***

Benefits are recorded when paid.

**NOTE 3 VALUATION OF INVESTMENTS**

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs

to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Codification are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology for the years ended December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 INVESTMENT IN STABLE VALUE CONTRACT**

The Plan has an investment in the Transamerica Stable Value Focus Option, which is a fully benefit responsive investment contract and, therefore, reported at contract value. Contract value, as reported to the Plan by the Custodians of the Plan, represents contributions made under the fund, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with issuer. Such events include the following: (a) amendments to the Plan Agreement (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The stable value contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 5 INFORMATION CERTIFIED BY THE CUSTODIANS**

The Plan's investments were held by the Custodians, Reliance Trust Company, Transamerica Trust Company, and Transamerica Life Insurance Company. Transamerica Trust Company and Transamerica Life Insurance Company held the Plan's investment assets and executed investment transactions as of December 31, 2024 and for the period from July 1, 2024 through

December 31, 2024. Reliance Trust Company held the Plan's investment assets and executed investment transactions as of December 31, 2023 and for the period from January 1, 2024 through June 30, 2024. Financial information related to those investments at December 31, 2024 and 2023 is included in the accompanying financial statements based on information certified as complete and accurate by the Custodians. **NOTE 6 TAX STATUS**

The Plan obtained its latest determination letter on June 30, 2020, wherein the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan was amended since receiving the determination letter. However, the Plan Administrator and tax counsel believe the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.

**NOTE 7 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the Custodians of the Plan. These transactions qualify as party-in-interest transactions. The Plan pays investment management and recordkeeping fees to parties in interest. The Plan paid approximately \$148,000 to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
