A. Description of the plan:

The following description of the Childrenfirst 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of Millennia Pediatrics, LLC (the "Company"), who have completed ninety days of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participants may contribute up to 100% of compensation, as defined in the Plan, subject to Internal Revenue Code limitations. Participants who have attained the age of fifty before the end of the Plan year are eligible to make catch-up contributions. The Company's contributions to the Plan are at its discretion. The Company did not make or elect to make any discretionary contributions during 2024 and 2023. Participants direct the investment of their accounts into various investment options offered by the Plan.

Voluntary "rollover" contributions may be accepted by the Plan under certain terms and conditions.

Participant accounts:

Each participant's account is credited with the participant's contributions plus Company matching contributions and allocations of the Company's discretionary profit sharing contribution and Plan earnings, and is charged with administrative expenses, as required. Allocations are based on participant compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)
DECEMBER 31, 2024 AND 2023

A. Description of the plan (continued):

Vesting:

Participants are immediately vested in all their contributions plus actual earnings thereon. Vesting in the Company's contributions plus actual earnings is based on years of service. Participants are vested in the Company's contributions and earnings thereon based on a three-year cliff schedule. Any participant employed at the date of total and permanent disability, death or the attainment of normal retirement age, as defined, is deemed to be 100% vested.

Participant notes receivable:

Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan terms range from one to five years or longer if for the purchase of a primary residence. The loans are secured by the balance in the participants' accounts and bear interest at rates commensurate with local prevailing rates, as determined by the plan administrator at the time of issuance. Principal and interest are repaid ratably through payroll deductions.

Forfeitures:

Forfeited accounts represent non-vested Company contributions forfeited by employees who terminate their employment or withdraw from the Plan. Forfeitures are retained by the Plan and used to reduce future Company contributions and administrative expenses. At December 31, 2024 and 2023, there were no forfeited non-vested accounts.

Payment of benefits:

Upon termination of service, death, disability or retirement, a participant may elect to receive a lump-sum payment equal to the vested value of his or her account.

The Plan also allows for in-service distributions of the participant's vested accounts upon reaching the age of 59½ or under certain qualifying conditions, as defined by the Plan.

B. Summary of significant accounting policies:

Basis of accounting:

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles (GAAP).

Use of estimates:

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

The change in fair value of investments and realized gains (losses) are reflected in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. The realized gains or losses on investments are the difference between the proceeds received and the fair value of the investment sold at the beginning of the Plan year.

Participant notes receivable:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Payment of benefits:

Benefits are recorded when paid.

C. Information prepared and certified by custodian:

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The investment information included in the accompanying financial statements and supplemental schedule was obtained from data that has been certified as complete and accurate to the plan administrator by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, "Empower"), the custodians of the Plan at December 31, 2024 and 2023. Incorporation of this financial information in the accompanying financial statements and supplemental schedule is based solely on those certifications.

The investment income reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024 was certified by Empower.

D. Fair value measurements:

The Fair Value Measurements and Disclosures Topic of FASB ASC requires disclosure of a fair value hierarchy of inputs the Plan uses to value an asset or a liability. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1: Quoted and readily available prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date. For the Plan, Level 1 inputs include marketable securities that are actively traded.

Level 2: Inputs other than Level 1 that are observable for the asset or liability, either directly or indirectly. For the Plan, Level 2 inputs include pooled separate accounts which are valued daily.

D. Fair value measurements (continued):

Level 3: Inputs that represent financial assets and liabilities whose values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. The Plan did not have any Level 3 assets at December 31, 2024 or 2023.

Following is a description of the valuation methodologies used for assets measured at fair value during the year ended December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended funds that are registered with the National Securities Clearing Corporation and/or directly from the fund house or secondary pricing source.

Pooled Separate Accounts: Valued at the quoted price of the underlying mutual fund and adjusted by expense factors in accordance with annuity contracts on a daily basis.

Collective Investment Trusts: Valued at the net asset value of shares held by the Plan at year end using a practical expedient to estimate fair value or using the fair value of pooled separate accounts and mutual funds that comprise the collective investment trusts depending on the assets held by the collective investment trusts at year end.

Guaranteed Investment Contracts: Guaranteed investments contracts are valued at contract value by the Custodian.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. Guaranteed investment contracts:

The Plan has a traditional, fully benefit-responsive investment contract (the "Contract") with the Custodian. The Custodian maintains the contributions in a general account. The Contract is credited with earnings on underlying investments and is charged for participant withdrawals and administrative expenses. The Contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the Contract, plus investment income credited to the Contract based on contract rates currently earned by Empower, less funds used to make benefit payments to participants and to pay administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract value of the traditional investment contract at December 31, 2024 and 2023 was \$140,816 and \$182,548, respectively. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

E. Guaranteed investment contracts (continued):

Certain events, such as the premature termination of the Contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Empower. The Plan administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with Plan participants is not probable.

F. Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

G. Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will be 100% vested in their accounts.

H. Administrative expenses:

Administrative expenses associated with custody, recordkeeping, loan and other transaction fees are charged to participants. The Company provides certain accounting and management services to the Plan at no charge and pays for the annual audit of the Plan.

I. Tax status:

The Plan has adopted a prototype plan that has been determined by the Internal Revenue Service, in an opinion letter dated June 30, 2020, to be in accordance with applicable sections of the Code. The Plan has since been amended; however, the Plan administrator believes that the Plan is currently designed and being operated in accordance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

J. Related party transactions:

Certain Plan investments are shares of funds managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

K. Subsequent events:

Subsequent events were evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
