We have performed audits of the financial statements of Promega Salary Deferral Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - PLAN DESCRIPTION

The following description of the Promega Salary Deferral Profit Sharing Plan (the Plan) is provided only for general information purposes. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is intended to meet the requirements of the Internal Revenue Code (IRC) and qualify as a defined contribution plan. It is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA), as amended. It was established to provide retirement benefits to eligible employees of Promega Corporation and its U.S. - based subsidiaries (Employer). Employees meeting the eligibility requirements below become eligible to contribute to the Plan and to receive an Employer matching contribution on the first day of the month following the date on which they meet the eligibility requirements. The eligibility requirements are as follows:

- U.S. resident, excluding territories of the U.S.;
- Non-temporary employee (project employee or intern);
- Non-independent contractor; and
- Employees at least 18 years of age.

Overall, responsibility for administering the Plan rests with the Plan's 401(k) Committee. Fidelity Management Trust Company (Trustee) serves as trustee and asset custodian of the Plan. The Employer is the sponsor of the Plan.

Contributions

Participants

Participants may contribute up to 75% of their eligible compensation in any calendar year to the Plan on a pre-tax or after-tax basis by means of a salary reduction agreement, subject to the maximum contribution limits allowed by the Internal Revenue Service (IRS). The Plan allows for catch-up contributions for participants who reach the age of 50 before the end of the Plan year, subject to the maximum contribution limits allowed by the IRS.

All newly eligible employees and all active participants without a deferral election are automatically enrolled in the Plan, unless otherwise elected by the participant. Elective contributions are established at a pre-tax rate of 8% of eligible compensation and are directed into the Plan's default investment option. The elective deferral rate will increase annually by 1% until the participant reaches a rate of 12%. Participants may subsequently change these deferral and investment elections at any time.

Employer

The Employer makes matching contributions to each participant's account equal to 50% of the participant's contribution, up to 8% of the participant's eligible compensation. Each plan year, the Employer may also make a discretionary profit sharing contribution to eligible employees (those who completed 1,000 hours and are employed on the last day of the Plan year). There was no discretionary profit sharing contribution in 2024.

Participant Accounts

Individual accounts are maintained by the Trustee for each plan participant. Each participant's account is credited with the participant's elective deferral contribution, the Employer matching contribution, allocations of revenue credits, allocations of Employer discretionary profit sharing contributions, and plan earnings, and is charged with withdrawals and allocations of plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of all participant and Employer contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a stable value collective trust fund and Fidelity BrokerageLink self-directed brokerage accounts (which include common stocks, mutual funds and cash) as investment options for participants.

Vesting

Participants are immediately vested in participant elective deferral contributions, plus earnings thereon. If a participant's employment with the Employer ends for any reason other than retirement, permanent disability, or death, vesting in the Employer matching contributions and Employer discretionary profit sharing contributions portion of their account plus the earnings thereon is based on years of continuous service. A participant vests in Employer matching and discretionary contributions according to the following:

Forfeitures

The Plan provides that, upon a participant's termination and distribution of his or her vested interest, the participant's non-vested interest in his or her account is forfeited. Forfeitures may be used to pay expenses under the Plan. Forfeitures not used to pay expenses shall be used to reduce the Employer matching contribution. In 2024, approximately \$1,000 of forfeitures were used to pay expenses for the Plan or offset Employer matching contributions. At December 31, 2024 and 2023, the outstanding balance of forfeited non-vested accounts totaled approximately \$457,000 and \$318,000, respectively.

Distributions

Upon termination of service due to retirement, death, disability or termination of employment, participants may elect to receive the value of their account balance (if over \$7,000) in a lump sum or in installments over a period not to exceed their life expectancy or the joint life expectancies of the participant and his or her spouse. If the participant's account balance is \$7,000 or less, the benefit will be transferred into a new employer's plan, if found.

Notes Receivable from Participants

Participants may borrow from their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. The loans are secured by the participant's account and bear interest at a rate commensurate with local prevailing rates. Interest rates on outstanding loans range from 4.25% to 9.5% at both December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions. Participants are limited to one outstanding loan (two outstanding loans if one loan was obtained in accordance with the CARES Act) at a time. The loans must be repaid within five years, unless the loan is used to purchase a principal residence, for which the repayment period may not exceed ten years.

Other Withdrawals

Participant hardship withdrawals for medical expenses, tuition and related educational expenses, home purchase or eviction prevention, major repair of damage to principal residence, and burial or funeral expenses are provided for in the Plan.

Plan Termination

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, all participants' accounts shall become fully vested.

Revenue Credit Program

The Plan participates in a revenue credit program with the Trustee whereby the Trustee shares certain revenue generated by the Plan in excess of their fees. The Plan receives the revenue credits on a quarterly basis which may be used to pay for plan expenses or may be reallocated to participants on a pro-rata basis based on participant account balances.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows.

Basis of Accounting

The financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

In preparing financial statements in conformity U.S. GAAP, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable and those in default from participants are recorded as benefit payments based upon the terms of the Plan.

Payment of Benefits

Benefits paid to participants are recognized when the funds are disbursed.

Administrative Expenses

The Plan provides that all reasonable expenses related to plan administration are to be paid by the Plan unless otherwise paid by the Employer at the Employer's discretion. For the year ended December 31, 2024, certain administrative expenses of the Plan were paid by the Employer.

NOTE C - RISKS AND UNCERTAINTIES

Investment securities are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan records investments at fair value using a fair value hierarchy that distinguishes between assumptions based on market data (observable inputs) and the Plan's assumptions (unobservable inputs). The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Cash equivalents - Valued at the quoted market value as of the last business day of the year.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fidelity BrokerageLink self-directed brokerage accounts - The underlying investments, which consist primarily of individual corporate common stocks, cash equivalents and Fidelity unit funds, are valued at the closing price reported on the open market and are classified within Level 1 of the valuation hierarchy.

Collective trust fund - Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

NOTE F - PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments include shares of mutual funds managed by Fidelity Management and Research (FMR Corp). Fidelity Investments Institutional Operations Company serves as the contractual recordkeeping agent for the retirement plan administrative products marketed and sold by the Trustee and is a wholly owned subsidiary of FMR Corp. FMR Corp. provides management, investment advisory and shareholder services for the Fidelity mutual funds and, therefore, transactions with FMR Corp. qualify as party-in-interest transactions. Fees paid by the Plan for the investment management totaled approximately \$241,000 for the year ended December 31, 2024. Revenue credits received from the Trustee qualify as party-in-interest transactions. Credits received by the Plan totaled approximately \$288,000 for the year ended December 31, 2024. Credits reallocated to participants totaled approximately \$269,000 for the year ended December 31, 2024.

In addition, the Plan issues notes receivable from participants, which are considered party-in-interest transactions.

NOTE G - TAX STATUS

The IRS has determined, by a letter dated June 30, 2020, that the prototype document on which the Plan is based is designed in accordance with applicable sections of the IRC. The letter stated that the prototype document is qualified under Section 401(a) of the IRC and is, therefore, not subject to taxation under present income tax laws. The Plan has not received an opinion letter specific to the Plan itself. The Plan has been amended since June 30, 2020; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax exempt as of the financial statement date. Therefore, no provision for income taxes is included in the Plan's financial statements.

U.S. GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

NOTE H - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The Form 5500 continues to record the Fidelity MIP value at the adjusted fair value based on the trust's audited financial statements, whereas the accompanying financial statements record this fund at the constant \$1 NAV.
