### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of the NFI 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

### ***Basis for Opinion***

# NFI 401(k) Plan

## *Notes to Financial Statements*

### 1. Description of the Plan

The following description of the NFI 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan, established effective January 1, 2022, is a defined contribution plan covering substantially all employees of Newbury Franklin Industrials, LLC (the “Plan Sponsor”, “Plan Administrator” or “NFI”), including all employees of subsidiaries of NFI who have adopted the plan as part of the controlled group. The Plan was most recently amended and restated effective April 25, 2024, to decrease the required eligibility age to make contributions from 21 to 18. Employees must be have completed 6 months of service in order to become a participant in the Plan and begin making elective deferrals and receiving Plan Sponsor contributions. In accordance with the Plan agreement, the following classes of employees are excluded from eligibility:

- Residents of Puerto Rico
- Employees covered by a collective bargaining agreements
- Leased employees
- Non-resident aliens; and
- Interns

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Plan Sponsor Acquisitions** – In April 2022, the Plan Sponsor acquired Metro Plastic Technologies, Inc. Contributions to the Plan started December 8, 2022, at which point the Plan Sponsor notified participants that future contributions would be made to the Plan. The Metro Plastic Technologies, Inc. 401(k) Plan merged with the Plan effective January 1, 2023. Plan assets totaling \$2,222,952 transferred to the Plan on February 13, 2023.

In April 2022, the Plan Sponsor acquired Moldtech, LLC. Contributions to the Plan started on December 15, 2022, at which point the Plan Sponsor notified participants that future contributions would be made to the Plan. The Moldtech, LLC 401(k) Plan merged with the Plan effective January 1, 2023. Plan assets totaling \$2,152,099 transferred to the Plan on January 11, 2023.

In July 2023, the Plan Sponsor acquired Bearing Distributors, LLC. Contributions to the Plan started on December 1, 2023, at which point the Plan Sponsor notified participants that future contributions would be made to the Plan. The Bearing Distributors, LLC 401(k) Plan merged with the Plan effective December 1, 2023. Plan assets totaling \$2,976,357 transferred to the Plan on December 12, 2023.

**1. Description of the Plan (continued)**

**Contributions** – Participants may elect to contribute a specific percentage or dollar amount of their annual compensation as a pre-tax or Roth contribution, up to 100% of compensation, limited by the amount imposed by law. Additionally, participants age 50 or older may elect to make a catch-up contribution limited to the amount imposed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (i.e., rollovers).

The Plan Sponsor may make discretionary non-elective contributions to eligible participants. For the year ended December 31, 2024, the Plan Sponsor did not make any discretionary contributions.

The Plan Sponsor makes safe-harbor matching contributions equal to 100% of the participant's deferrals that are not in excess of 3% of the participant's compensation plus 50% of the participant's deferrals that exceed 3% of the participant's compensation but that do not exceed 5% of the participant's compensation.

**Participant Accounts** – Individual accounts are participant-directed and are maintained for each Plan participant. Participant accounts are increased by participant contributions, Plan Sponsor contributions and the participant's share of Plan earnings. Participant accounts are decreased by participant distributions and each participant's share of Plan expenses and losses. The allocation of earnings and losses to participant accounts is based upon the value of an individual account in relation to the total assets of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are immediately vested in their salary deferral, rollover contributions, Plan Sponsor safe-harbor contributions, and actual earnings thereon. Participants vest in Plan Sponsor discretionary non-elective contributions and actual earnings thereon at the rate of 20% per year after two years of service and become fully vested after six years.

**Notes Receivable from Participants** – Participants may borrow a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one loan outstanding at a time and the minimum loan amount is \$1,000. The loans are secured by the vested balance in the participant's account and bear a reasonable rate of interest. Repayment terms may not exceed five years, with the exception of a note used to purchase a primary residence, in which case extended repayment terms up to 10 years are available. Principal and interest is paid ratably through each payroll deduction. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan agreement.

## NFI 401(k) Plan

*Notes to Financial Statements (continued)*

### 1. Description of the Plan (continued)

***Payment of Benefits*** – Upon termination of employment, retirement, death, disability, or as required by law, a participant may elect to receive installment distributions or a lump-sum distribution in an amount equal to the vested value of their account. The Plan allows for in-service distributions for participants older than age 59 ½. With regards to hardship withdrawals, a participant may elect financial hardship withdrawals for qualifying expenses before age 59 ½ while employed by the Plan Sponsor.

***Forfeitures*** – Forfeitures from non-vested Plan Sponsor contributions may be used to reduce Plan expenses or to reduce Plan Sponsor contributions. Forfeitures available for use amounted to \$22,882 and \$2,727 at December 31, 2024 and 2023, respectively.

Forfeitures of \$8,361 were used to reduce plan expenses during 2024. Forfeitures of \$17,929 were used to reduce employer contributions during 2023.

***Plan Termination*** – Although it has not expressed intent to do so, the Plan Administrator has the right to terminate the plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

***Income Taxes*** – The Plan Sponsor has adopted the CCH Incorporated Basic Plan Document #01. CCH Incorporated obtained a letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the Plan document satisfies the applicable provisions of the Internal Revenue Code (the “Code”). Although the Plan has been amended since the preapproved plan received the determination letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the accompanying financial statements.

### 2. Summary of Significant Accounting Policies

***Basis of Accounting*** – The accompanying financial statements are prepared using the accrual method of accounting in accordance with GAAP.

***Investment Valuation and Income Recognition*** – The Plan’s investments stated at fair value as of December 31, 2024 are determined by Transamerica Trust Company (“TTC”). The Plan’s investments stated at fair value as of December 31, 2023 are determined by Reliance Trust Company (“RTC” or “Former Custodian”). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

**2. Summary of Significant Accounting Policies (continued)**

The Plan's investments stated at contract value as of December 31, 2024 and 2023 are determined by Transamerica Financial Life Insurance Company ("TFLIC"). See Note 5 for a discussion of contract value.

The Plan presents in the accompanying statements of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains and losses and the unrealized net appreciation or depreciation of those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Administrative Expenses** – Certain accounting and administrative expenses of the Plan are paid by the Plan Sponsor, or paid by applying the forfeiture balance of the Plan. Expenses relating to investment activity are paid by the Plan.

**Payment of Benefits** – Benefits are recorded when paid.

**Party-in-Interest Transactions** – Certain Plan investments are managed by the Plan's Custodians, TTC and TFLIC (collectively "Transamerica" or the "Custodians"), as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, that are exempt from the prohibited transaction rules. Fees paid to the Custodians for custodial and investment management services for the years ended December 31, 2024 and 2023 totaled \$60,556 and \$44,282, respectively.

**Risks and Uncertainties** – Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Use of Estimates** – The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Subsequent Events** – The Plan Administrator has evaluated the effects of all subsequent events, for recognition or disclosure, through October 7, 2025, the date the accompanying financial statements were available to be issued, and determined that no additional recognition or disclosure was required.

**3. Information Certified by the Custodians and Former Custodian (Unaudited)**

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.

**4. Fair Value Measurements (continued)**

- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity’s own assumptions about the assumptions that market participants would use in pricing the asset or liability. There were no assets of the Plan that utilized Level 3 inputs as its primary measure of fair value as of December 31, 2024 and 2023.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds* – Shares of mutual funds are valued at quoted market prices of shares held by the Plan at year-end.

*Collective Investment Fund (“CIF”)* – The CIF is valued daily at net asset value (“NAV”) based on the market value of the underlying assets. NAV is determined by dividing the fair value of the CIF’s net assets by the total number of units owned. The CIF invests in assets (typically fixed-income securities or bond funds and may included derivative instruments such as futures contracts and swap agreements), enters into wrap contracts issued by third parties, and invests in cash equivalents represented by shares in money market funds. Fidelity seeks to minimize the exposure of the CIF to wrap credit risk through, among other means, diversification of the wrap contracts across an approved group of issuers. The CIF’s ability to receive amounts due pursuant to these contracts is dependent on the issuer’s ability to meet their financial obligations.

Participant level transactions take place daily while plan level liquidations require notice to Fidelity prior to processing the transaction. During 2024, the CIF held at Fidelity was transferred into mutual funds held with TTC.

**5. Investment Contract**

The Plan has entered into a fully benefit-responsive investment contract (the "Contract") with TFLIC, referred to as the Transamerica Stable Value Core Account. TFLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the Contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Contract. Contract value, as reported to the Plan by TFLIC, represents contributions made under the Contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on capital market developments, the performance of the separate account assets backing the contract, and the expected and actual contributions and withdrawals of all of the plans participating in the contract. There is no stated minimum or maximum interest rate for the Contract. Such interest rates are reviewed quarterly for resetting.

**5. Investment Contract (continued)**

Certain events limit the ability of the Plan to transact at Contract value with the Contract issuer. Such events include the following: 1) amendments to the Plan documents including complete or partial Plan termination or merger with another plan; 2) premature termination of the Contract; 3) changes to the Plan's prohibition on competing investment options; 4) bankruptcy of the Plan Sponsor or other Plan Sponsor events that significantly affect the Plan's normal operations; 5) the failure of TFLIC to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.
