### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Intecrowd LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). **1. Summary Plan Description:**

The following brief description of the Intecrowd LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan was established on January 1, 2018, and restated effective January 1, 2022. The Plan is a defined contribution plan covering all eligible employees of Intecrowd LLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

*Eligibility*

The Plan covers employees of the Company who are age 18 or older. Employees covered by a collective bargaining agreement, leased employees, and non-resident aliens are excluded employees and are not eligible to participate in the Plan. Employees may begin elective contributions on the 1st of the month following the date the Plan’s eligibility requirements and can receive employer discretionary matching contribution. Participants who have completed 1,000 hours of service in a year and are employed on the last day of the plan year are eligible to receive discretionary employer profit-sharing contributions.

*Contributions*

Participants may contribute pre-tax compensation to the Plan, as defined by the Plan and subject to certain limitations set by the Internal Revenue Code. The Plan has an automatic enrollment provision providing for a 3% salary deferral with increases of 1% annually on the first day of the plan year until reaching a maximum of 6%, whereby employees must elect out of the Plan if they do not wish to participate. In addition, employees who have attained age 50 by the end of the Plan year may make catch-up contributions up to limits defined by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company at its discretion may make an employer nonelective contribution and profit sharing contribution. For the Plan year 2024, the Company made a discretionary employer nonelective contribution of 100% of employee deferrals up to 1.5% of compensation contributed to the Plan, totaling \$329,872, that was allocated to participants based on their deferred contribution to the Plan during 2024.

*Participant Accounts*

Each participant’s account is credited with the participant’s contributions, allocations of Company contributions, and participant earnings. Participant earnings are based on an allocation of plan earnings respective to each participant’s account balances and investment selections. Any related administrative expenses based on participant earnings or account balances are deducted from the participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

**1. Summary Plan Description (Continued):**

*Investment Options*

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a selection of pooled separate accounts and a guaranteed investment contract as investment options for participants.

*Notes Receivable from Participants*

Participants may borrow from their fund accounts, a minimum of \$1,000 up to an amount not to exceed the lesser of 50% of the participant's vested interest under the Plan or \$50,000. The loans are secured by the balance in the participant's account and must be repaid in level payments through payroll deductions over a five-year period, except for loans for the purchase of a principal residence which may be repaid over a reasonable period of time up to 15 years. The loans bear interest at the prime rate as published by the Wall Street Journal plus one percentage point. Participants may have one loan outstanding at a time.

*Vesting*

Participants are 100% vested immediately in their elective deferrals including catch-up contributions, rollover contributions from other plans, and actual earnings thereon. Vesting in the discretionary match or profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are 100% vested in any discretionary match or profit-sharing contributions after three years of service.

*Payment of Benefits*

On termination of service due to death, disability or retirement, or other reasons, a participant may receive a lump-sum distribution equal to the value of the participant's vested interest in their account in accordance with Plan provisions. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

Account balances that are under \$5,000 may be automatically distributed upon termination of service as a lump sum without consent of the participant.

*Forfeited Accounts*

Forfeitures by non-vested participants are generally used to reduce future employer contributions or pay administrative expenses. As of December 31, 2024, and 2023, forfeited non-vested accounts held to be used in the future totaled \$21,402 and \$3,588, respectively. During the year ended December 31, 2024, \$3,588 were used by the Plan to reduce employer contributions.

*Plan Expenses*

Plan expenses, except for certain administrative expenses related to loans, distributions, and investment advisory services, are paid directly by the Company.

Management fees and operating expenses charged to the Plan for investments in the pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**2. Summary of Accounting Policies:**

*Basis of Accounting*

The accompanying financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

*Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Notes Receivable from Participants*

Participant loans are reported at amortized principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributed based upon the terms of the Plan document. The loans are secured by the balance in the participants' accounts.

*Investment Valuation and Income Recognition*

Participants in the Plan direct their accounts to be invested in various investment options. Investments are presented at fair value, except the guaranteed investment contract that is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Contract value is the relative measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on the sales of securities are reported on the average cost method.

*Payment of Benefits*

Benefits are recorded when paid.

*Risks and Uncertainties*

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risk in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

#### 3. Fair Value Measurements:

The Financial Accounting Standards Board, Accounting Standards Codification Topic 820 (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Pooled separate accounts:* Pooled separate accounts invest in registered mutual funds or collective investment trusts. The separate account owns and holds the underlying mutual fund or collective trust shares which are valued daily at their net asset value (NAV). The separate account is valued at its accumulation unit value (AUV) determined daily based on the NAV of shares of the underlying fund, the fund's dividends, and the contract's separate account charges. The AUV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported AUV. Participant transactions (purchases and sales) may occur daily. There are no participant or Plan redemption restrictions for these investments, and there are no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table represents investments for which fair value is measured using the NAV per share as a practical expedient as of December 31, 2024 and 2023. There are no participant restrictions for these investments.

#### 4. Fully Benefit-Responsive Guaranteed Investment Contract:

The Plan offers the option to invest in a guaranteed annuity contract with Voya who maintains the contributions in a general account. The contract is considered fully benefit-responsive and is reported at contract value. Contract value, as reported to the Plan by Voya, of \$258,634 and \$201,219 at December 31, 2024 and 2023, respectively, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk.

Voya is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Voya but may not be less than 1%.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include 1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or 5) premature termination of the contract. Events that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants are not probable of occurring.

In addition, certain events allow Voya to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events may include the following: 1) an uncured violation of the Plan's investment guidelines, 2) a breach of material obligation under the contract, 3) a material misrepresentation, and 4) an amendment to the agreement without the consent of Voya.

#### 5. Information Prepared and Certified by the Custodian:

The following investments included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the interest and net appreciation in fair value of investments included in the statement of changes in net assets available for benefits for the year ended December 31, 2024 have been derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, custodian of the Plan, in accordance with 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under Employee Retirement Income Security Act of 1974.

**6. Party-in-Interest Transactions:**

Certain Plan investments were managed by Voya during 2024 and transactions with Voya have been identified as party-in-interest transactions which are exempt from prohibited transaction rules. Fees paid by the Plan to Voya for the investment management services and transaction fees amounted to \$12,163 for the year ended December 31, 2024 and are included in administrative expenses in the accompanying statement of changes in net assets available for benefits.

Included in the Plan assets are notes receivable from participants. At December 31, 2024 and 2023, notes receivable from participants amounted to \$73,926 and \$90,145, respectively. For the year ended December 31, 2024, interest income related to notes receivable from participants amounted to \$7,734. These transactions qualify as party-in-interest transactions permitted under provisions of ERISA.

**7. Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants become 100 percent vested in their accounts.

**8. Tax Status:**

The Plan operates under a Volume Submitter 401(K) Profit Sharing Plan. The submitter plan received a favorable opinion letter from the Internal Revenue Service on June 30, 2020 which stated the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Management has evaluated the Plan's tax positions and concluded that as of December 31, 2024, the Plan had taken no uncertain tax positions that require recognition of liability (or asset) in the accompanying financial statements. With few exceptions, the Plan is no longer subject to income tax examination by the U.S. federal, state or local tax authorities for years before 2021.

**9. Subsequent Events:**

Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be filed and has determined that there were no material events requiring recognition or disclosure.
