NOTES TO FINANCIAL STATEMENTS

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Orthopedic & Sports Medicine Specialists of Green Bay SC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan. Orthopedic & Sports Medicine Specialists of Green Bay SC (the Company) is the administrator and sponsor of the Plan. The Plan was established on September 26, 2007, and uses Fidelity Investments, Ameriprise Financial, Morgan Stanley Smith Barney LLC, and Mid Atlantic Trust Company as the Plan trustees (custodians). The Plan was most recently restated August 1, 2020. The participants are responsible for the direction of their account balances into specific investment options. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Amendments:

Effective January 1, 2024, the Company amended the Plan to update the vesting schedule for discretionary matching and non-elective profit-sharing contributions (see Note 1, Vesting Subnote), removed the requirement for 1 year of service before participating in elective deferrals (see Note 1, Eligibility Subnote) and no longer permits notes receivable from participants. Effective August 16, 2024, the Plan no longer required employer safe harbor qualified non-elective contributions (see Note 1, Contributions Subnote).

Eligibility:

Employees of the Company who are not covered by collective bargaining agreements under which they have specifically negotiated coverage by the Plan, who are not resident aliens, who are not leased or reclassified employees, who have attained the age of twenty one years or older, are eligible to make participant contributions. Before January 1, 2024, employees additionally were required to perform one year of service to be considered eligible for participant contributions. Eligible employees who complete one year of service in which 1,000 hours are worked and who are employed on the final day of the year are considered eligible to receive employer contributions. Only non-owners may receive non-elective profit-sharing contributions. Plan entry dates are the first day of the first month and seventh month of the Plan year.

Contributions:

Each year, participants may contribute up to 100 percent of their compensation, as defined in the Plan. Participants may elect to change their contribution rate each quarter. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

NOTE 1. (CONTINUED)

Contributions (continued):

Before August 16, 2024, the Plan required an employer safe harbor qualified non-elective contribution of 3%. Qualified non-elective contributions of \$347,041 and \$426,025 were made for the years ended December 31, 2024 and 2023, respectively. The Company may make discretionary matching and non-elective profit-sharing contributions. Non-elective profit-sharing contributions are determined annually by Plan management based on employment and certain eligibility criteria. Discretionary non-elective profit-sharing contributions were made for the Plan years ending December 31, 2024 and 2023 totaling \$969,137 and \$758,113, respectively. Contributions are subject to certain IRS limitations.

Participant accounts:

Each participant's account is credited with participant pre-tax deferrals, participant post-tax Roth contributions, company safe harbor contributions, any other discretionary contributions made by the company and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participant accounts are valued as the end of each business day. The benefit the participant is entitled to is the benefit that can be provided from the participant's vested account.

Vesting:

Employees are fully vested at all times in their employee contributions and safe harbor matching contributions to the Plan plus actual earnings thereon. Vesting in the Company discretionary matching and non-elective profit-sharing contribution portion of their account is based on years of continuous service. Effective January 1, 2024, a participant is 100% vested after four years of credited service (previously five years). Notwithstanding above, a participant is fully vested upon death or permanent disability.

Notes receivable from participants:

Before January 1, 2024, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balances or \$50,000. The notes were secured by the balance in the participant's account and bear interest commensurate with prevailing market rates. Rates were determined at 1% over the current prime rate of interest. Principal and interest were paid through bi-weekly payrolls.

NOTE 1. (CONTINUED)

Payment of benefits:

Distributions to terminated or retired participants are made in a single lump-sum payment to the participant (or in the case of death, the participant's beneficiary) or periodic installments over a period specified by the plan. Effective January 1, 2024, if terminated/retired participants do not voluntarily elect to move their funds out of the plan, vested account balances between \$1,000 and \$7,000 (previously \$5,000) are rolled into an IRA on the employee's behalf. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan Administrator can authorize the benefit payment without the Participant's consent. Effective October 30, 2023, the Plan was amended to permit in-service distributions to individuals who have obtained age 59 ½ and active participants experiencing financial hardships. In-service withdrawals are limited pursuant to the Plan's provisions.

Forfeitures:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$265 and \$1,264, respectively. These accounts will be used to reduce future employer contributions or pay plan administrative expenses. During the years ended December 31, 2024 and 2023, \$13,345 and \$11,248 were used to reduce administrative expenses.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting:

The financial statements of the Plan are maintained on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for the discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded on the terms of the Plan document.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan and fees related to administration of notes receivable from participants and distributions are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

Subsequent events:

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 10, 2025, the date the financial statements were available to be issued.

NOTE 3. CERTIFICATION OF INVESTMENT INFORMATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Mid Atlantic Trust Company, the trustee (custodian) of the Plan, has certified as to the completeness and accuracy of the following information included in the statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years ending December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024:

NOTE 4. FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to adjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobserved inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are adjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets and liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means;

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market accounts: Cash approximates fair value in a non-inflationary economy.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The Mutual funds held by the Plan are deemed to be actively traded.

Common stocks: Valued at the daily closing price as reported on the active market on which the individual securities are traded.

Exchange-traded funds: Valued at the daily closing price as reported by the fund. Exchange traded funds held by the Plan are index-based exchange-traded funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The exchange-traded funds held by the Plan are deemed to be actively traded.

Fixed-income securities: Valued at the daily closing price as reported by the Bank. Securities held by the Plan are fixed-income investments with equity-like features that are registered with the SEC. These securities are required to publish their daily net asset value (NAV) and to transact at that price. The securities held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Investments, Ameriprise Financial, Morgan Stanley Smith Barney LLC, and Mid Atlantic Trust Company. Fidelity Investments, Ameriprise Financial, Morgan Stanley Smith Barney LLC, and Mid Atlantic Trust Company were the trustees for the years ended December 31, 2024 and 2023; therefore, these transactions qualify as party-in-interest transactions. Pension Inc. was the recordkeeper for the plan for the years ended December 31, 2024 and 2023; therefore, these transactions qualify as party-in-interest transactions. All these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7. PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated June 30, 2020, received from the Internal Revenue Service (IRS) on the Prototype Non-standardized Profit Sharing Plan with CODA indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under the current income tax law. The prototype Plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9. SECURE ACT 2.0

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and administratively adopted an increase to the force out limit for terminated participants (see Note 1, Payment of Benefits subnote). Plan management will determine other optional provisions to elect in the future.
