### Note 1: Description of Plan

The following description of the Capital Credit Union 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Capital Credit Union (the Sponsor). An employee becomes eligible to participate in the Plan after reaching the age of 18 and 1 month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted the provision increasing the age at which participants must begin taking required minimum distributions from age 72 to 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

#### Eligibility and Participation

All employees of the Sponsor are eligible to make pretax or after-tax (Roth) contributions to the Plan on the first day of the month on or after they become an employee and have attained age 18 and completing 1 month of service. Employees who have met these requirements are eligible to receive Sponsor Safe Harbor matching contributions.

#### Contributions

Each year, participants may contribute pretax or after tax eligible compensation up to the maximum allowed by the Internal Revenue Service (IRS). Employees who do not specify a deferred compensation arrangement are automatically enrolled in the Plan with a deferral rate of 3% of compensation which increases 1% each year starting in year 3 up to 6% after 5 years, unless the employee affirms otherwise. In addition, participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, subject to IRS limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Sponsor also provides a Safe Harbor matching contribution equal to 100% of elective deferral contributions up to 6% of compensation. For the 2024 plan year, Safe Harbor matching contributions totaled \$1,243,256

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, Sponsor Safe Harbor matching contributions, and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the sponsor contributions are as follows.

Notwithstanding the above, participants shall become 100% vested in their Sponsor contribution portion of their account upon attaining normal retirement (age 65), early retirement (age 55 and at least five years of service), their death, or becoming totally or permanently disabled.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The notes are secured by the vested balance in the participant's account and bear interest at a reasonable rate determined by the Plan administrator. Participants are allowed to have only one note outstanding. At December 31, 2024, the interest rate range on outstanding notes was 3.75-9.00%. Principal and interest are paid ratably through payroll deductions.

### Note 1: Description of Plan (Continued)

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either the value of the vested interest in his or her account in the form of a lump-sum distribution, substantially equal installments, or partial withdrawals. Distributions to terminated participants with vested account interests of \$1,000 or less are made as a lump-sum distribution without the participant's consent. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participants, while still employed, may receive an in-service distribution from their 100% vested accounts upon attaining age 59 ½ or may receive a hardship distribution from their salary deferral account, subject to Plan provisions.

#### Forfeited Accounts

Plan forfeitures arise as a result of participants who terminate before becoming 100% vested in the Sponsor's contributions. Forfeitures of non-vested contributions are used to reduce the Sponsor's contributions in accordance with the Plan document. During the year ended December 31, 2024, Sponsor contributions were reduced by \$19,739 from forfeited nonvested accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$523 and \$0, respectively.

#### Administrative Expenses

Certain investment and transactional expenses of the Plan are paid by the participants. The majority of administrative expenses of the Plan are paid by the Sponsor.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts (FBRICs)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 4: Information Prepared and Certified by Custodians

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, the FBRIC, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by CMFG Life Insurance Company (CUNA) and Matrix Trust Company, the custodians of the Plan.

### **Note 5: Fully Benefit-Responsive Investment Contract (FBRIC)**

The Plan invests in a FBRIC with CUNA in the form of a guaranteed investment contract (GIC). CUNA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. CUNA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 2.05%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the Plan's ability to transact at contract value with CUNA including plan termination and other events as specified in the GIC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the participants or the issuer are probable of occurring. The GIC does not permit CUNA to terminate the agreement prior to the scheduled maturity date.

### **Note 6: Related-Party Transactions and Party-in-Interest Transactions**

Certain Plan investments, including the guaranteed investment contract, are managed by CUNA. CUNA is a Custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments as they are paid through revenue sharing rather than a direct payment. Fees paid to CUNA for loan, distribution, and certain administrative services amounted to \$138,508 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Sponsor contributions.

### **Note 8: Plan Tax Status**

The IRS has determined and informed the Sponsor by a letter dated June of 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requires of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt

### **Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
