We have performed audits of the financial statements of Crest Insurance Group, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS
December 31, 2024

1. DESCRIPTION OF PLAN

The following description of the Crest Insurance Group, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on June 1, 2010, most recently restated on January 1, 2022, covering all employees of Crest Insurance Group, LLC, (the “Company”) who have completed three months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 100% of pre-tax or post-tax (Roth) annual compensation (\$23,000 in 2024), as defined in the Plan Agreement. Participants aged 50 or older may make additional deferrals up to \$7,500 (called “catch-up” contributions). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds plus a fixed interest account under an insurance company contract as investment options for participants. The Company has the right to make discretionary matching contributions and/or profit sharing amounts, subject to certain limitations. See Note 8 for discussion of discretionary contributions.

Participant’s Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) the Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in 100% of their contributions, Company matching contributions and any actual earnings thereon. Company matching contributions begin after three months of service. The Company has the right to make discretionary contributions and/or profit sharing amounts, subject to certain limitations.

1. DESCRIPTION OF PLAN (continued)

Payment of Benefits

On death, disability, retirement, or termination of service a participant may elect to receive a lump-sum amount equal to the value of their vested account balance.

Termination of Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

Administrative Expenses

As provided in the Plan Agreement, administrative expenses may be paid either by the Plan or by the Company. Expenses paid by the Plan are reported on the statement of changes in net assets available for benefits as administrative expenses. For the period ending December 31, 2024, the Plan paid administrative fees of \$83,880. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Per the Plan's loan policy, the loans are secured by the balance in the participant's account and bear interest at a rate of Prime plus 0%. Principal and interest is paid ratably through periodic payroll deductions.

Investment Options

Participants may direct their accounts to be invested in any of the investment options offered by the Plan. Participants may change their investment options daily.

Insurance

Because employee benefits depend solely on the amount in the employee's individual account, federal law provides that the Plan is not required to be insured under Title IV of ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles (“GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts of net assets available for Plan benefits at the date of the financial statements and the reported amounts of additions and reductions during the reporting period. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based on the terms of the Plan document.

Income Recognition and Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

(continued)

3. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company, by a letter dated June 30, 2020, that the form of the Plan adopted by the Company qualifies under Section 401(a) of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan sponsor and the Plan's third-party administrator believe that the Plan is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions, generally for three years following filing of required returns. However, there are currently no audits for any tax periods in progress. The Plan administrator believes it has not taken any uncertain tax positions that would subject the Plan to a tax liability or asset.

4. INVESTMENTS

The Plan has entered into investment contracts with Empower Trust Company, LLC ("Empower"). The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Empower. Investment information was obtained from data that has been prepared and certified as to being complete and accurate by Empower and Empower Annuity Insurance Company, the asset custodians.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed Interest Accounts

The Plan had an investment contract with Empower in 2024 and 2023, which is a fully benefit responsive guaranteed investment contract. Empower maintains the contributions in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses charged by Empower. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

(continued)

4. INVESTMENTS (continued)

During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought, sold and held during the year) appreciated in value by \$1,316,557. Gain and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

FASB Accounting Standards Codification 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following table sets forth a description of the inputs to the valuation methodology for the three levels in the fair value hierarchy.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

(continued)

4. INVESTMENTS (continued)

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants. The use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

All financial instruments held by the Plan are considered to be participant directed investments.

The Plan holds a portfolio of investments including the guaranteed account. Because the guaranteed account is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The average yield earned by the Plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for 2024 is 1.41%. The credited interest rate for the remaining contract value balance was 1.41% as of December 31, 2024, and was determined based upon the performance of Empower's general account. The credited interest rate can be changed quarterly. The guarantee is based on Empower's ability to meet its financial obligations from the general assets of Empower. Investment information was obtained from data that has been prepared and certified as to being complete and accurate by Empower Annuity Insurance Company of America and Empower, the asset custodians.

There are no reserves against contract value for credit risk of Empower or otherwise. The crediting interest rate is based on a formula and is reviewed on a quarterly basis. Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants, is probable.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. CONCENTRATION OF CREDIT RISK

The participant notes receivable are due from Plan participants, almost all of whom live and work in Arizona, California and Colorado and are employed by the Company, the Plan sponsor. The notes are collateralized by the participants' accounts in the Plan.

7. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments include shares of mutual funds and investment contracts managed by Empower. Empower is a custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Empower also provides third party administration and recordkeeping services to the Plan which qualify as exempt party-in-interest transactions. The Plan does not incur fees directly from Empower. Other fees related to the Plan's operations may be paid by the Company on behalf of the Plan.

8. DISCRETIONARY CONTRIBUTIONS

On a discretionary basis, the Company may elect to make matching contributions, and/or profit sharing contributions into the Plan.

For the Plan year ended December 31, 2024, the Company elected to make a matching contribution. For purposes of the match, the Plan sponsor approved an employer match calculated as the lesser amount of 50% of the participant deferral into the Plan, or 50% of 4% of the participant's gross wages. The employer match is credited to participants' accounts at the end of each pay period.
