INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bowen, Miclette & Britt Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 13, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period from January 1, 2025 through January 13, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 13, 2025 and December 31, 2024, and for the period from January 1, 2025 through January 13, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Transfer of Plan Assets

As discussed in Note 1 to the financial statements, effective January 1, 2025, the Plan was merged into the BroadStreet Partners 401(k) Plan (“BroadStreet Plan”). The Plan completed the transfer of all Plan net assets into the BroadStreet Plan as of January 13, 2025 and the Plan ceased operations. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Bowen, Miclette & Britt Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Bowen, Miclette & Britt Insurance Agency, LLC (“Plan Sponsor”); Bowen, Miclette & Britt of Louisiana, LLC; Horizons Managed Care, Inc.; Bowen, Miclette & Britt of Florida, LLC; and Merrimac Marine Insurance, LLC (together, the “Company”), except those covered by a collective bargaining agreement or nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees are eligible to participate in the Plan on the first day of any month coinciding with, or next following, the attainment of age 20 and completion of 30 days of service, including participating in any Company discretionary matching and profit-sharing contributions. The Plan is participant directed and participants may change their contribution rates monthly and investment options at any time.

Effective January 1, 2025, the Plan was merged into BroadStreet Partners 401(k) Plan (“BroadStreet Plan”). On January 13, 2025, net assets of the Plan were transferred into the BroadStreet Plan, at which time, the Plan ceased operations. Participants became eligible to participate in the BroadStreet Plan. Participants were unable to initiate transactions with the Plan from January 6, 2025 until after the Plan’s assets were transferred into the BroadStreet Plan on January 13, 2025.

Contributions

Participants may elect to make pre-tax and/or Roth salary deferral contributions to the Plan of up to 90% of their eligible compensation as defined by the Plan, subject to certain limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company may automatically enroll employees who meet the eligibility requirements in the Plan unless the employee declines participation in writing or elects a salary deferral contribution. Participants who are automatically enrolled by the Company will make pre-tax salary deferral contributions of 3% until changed by the participant.

Roth elective deferrals are contributions that are made to the Plan by participants on an after-tax basis. Earnings on Roth elective deferrals will generally not be subject to federal income tax upon distribution provided certain requirements are satisfied. Roth elective deferrals are subject to the Internal Revenue Code (IRC) limitations applicable to pre-tax deferrals to the Plan.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

The Company may contribute a discretionary matching or profit-sharing contribution to all eligible participants. Participants must be employed at the end of the plan year to be eligible for the Company profit sharing contributions. For 2025, the Company made no contributions.

The Plan allows for rollover contributions from a former employer's qualified plan. Participants are at all times 100% vested in rollover contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's discretionary matching and profit-sharing contributions and (b) Plan earnings and charged with any applicable administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are at all times fully vested in their contributions and the appreciation or depreciation thereon. Participants become fully vested in the Company's contribution portion of their accounts, plus earnings thereon, upon completion of two years of service.

Notes Receivable from Participants

Plan participants may borrow Plan assets up to a maximum of the lesser of \$50,000 or 50% of their vested account balance in the Plan. Notes are paid in level installments through payroll deductions for periods ranging up to five years, or longer for the purchase of a primary residence. The notes bear interest at reasonable rates and are secured by the participant's vested account to the extent of the principal amount of the note plus accrued interest.

Payments of Benefits

A participant shall be immediately vested upon death, retirement, termination of employment due to total and permanent disability, and termination of the Plan. Normal retirement age under the Plan is 65. Upon death, retirement, disability, or termination of employment, participants are eligible for a benefit payment. The Plan also allows hardship and in-service withdrawals. The funds in the participant's account are distributed in a lump-sum payment unless the participant elects an alternate payment method allowed by the Plan.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Forfeitures

Forfeitures of nonvested Company discretionary matching contributions may be used to reduce any employer contribution. Forfeitures of nonvested Company discretionary profit-sharing contributions may be applied first to pay Plan administration expenses and any remaining shall be added to Company discretionary profit-sharing contributions and reallocated to participants eligible for profit sharing in the ratio that their eligible compensation bears to total eligible compensation each year. There was no forfeitures balance at January 13, 2025. The forfeitures balance was \$54,623 at December 31, 2024. No forfeitures were used to pay Plan administrative expenses, reduce employer contributions, or make discretionary profit-sharing contributions for 2025.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Contributions

Contributions from Plan participants and the Company matching contributions are recorded in the plan year in which the participant contributions are withheld from compensation. The Company profit-sharing contribution is recorded in the plan year in which participant compensation is paid.

Investments

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts as contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan, as discussed in Note 4, invests in a fully benefit-responsive investment contract with Massachusetts Mutual Life Insurance Company ("Mass Mutual").

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to notes receivable from participants and certain transactions are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net depreciation in fair value of investments.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

NOTE 3 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Pooled Separate Accounts: The pooled separate accounts invest directly in designated mutual funds or, in some cases, collective investment trusts. The separate accounts own and hold the underlying mutual fund or collective trust shares, which are valued daily at their NAV. Participants hold “units of participation” in the separate accounts. The accumulation unit value (AUV) is the value of each unit in the separate accounts, and the separate accounts are valued daily as the number of accumulation units held multiplied by the AUV. The pooled separate accounts held by the Plan provide for daily redemption by the Plan at reported AUV with no advance notice requirement. The Plan has no unfunded commitments and no contractual obligations to further invest in the accounts.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024.

The Plan had no investments measured at fair value as of January 13, 2025.

NOTE 4 - SEPARATE ACCOUNT GUARANTEED INVESTMENT CONTRACT

The Plan has a fully benefit-responsive investment contract with MassMutual. Contributions for the MassMutual Separate Account Guaranteed Investment Contract (SAGIC) Diversified Bond II are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Mass Mutual. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events, including discontinuance of the SAGIC or termination of the Plan, limit the ability of the Plan to transact at contract value with MassMutual. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The contract may be cancelled by the Plan or MassMutual with 30 days notice.

There was no investment measured at contract value as of January 13, 2025. The contract value of the investment contract as of December 31, 2024 was \$10,668,549. The crediting interest rate is determined by MassMutual and communicated to the Plan semi-annually. The SAGIC does not allow the crediting interest rate to fall below zero percent.

NOTE 5 - INFORMATION CERTIFIED

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Retirement LLC ("Empower"), the custodian, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of January 13, 2025 and December 31, 2024, except for participant loans, and the related investment activity reflected in the statement of changes in net assets available for benefits for the period from January 1, 2025 through January 13, 2025.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower Annuity Insurance Company of America ("EAICA"), which is an affiliate of Empower. These transactions qualify as party-in-interest transactions, as defined by ERISA. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

NOTE 7 - TAX STATUS

The Plan has adopted a volume submitter prototype plan, which obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the prototype document satisfies the applicable provisions of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

NOTE 7 - TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 13, 2025 and December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS
