## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Retirement Plan Committee of  
**401(k) Profit Sharing Plan of Magnetic Analysis Corporation**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the 401(k) Profit Sharing Plan of Magnetic Analysis Corporation (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

### Opinion

### NOTES TO FINANCIAL STATEMENTS

#### ( 1 ) Description of plan

The following description of the 401(k) Profit Sharing Plan of Magnetic Analysis Corporation (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

**General** - The Plan is a defined contribution plan sponsored by Magnetic Analysis Corporation (the "Company") for the benefit of its employees who have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions** - Each year, participants may contribute up to 60% of annual compensation, as pre-tax or Roth contributions, as defined in the Plan. Participants may also make after-tax contributions up to 100% of annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Additionally, participants aged 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation, and their contributions are invested in a designated target date fund until changed by the participant.

The Company makes matching contributions of 50% of participants' contributions up to 5% of eligible compensation, as defined. Additional discretionary contributions amounts may be contributed at the option of the Company and are allocated to eligible participants in the same proportion that their eligible compensation bears to the total Company compensation for the year. Participants must have completed one year of service and be employed as of December 31 of each year in order to be eligible for discretionary contributions. For the year ended December 31, 2024, the Company made a \$41,418 discretionary contribution to the Plan. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**Participant investment account options** - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market fund as the participant-directed investment options, which are managed by Fidelity Investments, an affiliate of the trustee, Fidelity Management Trust Company ("FMTTC").

**Participant accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, participant contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants' contributions plus actual earnings are 100% vested immediately. Company matching and discretionary contributions are subject to the following vesting schedule:

#### ( 1 ) Description of plan (continued)

**Payment of benefits** - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments. Vested balances under \$7,000 are distributed in a lump sum. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Forfeited accounts** - Forfeited balances of terminated participants' nonvested accounts may be used to pay the Plan's administrative expenses and/or to reduce employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22,940 and \$12,984, respectively. For the year ended December 31, 2024, forfeitures of \$11,995 were used to pay administrative expenses.

#### ( 2 ) Summary of significant accounting policies

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual method of accounting.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions** - Contributions from Plan participants and the matching and discretionary contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Investment-related expenses are included in net appreciation in fair value of investments.

#### ( 3 ) Information prepared and certified by the trustee

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held on December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by FMTC, the trustee of the Plan.

#### ( 4 ) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds and money market fund:* Valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. These funds held by the Plan are deemed to be actively traded.

All of the Plan's investments at fair value as of December 31, 2024 and 2023, were mutual funds and a money market fund that are deemed to be Level 1 in the fair value hierarchy.

#### ( 5 ) Related-party transactions and party-in-interest transactions

Certain Plan investments are shares of mutual funds and a money market fund managed by Fidelity Investments. FMTC, an affiliate of Fidelity Investments, is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net depreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. Fees paid by the Plan for certain investment-related and recordkeeping expenses for the year ended December 31, 2024, were \$12,560. Fees paid by the Plan to a vendor for investment advisory services for the year ended December 31, 2024, were \$550.

#### ( 6 ) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**( 8 ) Tax status**

The IRS has determined that the FMTC prototype 401(k) profit sharing plan is designed in accordance with applicable sections of the IRC and informed the trustee of such in a letter dated June 30, 2020. The plan administrator has adopted the prototype plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that "more likely than not" would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**( 9 ) Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**( 10 ) Subsequent events**

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.
