We have performed audits of the financial statements of The Plote Companies 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1. Description of the Plan

The following description of The Plote Companies 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with a 401(k) salary reduction arrangement covering all employees of Plote Construction, Inc. and certain adopting employers, as defined (Sponsor or Company), who are not subject to a collective bargaining agreement for which retirement benefits have been the subject of good faith negotiations or not a leased employee. Employees are required to complete one month of service for full-time employees or one year of service for part-time employees and be 21 years of age or older in order to participate in the 401(k) and matching contributions of the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

Contributions

Participants may contribute up to 100% of their annual pre-tax compensation through a salary deferral program. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions can be made on a before-tax basis only and cannot exceed \$23,000 in 2024. Age 50 and over participants can contribute an additional \$7,500 in 2024.

The Plan has an automatic deferral feature under which the amount to be automatically withheld from a participant's compensation each pay period is equal to 5% unless the participant opts out. The Plan also has an auto-escalation feature in which those participants with a deferral rate greater than zero will have that deferral increased annually by 1% of compensation until a maximum deferral rate of 10% is reached. The escalation provision applies each year on July 1st, except with regard to the first such annual increase which shall not apply to a participant within the first six months following the date such participant was automatically enrolled.

Employer discretionary matching contributions of \$362,425 were granted for the year ended December 31, 2024.

Participant Accounts

Each participant's account has been credited with the participant's contribution and allocations of (a) the Sponsor's contribution and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings and account balances as defined. The benefit to which a participant is entitled is the participant's vested account balance.

Forfeited Accounts

Forfeited nonvested accounts related to employer-matching contributions are first used to pay plan expenses and then to reduce future employer contributions. Any remaining forfeitures are to be allocated to participants in the manner described in the Plan. Effective April 16, 2013, the Company added a discretionary annual employer-matching contributions feature to the Plan to facilitate annual forfeiture allocations.

During the year ended December 31, 2024, no forfeitures were applied to plan expenses or used to reduce employer contributions. At December 31, 2024 and 2023, forfeiture balances of \$12,729 and \$685, respectively, were available to offset future plan expenses or employer contributions, with any remaining forfeitures to be allocated to participants. The 2024 employer contribution of \$362,425 remitted in March 2025 was not reduced by forfeitures.

Vesting

Participants are immediately 100% vested in their pre-tax contributions plus actual earnings thereon. Vesting in the Sponsor's matching contribution plus actual earnings thereon is based on years of continuous service. Participants become 50% vested after two years of service, and 100% vested after three years of service.

Investment Options

Participants direct the investment of their account balances into various investment options offered by the Plan.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Withdrawals

Participants may request hardship withdrawals for extreme hardships, pursuant to plan requirements, not to exceed the total amount of employee contributions to date. Participants receiving hardship withdrawals are prohibited from contributing to the Plan for a period of six months from the date of the withdrawal.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years unless the loan is for the purchase of a principal residence, in which case the loan term may be longer. Principal and interest payments are generally made through payroll withholding. The loans bear interest at prevailing market rates. Interest rates at December 31, 2024, ranged from 4.25% to 9.50%.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The Plan's investments in shares of registered investment companies are valued at quoted market prices. The common or collective trust funds are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan provides for investments that, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Benefit Payments

Benefits are recorded when paid.

Administrative Costs

The Sponsor absorbs substantially all the administrative costs of the Plan. The trust fees are first paid using any available forfeitures, with any remaining fees being absorbed by the Sponsor. Administrative costs of \$13,645 paid by the Plan during 2024 were expensed as incurred. Certain investment management fees are included with the net appreciation in fair value of investments.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

Level 1 Quoted prices in active markets for identical assets or liabilities

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted market prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3 Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Tax Status

The Plan operates under a nonstandardized pre-approved profit sharing plan with CODA sponsored by FMR LLC. This nonstandardized plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter dated June 30, 2020, from the Internal Revenue Service stating that the prototype plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Plan Termination

Although it has not expressed an intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan under the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

Note 7. Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company, the trustee of the Plan. Therefore, these transactions qualify as permitted party-in-interest transactions. The Sponsor provides certain administrative services at no cost to the Plan.

Note 8. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month which the participant contributions are withheld by the employer. During the years ended December 31, 2024, 2023 and 2022, contributions of \$46,706, \$5,256 and \$40,163, respectively, were not remitted within the required time period. The 2023 and 2022 late remittances of \$5,256 and \$40,163, respectively, were fully corrected, including lost earnings, in 2024. Plan management has identified a corrective action plan and is actively working to remit lost earnings to affected participants for the 2024 amount.

Note 9. Subsequent Events

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
