Opinion

We have audited the financial statements of Emergency Medicine Specialists, S.C. Employees' Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the Emergency Medicine Specialists, S.C. Employees' Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Emergency Medicine Specialists, S.C. (the Company) effective July 1, 1982, as restated January 1, 2024. The Plan covers all employees of the Company including its wholly-owned subsidiary, Consensio Health, excluding union employees and leased employees, who have completed one year of service, as defined in the plan document, and are age 21 or older. Long-term part-time employees who met eligibility requirements under SECURE 2.0 are also eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Board of Directors is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company contributes 3% of each participant's eligible compensation for the year as a safe harbor contribution. Additional profit sharing amounts may be contributed at the option of the Company's Board of Directors for eligible participants that worked at least 700 hours during the plan year, as defined in the plan document. For the year ended December 31, 2024, the Company approved total discretionary profit sharing contributions of \$3,595,745 which are paid monthly.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Company's safe harbor contribution, plus actual earnings thereon. For participants hired on or after January 1, 2023, vesting in the Company's profit sharing contribution portion of their account is based on years of continuous service, as defined in the plan document. A participant is 25% vested after one year of credited service and continues to vest in increments of 25% until 100% vested after four years of credited service. All participants hired on or before December 31, 2022 remain 100% vested in their accounts.

Participants are 100% vested upon death or total and permanent disability.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may receive a lump-sum distribution equal to the value of the participant's vested interest in their account. The Plan provides for normal retirement at age 65. In-service withdrawals are allowed upon attaining age 59 1/2. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of a lump-sum payment. In addition, the Plan allows for hardship distributions of at least \$1,000 if certain criteria are met.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2 and \$199, respectively. These accounts will be used to reduce future Company contributions or to pay plan administrative expenses. During 2024, \$10,564 was applied from forfeited nonvested accounts to reduce the Company's contributions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee and insurance companies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated through October 6, 2025, the date the financial statements were available to be issued.

Recent Regulatory Update

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of the SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Group annuity contract: Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer (see Note 4). In determining the reasonableness of the methodology, the Company evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate).

Self-directed brokerage accounts: These accounts include interest-bearing cash, money market funds, mutual funds, common stocks, real estate investment trusts (REITs), U.S. government securities, corporate bonds and an annuity contract. The fair values of mutual funds and money market funds are based on the quoted NAV of the shares held by the Plan at year end. Interest-bearing cash is reported at carrying value which approximates fair value. The fair values of common stocks and the REITs are valued at the closing price reported on the active markets on which the individual securities and REITs are traded. Equity investments are valued at the closing price reported on an active market on which the securities are traded. The U.S. government securities are valued at the closing price models maximizing the use of observable inputs for similar securities. The fair value of bonds for which quoted market prices are not available are valued based on yields currently available on comparable securities of issues with similar credit ratings. The annuity contract is reported at contract value equal to the accumulated cash contributions and earnings less any withdrawals, which approximates fair value (see Note 4).

4. Contracts With Insurance Companies

Group Annuity Contract

The New York Life Anchor Stable Value Fund (Group Annuity Contract) is managed by the New York Life Insurance Company (New York Life). The Group Annuity Contract is intended to be a long-term investment for participants seeking stability of principal. The assets supporting it are invested by the New York Life with this goal in mind. Therefore, New York Life may impose restrictions on the ability to move funds into or out of this investment option or among investment options in general.

New York Life is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate ranges from 2.76% to 4.00%, with the current rate set at 3.73%. The crediting rate is based on a formula established by the contract issuer but may not be less than zero. The current rate is subject to change at any time, but will never fall below the guaranteed minimum. Daily credited interest becomes part of principal and the investment increases through compound interest. All funds invested by the Plan in the Group Annuity Contract receive the same credited rate. The crediting rate is reviewed on a quarterly basis for resetting. The plan sponsor must provide 12 months advance notice to terminate the contract.

New York Life's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. New York Life assumes the risk of investment gain or loss by guaranteeing the principal amount the Plan allocates to this contract.

Certain events may limit the ability of plan participants to transact at contract value. Examples of these events would include (but would not be limited to) premature termination of the contract and termination of the retirement plan. In these examples, the contract value could be reduced by applicable surrender charges upon distribution of contract's funds. These potential restrictions preclude classifying the investment as fully benefit-responsive.

Annuity Contract

An individual annuity contract is held within the participant-directed brokerage accounts and is managed by The Northwestern Mutual Life Insurance Company (Northwestern Mutual). The annuity contract is intended to be a long-term investment for the participant seeking stability of principal.

Northwestern Mutual is obligated to repay the principal and interest at a specified interest rate that is guaranteed to the individual. The crediting rate ranges from 3.50% to 5.00%, with the current rate set at 3.63%. There are no restrictions on the ability to move funds into or out of this investment option or among investment options in general.

Certain events may limit the ability of the participant to transact at contract value. Examples of these events would include (but would not be limited to) premature termination of the contract and termination of the retirement plan. In these examples, the contract value could be reduced by applicable surrender charges upon distribution of contract's funds. These potential restrictions preclude classifying the investment as fully benefit-responsive.

5. Concentrations

As of December 31, 2024, the Plan held one investment fund totaling \$6,822,614 which represented more than 10% of the Plan's net assets available for benefits. As of December 31, 2023, the Plan had no such investment concentrations.

6. Related-Party and Party in Interest Transactions

A portion of the Plan's investments are managed by the trustee, and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for trustee and investment manager services are included in administrative expenses in the accompanying Statement of Changes in Net Assets Available for Benefits. Payments to the trustee for these services totaled \$94,213 for the year ended December 31, 2024. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants subject to graded vesting as described in Note 1 would become 100% vested in the Company's profit sharing contributions portion of their accounts.

8. Tax Status

The Plan adopted a pre-approved plan offered by PPG Retirement Plan Services, Ltd. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

10. Delinquent Participant Contributions

For the year ended December 31, 2024, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule H, Line 4(a) - Schedule of Delinquent Participant Contributions totaled \$22,250 for the year ended December 31, 2024 which was corrected outside of the DOL Voluntary Fiduciary Correction Program (VFCP) and Prohibited Transaction Exemption (PTE) 2002-51 during 2025. The Company compensated the affected participants for lost earnings resulting from the untimely remittances during 2025.




