Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of FXCollaborative Architects LLP Profit Sharing and Incentive Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. Description of Plan

Effective January 1, 1981, FXCollaborative Architects LLP (the "Company" or "Employer") established the FXCollaborative Architects LLP Profit Sharing and Incentive Savings Plan (the "Plan"). The following brief description and summary of major Plan provisions provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is a 401(k) type of defined contribution plan. All eligible employees of the Employer who are at least 21 years of age with three months of service are eligible to participate in the Plan. Union employees, non-resident aliens, leased employees and residents of Puerto Rico are not eligible for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year participants may elect to have a percentage or dollar amount deducted on a pre-tax or Roth basis from their eligible compensation, as defined by the Plan document. Participants may elect to increase, decrease or suspend their contributions according to procedures established by the Employer. The Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a rate of 3% unless they affirmatively opt out. Participants who have attained age 50 before the Plan year-end are eligible to make catch-up contributions up to the statutorily permitted amounts. There is an annual dollar limit as to the amount that can be contributed on a pre-tax or Roth basis into the Plan which is determined by the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified retirement plans.

At the Employer's sole discretion, the Employer may make matching contributions on behalf of each participant in any specific percentage of the participants' elective deferrals. Participants who have completed 12 months of service and are employed on the last day of the year are eligible for the matching contribution. In addition to the matching contribution, the Employer may make a discretionary non-elective contribution. The Employer discretionary non-elective contribution is for each eligible participant who has completed at least 12 months of service and are employed on the last day of the year. During the 2024 Plan year, the Employer did not make a matching contribution or a discretionary non-elective contribution.

Participant Accounts

Each participant's account is credited with the Employer and participant contributions and the investment earnings thereon. The contributions are allocated among investment options according to the participant's instructions. Allocations are based on participant earnings, account balances, or specific participant accounts transactions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the amount accumulated in the participant's vested account.

Vesting

A participant is fully vested in their own contributions and earnings thereon at all times.

Participants' interest in the Employer matching contribution account and Employer discretionary non-elective contribution account will vest based on their years of vesting service, in accordance with the following schedule:

0-1 year	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

Forfeitures

In the event that a participant terminates before becoming fully vested in his or her account balance, the non-vested portion of the participants' account balances will be forfeited as of the termination date. Forfeitures of terminated non-vested accounts will be used to reduce future Employer contributions made to the Plan or used to pay any administrative expenses of the Plan. At December 31, 2024 and 2023, unapplied forfeitures totaled \$0 and \$561. During 2024, no forfeitures were used to reduce Employer contributions and forfeitures of \$3,428 were used to reduce administrative expenses from forfeited non-vested accounts.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participants' accounts and bear interest equal to 1% above the prime rate at the time of the approval of the loan. Loans are repaid through payroll deductions over a period of up to five years unless the loan was made to acquire a residence, in which case, the loan can be repaid over a period greater than five years.

Payment of Benefits

Benefits are paid upon retirement, death, hardship, disability, age 59 1/2 or termination of employment. Upon termination due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. Participants may elect to receive benefits from several options available as set forth in the Plan document. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("US GAAP"), which requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value of Financial Instruments

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable inputs and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value. The mutual funds and money market fund held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These funds are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

Payment of Benefits

Benefits are recorded when paid.

Reclassifications

Certain 2023 amounts have been reclassified to conform with the 2024 presentation.

Expenses

Administrative expenses of maintaining the Plan may be paid by the Company and excluded from these financial statements, or the Plan, at the Employer's discretion. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 10, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution.

4. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

5. Tax Status

The Internal Revenue Service has determined and informed the prototype document preparer by a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Party-in-Interest Transactions

The money market fund is managed by Charles Schwab Trust Bank, the custodian of the Plan, as defined by the Plan document. Accordingly, these transactions are considered exempt party-in-interest transactions.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA and are reflected in the statements of net assets available for benefits as notes receivable from participants.

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
