Note 1 - Plan Description

The following description of Mesa Laboratories, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan Agreement for a more complete description of the Plan's provisions.

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

General

The Plan is a defined contribution plan covering all regular full-time and part-time employees of Mesa Laboratories, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The board of directors of the Company administers the Plan. Fidelity Management Trust Company (Fidelity) serves as trustee, manages plan assets, and maintains the Plan's records. Fidelity offers plan participants a variety of investment options through various mutual funds and a money market fund. Individual accounts are invested in the various investment options at the direction of the participant.

Administration

The Company is the sponsor of the Plan. The board of directors has delegated authority to administer the Plan to an administrative committee, as provided in the Plan Agreement. Fidelity functions as trustee and investment manager. Investment management fees and trustee fees are paid by the Plan in accordance with the Plan Agreement.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 60 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions. Catch-up contributions may be deferred up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances in which inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. Assessment of the significance of particular inputs to the fair value measurements of Plan assets requires judgment and considers factors specific to each asset.
