## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Employee Benefits Plan of Methodist Children's Home Society (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits (in liquidation) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (in liquidation) for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Plan Termination**

As discussed in Note 7 to the financial statements, the Board of Directors of Methodist Children’s Home Society, the Plan’s sponsor, voted in September 2023 to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan is on the liquidation basis for presentation of the 2023 and 2024 financial statements. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors’ Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess

whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Other Matter**

### **Supplementary Schedules Required by ERISA**

The supplementary Schedule of Assets (Held at End of Year) as of December 31, 2024 and Schedule of Reportable Transactions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplementary schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplementary schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

#### **Note 1 – Description of the Plan**

The following description of the Employee Benefits Plan of Methodist Children's Home Society (Plan) provides only general information. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

#### **General**

The Plan is a single employer defined benefit plan covering all employees of Methodist Children's Home Society (Society). The Plan was adopted effective January 1, 1996. Previously, the Society was a participant in the employee benefits plan of United Way Community Services and Affiliated Agencies (UWCS), a multiple employer defined benefit plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended effective July 29, 2019, to freeze the benefits for employees who are hired or rehired on or after July 29, 2019. Effective January 31, 2023, an amendment was adopted that no additional benefits shall accrue after such date.

As further discussed in Note 7, on September 11, 2023, the Society's Board of Directors adopted a resolution to terminate the Plan. As a result, liquidation of the Plan was considered to be imminent and unlikely not to occur.

#### **Eligibility**

Prior to July 29, 2019, an employee was eligible for plan participation after completing one year of service and are at least age 21.

#### **Funding Policy**

The Plan's funding policy is for the Society to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. During 2024 and 2023, the Society made contributions of \$0. A minimum contribution of \$0 was determined for plan years 2024 and 2023. This was covered through the Plan's prefunding balance, so additional contribution was not made for plan year 2024 and 2023. Because the Plan is in liquidation, contributions expected to be paid through the date of liquidation were accounted for. This amounted to \$685,000 at December 31, 2024.

#### **Vesting**

Existing participants of the Plan prior to January 1, 2014, become fully vested upon attainment of early retirement age of 55 or the completion of three years of vesting service. New participants entering the Plan after January 1, 2014, become fully vested upon completing five years of vesting service. In addition, a participant shall be fully vested upon attainment of normal retirement age of 65.

#### **Pension Benefits**

The plan was amended, effective January 1, 2014, to change the normal retirement benefit calculation to 1.125% of final average compensation, multiplied by years of service earned on or after January 1, 2014. Normal retirement benefits for service earned prior to January 1, 2014, are calculated as the greater of 1.625% of final average compensation, multiplied by years of service as of December 31, 2013, plus 0.5% of final average pay in excess of covered compensation multiplied by years of service at retirement (maximum of 35 years). An early retirement benefit is available at a reduced rate.

#### **Death Benefits**

A death benefit is paid to the participant's spouse if the participant dies before retirement benefits start, the participant is married for the full year before death, and the participant's vesting percentage is greater than zero. The death benefit equals the survivor's benefit under a 66 2/3% survivor form. The benefit is payable to the

participant's spouse as of the earliest date the participant could have retired on or after the date of the participant's death. This will be the participant's normal retirement date if they die before your normal retirement date and would not have reached early retirement age before that date. If the participant were still working for the Society on the date of their death, the earliest date the participant could have retired will be determined as if they had stopped working for the Society on the date of their death and survived to retire. This date will be the date of their death if they die on or after their normal retirement date or they had reached early retirement age on the date of their death.

The amount of the benefit is based on the participant's vested benefit when they die. If they are not working for the Society then, it is based on the participant's vested benefit when they stopped working for the Society. If the earliest date the participant could have retired is before their normal retirement date, the vested benefit is adjusted for early retirement. The vested benefit is also adjusted for the 66 2/3% survivor form. Two-thirds of this reduced amount is payable to the participant's spouse monthly for life.

If the value of the spouse's death benefit is \$5,000 or less, such value will be paid to the participant's spouse in a single sum in place of the monthly income.

The participant's spouse may choose to begin benefits on an earlier or later date. If the participant's spouse chooses to begin benefits on an earlier date, the survivor's benefit will be actuarially reduced. If the participant's spouse chooses to begin benefits on a later date, the survivor's benefit will be actuarially increased.

#### **Form of Benefit**

Participants may elect to receive benefits in the form of a joint and survivor annuity, life annuity, installments, or lump sum payments if certain conditions are met as defined in the plan agreement.

## **Note 2 – Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements have been prepared under the liquidation basis. This basis was adopted when liquidation was deemed imminent in accordance with Accounting Standards Update ("ASU") 2013-07, *Liquidation Basis of Accounting*. Plan management determined that liquidation was imminent upon adoption of the resolution to terminate the Plan on September 11, 2023. Under the liquidation basis of accounting, assets are measured at their net realizable value, estimated by fair value reduced by surrender charges, penalties and redemption charges, and disposal expenses, to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process. Liabilities are measured using the accrual basis of accounting, including any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment adviser, and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

#### **Contributions Receivable**

Contributions receivable consist solely of employer contributions receivable. No allowance was recorded as the full balance is deemed collectible. This is the amount expected to be paid to meet all Plan obligations. Liquidation of assets is expected to be completed by December 2025.

#### **Accrued Liquidation Costs**

Upon adoption of the liquidation basis of accounting, the Plan recorded expected costs that will be paid through final liquidation. Liquidation of assets is expected to be completed by December 2025.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain administrative functions are performed by officers or employees of the Society. No such officer or employee receives compensation from the Plan. Certain expenses of maintaining the Plan are paid directly by the Society and are excluded from these financial statements. Fees related to actuarial fees, trustee fees, plan administration, investment advice, and other miscellaneous fees are charged directly to the Plan and are included in administrative expenses on these financial statements. Investment-related expenses are included in investment income.

#### **Subsequent Events**

Management has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

#### **Note 3 – Actuarial Present Value of Accumulated Plan Benefits**

Accumulated plan benefits are those estimated future periodic payments that are attributable under the Plan's provisions for the service employees have rendered. These include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries.

#### Actuarial Assumptions and Methods

The actuarial present value of accumulated plan benefits is determined by the actuary, Principal, and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected payment date.

The significant assumptions used in the valuations as of January 1, 2024 (in liquidation) were:

- Interest rate used to value liabilities: 5.00%
- Asset return: 5.50%
- Mortality basis: Based on Pri-2012 Total dataset base rate mortality table projected generationally using MP-2021.
- Plan expenses: The expected expense included in the target normal cost is an estimate based on prior year expenses paid from the plan assets. This is the best estimate available.

The assumed asset return has decreased from 7.00% (at January 1, 2023) to 5.50% (at January 1, 2024) and the interest rate has decreased from 6.25% (at January 1, 2023) to 5.00% (at January 1, 2024) to reflect current expectations of the Plan’s long-term investment performance. These changes in assumptions resulted in an adjustment to the accumulated plan benefits (see Note 9).

The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2024. Had the valuations been performed as of December 31, 2023, there would be no material differences.

**Note 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under US GAAP are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts – valued at the net asset value (NAV) of units held by the Plan at year end. The NAV, as provided by Principal Trust Company, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The NAV is not a publicly-quoted price in an active market.

Mutual funds – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 5 – Related-Party Transactions and Party-In-Interest Transactions**

Certain plan investments are managed by Principal Life Insurance Company. Principal Trust Company is the Plan's trustee; therefore, these transactions qualify as party-in-interest transactions. The Plan also made payments to Principal Life Insurance Company for administrative expenses and assistance with the Plan termination.

During plan years 2024 and 2023, the plan made payments to LPL Financial, LLC for investment advisory services. Fees incurred by the Plan for these services are netted with investment income and paid through revenue sharing (indirect compensation).

Upon adoption of the liquidation basis of accounting, the Plan recorded expected costs that will be paid through final liquidation. This was \$143,100 as of December 31, 2024. This includes expenses for administration, termination services, and investment advisory services.

**Note 6 – Certification of Investments**

Certain information in the accompanying financial statements and ERISA-required supplementary schedule related to investments as of December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, dividends, and interest for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, a qualified institution.

**Note 7 – Plan Termination**

The Society has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- Benefits for plan participants who retire three years or more before termination
- Those participants who were eligible to retire at least three years before termination
- Those benefits of all other participants that were vested before termination of the plan
- Those nonvested benefits that became vested on termination of the plan

Where a benefit falls in the priorities also depends on:

- Plan provisions in effect five years prior to the termination date.
- A percentage of any increase in benefits due to changes in the plan during the last five years
- Amounts guaranteed by the Pension Benefit Guaranty Corporation
- Limitations for plan participants who are classified as substantial owners
- Dollar maximums on pensions, all as regulations by the Pension Benefit Guaranty Corporation

If the plan does not have enough money to pay all benefits, the law specified the general manner and order that plan assets will be distributed. If this happens, the plan assets will be used up on a priority basis to provide retirement income for plan participants.

The PBGC monthly maximum guaranteed benefit for a 65-year-old retiree in a single-employer plan was \$7,108 and \$6,750 for 2024 and 2023, respectively.

Effective September 11, 2023, the Board of Directors adopted a resolution to terminate the Plan. The effective date of the termination was May 31, 2024. Liquidation of the plan is considered to be imminent and unlikely not to occur. As of the date of termination, all participants were 100% vested in their accrued benefits. Liquidation of assets is expected to be completed by December 2025 (previously expected July 2025).

The Society’s plan of termination is being conducted in accordance with ERISA and PBGC requirements. The process includes locating and notifying participants of their vested accrued benefits, and liquidating the Plan’s investments to pay benefits within the required statutory time frame. Participants will receive formal communications regarding their benefit options, deadlines for elections, and any impact on benefit amounts.

Accumulated benefits may be paid, as elected by participants, in a single lump sum, a deferred annuity, or an immediate annuity. Participants who cannot be located will be reported to the PBGC. For participants who do not elect a form of payment, the Society will purchase an annuity contract in the participant’s name, administered by a qualified insurance company selected by the Society. The insurance company will be responsible for administering the contract and making benefit payments in accordance with ERISA and PBGC requirements. The terms of the annuity contracts, including fiduciary responsibilities and participant rights, will be communicated to affected participants. If plan assets are insufficient to pay all benefits, distributions will be made in the order prescribed by ERISA and PBGC regulations. All expected costs associated with the liquidation, including administrative and professional fees, have been accrued in accordance with the liquidation basis of accounting.

**Note 8 – Tax Status**

The Society adopted a volume submitter defined benefit plan, which received a favorable opinion from the Internal Revenue Service (IRS), dated March 30, 2018, indicating that the volume submitter plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the letter, however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Methods selected by plan sponsor

Asset method

The asset valuation method is prescribed by law for plans that elect to use a value other than market value.

For each of the preceding two years, an expected value of assets at the end of the year is compared to the end of year market value. The resulting gain or loss is recognized evenly over three plan years.

The expected value includes contributions, distributions, any deducted administrative expenses, and expected earnings (based on the lesser of the assumed interest rate or the maximum allowable rate). The deferred gains and losses are added to the current market value and then restricted to no more than 110% and no less than 90% of that market value.

When actual returns exceed the assumed return, the actuarial value of assets will lag below market value. The lag and the smoothing effect are limited since the value must be within 10% of market value.

The Society of Actuaries (SOA) is an actuarial organization that periodically reviews mortality data and publishes mortality tables and improvement scales. In October 2019, the SOA released the Pri-2012 Mortality Tables for private-sector retirement plans in the U.S. The Pri-2012 report contains different sets of mortality tables based on complete dataset or various subsets. The Total dataset base rate table was selected based on information provided by the plan sponsor.

**Mortality improvement**

Pri-2012 section 12.4. provided three approaches for designated beneficiaries in the calculation of joint-and-survivor annuities. We believe "Approach 1" is reasonable for this plan.

MP-2021 is the most recent improvement scale published by the SOA in October 2021.

In selecting this assumption, we considered the other parameters available in the MIM-2021-v4 application tool issued by the SOA in October 2023 and consider the selections in MP-2021 reasonable. Based on the sponsor's input, plan experience does not show a need for long-term excess death or Covid death load adjustments.

**Interest rate used to value liabilities** 5.00%

The interest rate used to value ASC 960 liabilities is developed as long-term expected geometric return on plan assets. Arithmetic expected return is calculated as the weighted average of broad asset classes' arithmetic returns of the plan's target asset allocation, and then converted to the geometric under lognormal distribution assumption. For details, see Long-Term Capital Market Assumptions link.

[Treatment of administrative expenses](#)

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.

The optional form conversion basis is 8.5% interest and the 1983 Individual Annuity Mortality table for payments other than lump sums.

For lump sum payments, the optional form conversion basis uses the applicable interest rate and applicable mortality table as set forth in Code Section 417. The applicable interest rate uses the first calendar month preceding the first day of the stability period which is the plan year.
