### Note 1 – Description of the Plan

The following description of The Profit Sharing and Savings Plan of Graybar Electric Company, Inc. (the “Plan”) is provided for general information purposes only. Graybar Electric Company, Inc. (the “Company”) is the Plan Sponsor. Participants should refer to the Plan document and summary plan description for more complete information of the Plan’s provisions, copies of which can be obtained from the Plan Sponsor.

#### **General**

The Plan is a defined contribution profit sharing plan that includes a 401(k) provision. The Plan was established by the Company in 1956 covering all employees, except employees holding employment contracts or employees who are union members governed by bargaining agreements precluding their participation in the Plan. The Plan is funded by Company and employee contributions. Employees become participants in the Plan on the day they are hired. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The trustee and recordkeeping functions for the Plan are performed by Vanguard Fiduciary Trust Company (the “Trustee”) and The Vanguard Group (the “Plan Recordkeeper”).

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 (“SECURE 2.0”) was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Company has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0.

#### **Contributions**

##### *Participant Contributions:*

Participants may begin making voluntary pre-tax, Roth after-tax, and traditional after-tax contributions to the Plan in the form of payroll deductions as soon as administratively practicable following hire.

The Plan allows participants to make voluntary pre-tax contributions and Roth after-tax contributions of 2% to 50% of their eligible compensation. Employees hired or rehired on or after July 1, 2015, are automatically enrolled to participate in pre-tax contributions at a default contribution rate of 3% of their eligible compensation. Employees have the ability to change this default election or opt out during a 30-day window prior to their enrollment date.

The Plan also allows certain participants to make voluntary traditional after-tax contributions of up to 10% of their eligible compensation to the Plan. Participants’ combined Roth after-tax, traditional after-tax and pre-tax contributions are limited to a maximum of 50% of their eligible compensation.

Participants may also make contributions in the form of a rollover of a lump-sum distribution from other qualified plans and conduit individual retirement accounts (“IRAs”) as defined in the Plan document.

#### ***Contributions (Continued)***

##### *Company Matching Contributions:*

Participants hired or rehired on or after July 1, 2015, are eligible to receive Company matching contributions after achieving certain service time and work hours. Eligible participants receive Company matching contributions beginning the first pay period after completion of six months of service and 500 hours of service. Thereafter, participants must work 1,000 hours each year to receive the Company matching contributions during the subsequent year. The Company matches 50% of eligible participant pre-tax and Roth after-tax contributions up to a maximum of 6% of the participant's eligible compensation. Company matching contributions amounted to \$7,945,973 and \$7,174,911 in 2024 and 2023, respectively.

##### *Profit Sharing Contributions:*

The Company, at the discretion of its Board of Directors, may make a profit-sharing contribution to the Plan. Participants are eligible to share in the Company profit sharing contribution beginning the first pay period following the completion of one year of service and 1,000 hours of service annually. Profit sharing contributions by the Company amounted to \$65,372,529 and \$54,194,361 in 2024 and 2023, respectively.

#### ***Participant Accounts***

Participant accounts are maintained on a cash basis by the Plan Recordkeeper. Participants' equity fund accounts are credited with contributions when received, charged with distributions and administrative expenses when paid, and credited with earned income, including unrealized gains and losses on equity fund investments, at a rate commensurate with equity fund earnings. Participants' Stable Value Fund accounts are credited with contributions when received, charged with distributions and administrative expenses when paid, and credited with earned income at a daily rate calculated and approved by the Plan's investment advisors.

#### ***Vesting***

Participants are 100% vested in their contributions to the Plan and earnings thereon. Company contributions and related earnings thereon become 100% vested upon completion of three years of service. Company contributions transferred into the Plan are subject to the vesting provisions of the plan in which the contributions were made.

Upon the complete or partial discontinuance or termination of the Plan, the account balances of all affected Plan members become fully vested.

#### ***Investment Options***

Participants may select one or a combination of the following investments for both employee and Company contributions made on their behalf:

- Registered investment companies and common/collective trusts (“CCTs”) with a variety of risk and return characteristics.
- Stable Value Fund - invested in investment contracts that may be purchased in conjunction with fixed income securities or units of fixed income funds that invest in such securities, Stable Value commingled investment trusts and/or short-term investment funds.

#### ***Notes Receivable from Participants***

An active participant with a vested balance may borrow up to the lesser of \$50,000 or 50% of their vested Company contribution account and/or pre-tax participant contribution account, with a minimum note of \$1,000. These notes must be repaid within five years, and the participant is charged interest on the outstanding note balance at the prime rate plus 1% as determined on the first calendar day of the quarter in which the note was made. Participant loans transferred into the Plan are subject to the provisions of the plan in which the loan was originated, and any new loan is subject to the loan provisions noted above.

#### ***Payment of Benefits***

Upon termination of service, a participant is entitled to vested benefits, if any, computed in accordance with the terms of the Plan. Any non-vested amount is forfeited.

#### ***Expenses***

Expenses of the Plan are paid primarily with Plan assets. Investment-related expenses are included in net appreciation in fair value of investments.

#### ***Forfeitures***

Forfeitures are used to pay Plan expenses and to restore the accounts of eligible employees rehired and entitled to have amounts forfeited upon prior termination restored to their accounts. Any remaining forfeitures are used to reduce future Company contributions. In the event that the Company does not make a contribution, any remaining forfeitures may be allocated among eligible Plan participants.

At December 31, 2024 and 2023, forfeitures were \$1,976,597 and \$1,076,074 respectively. Forfeitures were available to be used and were fully used to reduce Company contributions in each year.

#### ***Plan Mergers***

Effective January 1, 2024, the Connexion 401(k) Plan merged with the Plan. Net assets of the Connexion 401(k) Plan, in the amount of \$6,952,996, were transferred into the Plan.

Effective February 1, 2024, the Walker Industrial Products, Inc. 401(k) Plan merged with the Plan. Net assets of the Walker Industrial Products, Inc. 401(k) Plan, in the amount of \$1,647,067, were transferred into the Plan.

Effective January 1, 2023, the Steven Engineering, Incorporated Profit Sharing and Employee Savings Plan merged with the Plan. Net assets of the Steven Engineering, Incorporated Profit Sharing and Employee Savings Plan, in the amount of \$15,957,766, were transferred into the Plan.

Effective July 1, 2023, the St. Louis Metro Electric Supply, Inc. Employees' Savings & Profit Sharing Plan and Trust merged with the Plan. Net assets of the St. Louis Metro Electric Supply, Inc. Employees' Savings & Profit Sharing Plan and Trust, in the amount of \$7,645,845, were transferred into the Plan.

### Note 2 – Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual method of accounting.

#### ***Reporting of Fully Benefit-Responsive Contracts***

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Stable Value Fund is a fully benefit-responsive investment and is reported at contract value in the statements of net assets available for benefits. See Note 5 for further information on the Stable Value Fund.

### Note 2 – Summary of Significant Accounting Policies (Continued)

#### ***Use of Estimates and Assumptions***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is accrued when earned. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Subsequent Events***

The Plan has evaluated subsequent events through the date the financial statements were available to be issued, which is the date of the Independent Auditor’s Report.

Effective January 1, 2025, the PDG 401(k) Plan merged with the Plan. Net assets of the PDG 401(k) Plan, in the amount of \$19,445,453, were transferred into the Plan.

Effective September 2, 2025, the Shepherd Electric Company, Inc. 401(k) and Profit Sharing Plan merged with the Plan. Net assets of the Shepherd Electric Company, Inc. 401(k) and Profit Sharing Plan, in the amount of \$45,427,838, were transferred into the Plan.

### **Note 3 – Certification of Investments (Unaudited)**

Financial information related to the investments and notes receivable from participants disclosed in the accompanying financial statements and Schedule of Assets (Held at End of Year), including investments and notes receivables from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained or derived from information provided by the Trustee. This information, which has not been audited by the Plan's independent auditors, has been certified as complete and accurate by the Trustee.

### **Note 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered Investment Companies** - Valued at daily closing prices as reported by the registered investment company ("RIC"), which represent the net asset value ("NAV") of shares held by the Plan at year end. RICs held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The RICs held by the Plan are deemed to be actively traded.

**Common/Collective Trusts ("CCT")** - Valued at the NAV of shares held by the Plan at year end, as reported by the Trustee. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the CCT. While the underlying assets of the CCT are publicly available, the CCT is not. The CCTs annually file Form 5500s as direct filing entities. For the years ended December 31, 2024 and 2023, the Plan had no unfunded purchase commitments or redemption restrictions.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 – Stable Value Fund

The Plan is invested in a Stable Value Fund (the “Fund”) which is managed exclusively for the Plan. The Fund is a conservative fixed income vehicle that invests in a diversified portfolio of high-quality fixed income securities (CCTs and a money market fund) and strives to protect against interest rate volatility by entering into benefit-responsive contracts, such as wrap contracts, guaranteed investments contracts (“GICs”), and separate account contracts issued by major insurance companies, banks and other financial institutions.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Fund because the Fund is fully benefit-responsive. The Fund is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by the Trustee, represents contributions, plus earnings, less participant withdrawals and administrative expenses. Benefit-responsive investment contracts are designed to permit participant withdrawals relating to activities such as investment option transfers, retirement withdrawals, and in-service withdrawals in accordance with the Plan to occur at contract value. However, withdrawals that result from certain actions initiated by the Plan Sponsor, such as bankruptcy filings, plan or fund terminations, and certain layoffs or early retirement programs, may be paid at market value, which could be less than contract value.

The crediting interest rate for wrapped fixed income contracts and separate account contracts is based on a formula agreed upon in the contract and is guaranteed by the issuer not to fall below zero. Such interest rates are reviewed and set on a monthly basis.

### Note 5 – Stable Value Fund (Continued)

Benefit-responsive contracts, including guaranteed investment contracts, wrap contracts, and separate account contracts are agreements with insurance companies and other financial institutions which are designed to help preserve principal and provide a stable crediting rate. These contracts provide that participant-initiated withdrawals, permitted by the Plan, will be paid at contract value. In addition to certain contract termination provisions discussed below, the contracts provide for withdrawals associated with certain events which are not in the ordinary course of Plan operations, and in some cases that the issuer determines will have a material adverse effect on the issuer's financial interest, will be paid with a market value adjustment to the contract value amount of such withdrawal as defined in such contracts. While each contract specifies the events which may trigger such a market value adjustment, such events typically include all or some of the following: (1) amendments to the Plan documents or Plan's administration, including reduction or elimination of employer matching contributions; (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) complete or partial termination of the Plan or its merger with another plan; (4) the failure of the Plan or its trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; (5) unless made in accordance with the withdrawal provisions of the Plan, the withdrawal from the contract resulting from an event at the direction of the Plan Sponsor ("employer-initiated event") such as withdrawals due to the removal of a specifically identifiable group of employees from coverage under the Plan (such as a group layoff or early retirement incentive program), or the closing or sale of a subsidiary, employing unit or affiliate, the bankruptcy or insolvency of a Plan Sponsor, Fund, Trustee or Investment Manager, the merger of the Plan with another plan, or the Plan Sponsor's establishment of another tax-qualified defined contribution plan; (6) any change in law, regulation, ruling, administrative or judicial position or accounting requirement, in any case applicable to the Plan or Fund, and (7) the delivery of any communication to Plan participants designed to influence a participant not to invest in the Fund.

At this time, the Plan Sponsor does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

### Note 6 – Party-In-Interest Transactions

The Plan has investments in funds that are managed by the Trustee. Therefore, transactions related to these funds qualify as party-in-interest transactions.

### Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### Note 8 – Tax Status

The Plan has received a determination letter from the Internal Revenue Service (the “IRS”) dated June 13, 2017, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the “Code”), and therefore, the related trust is exempt from taxation. Subsequent to the issuance of this determination letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

### Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

### Note 10 – Reconciliation of Financial Statements to Form 5500

The financial statements of the Plan, as prepared under U.S. GAAP, include distributions to participants as deductions when paid. The Department of Labor requires notes receivable from participants that violate the Code to be recorded as deemed distributions on the Form 5500 although the Plan still holds the notes receivable from participants as an asset.
