## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee Alliance Health Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Alliance Health Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Alliance Health Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### NOTES TO FINANCIAL STATEMENTS For the Years Ended December 31, 2024 and 2023

#### NOTE 1 – DESCRIPTION OF PLAN

The following description of Alliance Health Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

##### General

The Plan is a defined contribution plan covering all full-time and part-time employees of Alliance Health Professionals, PLLC (“AHP”) and Alliance Management Partners, LLC who have completed one year (1,000 hours) of service. The Plan has been amended, effective September 1, 2024, to credit the service of employees of predecessor employers, as defined in the amendment, for purposes of eligibility. Upon attaining eligibility, Plan entry dates are the first day of each Plan year and the first day of the seventh month of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

##### Plan Amendments

The Plan intends to formally adopt certain provisions from the Secure Act 2.0 by the Plan year ending December 31, 2026. Certain changes were effective as soon as administratively and operationally feasible.

##### Contributions

Each year, participants may contribute any amount up to fifty percent of eligible compensation and the maximum dollar amount permissible, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may elect either regular 401(k) deferrals (pre-tax) or Roth 401(k) deferrals (after tax). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with an initial pre-tax deferral rate set at 4% of eligible compensation. Contributions are automatically invested in a designated age-based target date fund until changed by the participant. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a guaranteed investment contract as investment options for participants. The Company matches the participant’s deferral contribution up to 4% of eligible compensation. In addition, the Company may make a discretionary 5% profit-sharing contribution integrated with social security. Contributions are subject to certain statutory limitations.

### NOTE 1 – DESCRIPTION OF PLAN – CONTINUED

#### Plan Operations

AHP has appointed Fidelity Management Trust Company (“Fidelity”) to serve as Trustee, AHP to act as plan administrator and Fidelity Workplace Services, LLC (“FWS”) to assist AHP with Plan administration. The Trustee is responsible for holding the investment assets of the Plan, executing investment transactions, and making distributions to participants. The plan administrator interprets and communicates the provisions of the Plan and ensures that all government and participant reporting requirements are fulfilled.

#### Participant Accounts

Each participant’s account is credited with (a) the participant’s contribution, (b) allocations of the Company’s matching and profit sharing with social security integration contributions, if applicable and (c) Plan earnings (losses) and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. See Vesting, below.

#### Vesting

Participants are immediately vested in their contributions and the employer matching contributions plus actual earnings thereon. Some employer contributions are discretionary. In the event of an employer discretionary contribution, vesting in the Company’s discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service.

#### Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. On termination of service, participants with vested account balances of \$7,000 or less are subject to involuntary cash-outs, in which automatic distribution of their account balance will occur without direct consent. The Plan allows for in-service distributions upon attainment of age 59 1/2 for all deferral contributions, discretionary employer matching contributions, and rollover contributions for any reason. Financial hardship withdrawals are permitted if certain conditions are satisfied as defined by the Plan.

Benefits are recorded when paid.

#### NOTE 1 – DESCRIPTION OF PLAN – CONTINUED

##### Forfeited Accounts

Forfeited amounts may be used to pay the employer match. During 2024 and 2023, forfeitures in the amount of \$0 and \$2,717, respectively were used to pay a portion of the employer match. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$20,450 and \$8,482, respectively. These accounts will be used to reduce employer contributions.

#### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

##### Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements. See Note 4 for discussion of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

##### Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of benefits are included in administrative expenses and charged directly to the participant's account. See Note 6.

##### Date of Management's Review

The Plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.

#### NOTE 3 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification Topic 820, Fair Value Measurement, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets;
- b. Quoted prices for identical or similar assets or liabilities in inactive markets;
- c. Inputs other than quoted prices that are observable for the asset or liability;
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 3 – FAIR VALUE MEASUREMENTS – CONTINUED

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as quoted by the fund. The mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by The Plan are deemed to be actively traded.

The Plan held no Level 2 or 3 investments at December 31, 2024 and 2023.

#### NOTE 4 – GUARANTEED INVESTMENT CONTRACT WITH TRUST COMPANY

In 2015, the Plan entered into a synthetic fully benefit-responsive guaranteed investment contract with Fidelity. Fidelity maintains the contributions in a commingled pool. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Fidelity, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no unfunded commitments. The contract value of the investment contract with Fidelity was \$1,591,342 and \$1,646,162, at December 31, 2024 and 2023, respectively.

Certain events limit the Plan's ability to transact at contract value with Fidelity. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination) (b) changes to the plan's prohibition on competing investment options (c) employer initiated events (for example, sale of a division, corporate layoff or early retirement) that cause a significant withdrawal from the plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investments guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

#### NOTE 5 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEES

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, all investment information disclosed in the accompanying financial statements and the supplemental schedule of assets held at December 31, 2024 and 2023 and net appreciation in fair value and contract value of investments, earnings and dividends for the years then ended were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity.

#### NOTE 6 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity and investment in a Fidelity guaranteed investment contract. Fidelity is the trustee as defined by the Plan and, therefore these transactions qualify as party-in-interest transactions.

During 2024 and 2023, fees in the amount of \$5,582 and \$4,595 were paid to Strategic Advisors, Inc., for investment advisory services, respectively.

During 2024 and 2023, fees in the amount of \$125 and \$0 were paid to Fidelity Investments Institutional Operations Company, LLC (a wholly owned subsidiary of FWS), for recordkeeping services, respectively.

The trustees of the Plan are currently participants in the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### NOTE 7 – NON EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Company remitted certain participant contributions to the Trust later than required by DOL Regulation 2510.3-102, in the amounts of \$2,824 and \$0 during 2024 and 2023, respectively. The lost earnings, using the Actual Earnings Method, related to the delinquent contributions were remitted to the Trust. The Company filed the required Form 5330 with the IRS and paid the required excise tax on the transactions. Participant accounts were credited with the amount of investment income that would have been earned had the participant contributions been remitted on a timely basis as required by the DOL guidelines.

#### NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, to the extent a participant's account is not already 100% fully vested, participants' accounts will automatically become 100% vested.

#### NOTE 9 – TAX STATUS

The Plan was restated effective January 2, 2022, and the *FMR LLC Non-Standardized Pre-Approved Profit Sharing with CODA* (the "plan") which is used by the Plan, obtained an opinion letter dated June 30, 2020 in which the Internal Revenue Service stated that the plan is acceptable for use by employers for the benefit of their employees under Internal Revenue Code Section 401. The Plan has not requested or received a plan determination letter. However, the Plan's administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

#### NOTE 10 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
