Notes to Financial Statements

Note 1: Description of Plan

The following description of the DeWitt LLP Savings Plan & Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all non-leased employees of DeWitt LLP (the "Employer"). Participants may begin making pretax or Roth deferrals, and may begin receiving Employer contributions, upon employment. All investments are participant-directed. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute up to 100% of eligible compensation. Participants who have reached age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation, which increases by 1% each year until a maximum deferral rate of 15%, unless otherwise changed by the participants.

For the year ended December 31, 2024, the Employer made a discretionary profit-sharing contributions on a tier-based calculation:

- Tier 1 - Participants with eligible compensation greater than \$200,000 (but limited to a maximum of \$345,000 for 2024) - receive an Employer contribution equal to maximum allowed amounts under Internal Revenue Service (IRS) regulations.
- Tier 2 - Participants with eligible compensation between \$100,000 and \$200,000 - receive an Employer contribution equal to 7.0% of eligible compensation.
- Tier 3 - Participants with eligible compensation less than \$100,000 - receive an Employer contribution equal to 5.7% of eligible compensation.

The first 3.0% of the Employer profit-sharing contribution is considered safe-harbor.

Contributions may not exceed the annual maximum allowed by the IRS.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with their participant salary deferral contributions, any rollover contributions, and Employer contributions, as well as allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully and immediately vested in all contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Interest rates on existing loans range from 4.25% - 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may receive a single lump-sum payment or installment payments equal to the value of the participant's vested interest in their account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, hardship distributions out of the participant's voluntary contribution account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants with balances less than \$7,000 who terminate service will have the vested balance of their accounts distributed to them upon termination.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to various plan activities are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in total investment income.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There were no investments requiring the use of Level 2 or Level 3 investments.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: The fair values of the securities are based on observable market quotations for identical assets and are priced on a daily basis at the close of business.

Collective trust fund: Valued at the net asset value (NAV) of units of an investment fund. The NAV, as provided by the fund, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying assets and liabilities of the fund. Fund unit sales and repurchases occur on a daily basis at the NAV per share determined at the close of each business day.

Self-directed brokerage accounts: Accounts consist of mutual funds, exchange traded funds, individual stocks, corporate bonds, treasury bonds, and money market funds which the fair value of which are based on observable market quotations for identical assets and are priced on a daily basis at the close of business.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7: Income Tax Status

The IRS has determined and informed the Employer by a letter dated March 14, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
