**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of the Claypool Electric, Inc. Savings Incentive Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Adjustments to Prior Period Financial Statements**

The financial statements of the Plan as of December 31, 2023 were audited by a predecessor auditor. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated October 9, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, on the modified cash basis which is a basis of accounting other than accounting principles generally accepted in the United States of America (their opinion is not modified with respect to that matter), and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

As part of our audit of the 2024 financial statements, we also audited the adjustments to the 2023 financial statements to retrospectively apply the change in accounting as described in Note 3. In our opinion, such adjustments are appropriate and have been properly applied. We were not engaged to audit, review, or apply any procedures to the Plan's 2023 financial statements other than with respect to the adjustments and, accordingly, we do not express an opinion or any other form of assurance on the 2023 financial statements as a whole.

### **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the 2024 Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - PLAN DESCRIPTION

The following description of the Claypool Electric, Inc. Savings Incentive Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established by Claypool Electric, Inc. (Company or Plan Sponsor) effective January 1, 1988. The Plan covers all eligible employees of the Company. It excludes employees covered by a collective bargaining agreement, non-resident aliens, leased employees and seasonal employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Contributions to the Plan include (i) salary reduction contributions authorized by participants; (ii) matching contributions made by the Company; (iii) discretionary contributions made by the Company; and (iv) participant rollovers from another qualified retirement plan. Participants may make voluntary contributions to the Plan through payroll deductions of not more than one hundred percent (100%) of their eligible pre-tax or after-tax (Roth) total pay, as defined by the Plan, not to exceed the limits imposed by the Internal Revenue Code (IRC). Additionally, the Plan allows participants who have attained the age of 50 by the end of the Plan year to make catch-up contributions in accordance with IRC Section 414(v). Participants may also roll over into the Plan amounts representing distributions from other qualified retirement plans or individual retirement accounts.

The Plan has an automatic enrollment provision, whereby all employees are automatically entered in the Plan, electing a 3% deferral percentage when determined eligible, unless the employee waives participation or elects a different deferral percentage. Contributions made by automatically enrolled participants are invested in a designated balanced fund until changed by the participant. Participants direct the investment of all contributions into the various investment options offered by the Plan.

The Company's provision to match eligible employees' deferral is up to 20% of employee contributions. Additional profit-sharing amounts may be contributed at the discretion of the Plan Sponsor. During the year ended December 31, 2024, the Company made a profit-sharing contribution to the Plan totaling \$500,000. The Company also makes prevailing wage contributions for eligible employees that are covered under government contracts. Prevailing wage contributions are based on a formula included in the government contracts for the hours worked on specified services. Prevailing wage contributions are offset by any discretionary profit-sharing contributions made by the participant.

Participant Accounts - Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contribution and related matching and discretionary contributions and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Vesting - Participants are immediately vested in their contributions and employer prevailing wage contributions plus any earnings thereon. Upon retirement, death or disability, participants become 100% vested in their accounts. Participants are 100% vested after three years of service. Vesting of the employer matching and employer profit sharing contributions is based on years of service, as follows:

Payment of Benefits - Upon termination of service due to death, disability, retirement, separation or attainment of age 59½ (in-service distribution), a participant or his/her beneficiary, as applicable, may receive a lump-sum distribution of his/her vested account balance. The Plan has an immediate distribution of vested accounts of \$5,000 or less. These distributions are either paid in cash or are rolled over to an IRA on the employee's behalf. Nonvested account balances are treated as forfeitures.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships in accordance with the guidelines of ERISA. Following a hardship withdrawal, participants are not allowed to contribute to the Plan for a period of six months.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying statements of net assets available for benefits and related statement of changes in net assets available for benefits and the related notes to the financial statements (financial statements) is as follows:

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting for 2024. The 2023 amounts, unless otherwise noted "as adjusted," are on the modified cash basis.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Forfeited Accounts - Contributions that are not vested upon retirement, death or disability are used to reduce employer contributions or Plan administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$15,800 and \$1,600, respectively. During 2024, administrative expenses were reduced by approximately \$3,400 from forfeited nonvested accounts.

Payment of Benefits - Benefit payments to participants are recorded when paid.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses - Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Management fees and operating expenses related to participant directed transactions are allocated to participant accounts. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

NOTE 3 - CHANGE IN ACCOUNTING PRINCIPLE

Effective for the year ended December 31, 2024, the Plan elected to change its basis of accounting from the modified cash basis to accounting principles generally accepted in the United States of America (U.S. GAAP). The modified cash basis of accounting is a comprehensive basis of accounting other than U.S. GAAP, which recognizes revenues when received and expenses when paid, with certain modifications.

The change was made to improve the consistency and comparability of the Plan's financial statements with those of other employee benefit plans and to align with regulatory and industry best practices.

As a result of this change, the financial statements for the prior period have been retrospectively adjusted to reflect the application of U.S. GAAP. The impact of the change includes adjustments to the 2023 employer and participant contribution receivables have been adjusted, as noted on the statement of net assets available for benefits, as well as the beginning of year net assets available for benefits amount on the statement of changes in net assets available for benefits.

The following table summarizes the effect of the change on the beginning net assets available for benefits as of December 31, 2024:

NOTE 4 - INFORMATION CERTIFIED BY THE PLAN TRUSTEE (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by the Plan administrator and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (the trustee of the Plan).

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Certain administrative functions are performed by officers or employees of the Company at no cost to the Plan. These transactions qualify as party-in-interest transactions.

NOTE 6 - TAX STATUS

The Plan has adopted a non-standardized pre-approved profit-sharing Plan document, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan is qualified pursuant to the appropriate sections of the IRC. The Plan has been amended since adopting the non-standardized pre-approved profit-sharing Plan document. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for tax years prior to 2021.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan in whole or part subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested and account balances will be distributed in accordance with the Plan agreement.

NOTE 8 - FAIR VALUE MEASUREMENT

The Financial Accounting Standards Board (FASB) accounting standard for Fair Value Measurement establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology are based on quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Cash and Cash Equivalents - Valued at \$1, which approximates fair value

Mutual Funds - Valued at the net asset value (NAV) of shares held by the Plan at year-end based upon quoted market prices. Mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust - Valued at NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above might produce a fair value calculation that might not be indicative of net realizable value or reflective of future fair values. Further, while the Plan administrator believes that the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan was restated effective January 1, 2025 following Park National Bank's conversion to GoRetire as its new online platform. In addition to the terminology changes to align with GoRetire, the following changes have also been made: seasonal employees are now eligible, and participants with balances of \$1,000 or less now roll into an Individual Retirement Account instead of the forced-out distributions.
