Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Talus Payments 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Talus Payments 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan whereby eligible employees of FPT Operating Company, LLC (the Company or Employer or Plan Sponsor) are permitted to make post-tax and pretax contributions that are tax-deferred under Section 401(k) of the Internal Revenue Code (the Code). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became effective on January 1, 2018, and was restated effective January 1, 2022.

Eligibility: Employees of the Company, aside from union, leased, nonresident aliens and commissioned sales agent employees, become eligible to participate in the Plan on the entry date (first day of each calendar month) following the completion of 60 days of service, as defined by the Plan.

Contributions and investment options: Each year, participants may contribute up to 100% of post-tax or pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

For the year ended December 31, 2024, the Company made safe harbor matching contributions equal to 100% of the participant's matched employee contributions that were not in excess of 3% of the participant's compensation plus 50% of the amount of the participant's matched employee contributions that exceeded 3% of the participant's compensation but that did not exceed 5% of the participant's compensation.

The Company may also make profit sharing contributions equal to a discretionary amount. The contribution is given pro-rata to participants in the ratio that each participant's compensation bears to the compensation of all eligible participants. For the year ended December 31, 2024, the Employer did not make any discretionary profit sharing contributions. Participants must have worked for six months and be an active employee on the last day of the plan year with at least 1,000 hours of service during the plan year to be eligible to receive the profit sharing contributions.

Vesting: Participants are immediately vested in their contributions and employer safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions are based on years of continuous service. A participant is 25% vested after one year of credited service, 25% for each additional year, and is fully vested after four years. A participant is 100% vested regardless of years of service, upon disability, death or attaining normal retirement age.

Participant accounts: Each participant's account is credited with the participant's contribution, rollover contributions and allocation of (a) the Company's safe harbor matching contributions, the Company's discretionary matching contributions and the Company's discretionary profit sharing contributions, if any, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits: On termination of service due to death, disability, termination of employment or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Installments are allowed for required minimum distribution purposes only. If the participant's vested balance is less than \$5,000, benefits shall be distributed to the participant through a lump-sum distribution, or, if no election has been made by the participant, through a direct rollover into an Individual Retirement Account.

Note 1. Description of the Plan (Continued)

Participants may receive an in-service distribution from the Plan prior to termination provided they have attained age 59½ and are fully vested. In addition, hardship distributions may be made to satisfy certain immediate and heavy financial needs a participant may have, subject to certain limitations as defined in the Plan agreement.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested amounts were not significant in nature. Forfeitures may be allocated to the participants based on the Company's matching contributions to the participant's account, or used to pay administrative expenses. No forfeitures of terminated participants' nonvested accounts were reallocated to participants in the 2024 plan year for employer match or used to pay administrative expenses.

Notes receivable from participants: The Plan allows participants to borrow a minimum of \$1,000 up to a maximum of \$50,000 from their fund accounts, up to 50% of the participant's vested account balance. A participant can only have one outstanding note at a time. Notes receivables are secured by the vested balance in the participant's account and bear interest at the national prime interest rate plus 2% per year. The interest rates on the outstanding notes receivable ranged from 5.25% to 10.50% at December 31, 2024. Note terms generally range from one to five years. Principal and interest is collected each pay period through payroll deductions, and loans are due in varying amounts through July 2029.

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Summary of Significant Accounting Policies

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental Schedule H, line 4i—schedule of assets (held at end of year).

Note 2. Summary of Significant Accounting Policies (Continued)

Contributions and contribution receivables: Contributions are recorded on the accrual method of accounting. Contribution receivables are obligations arising from amounts owed to the Plan from the participants or the Employer that have not been included in the Plan's investments at year-end. Contribution receivables are recorded at cost.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Administrative expenses are paid by the Company or the Plan. Certain administrative functions are performed by employees of the Company. However, such employees receive no compensation from the Plan.

Subsequent events: The Plan Administrator has evaluated events and transactions for potential recognition or disclosure through October 8, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are discussed below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of an input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued based upon quoted market prices in the active market in which they are traded and are classified within Level 1 of the valuation hierarchy.

Money market fund: Valued at the quoted market price reported on the active market in which it is traded and is classified within Level 1 of the valuation hierarchy.

Note 5. Party-in-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary to the Plan or party rendering services to the Plan, the Employer and certain others. As such, transactions conducted with the Company and BOKF, NA, the Plan's trustee, qualify as party-in-interest transactions.

Note 6. Tax Status

The Plan has adopted a non-standardized pre-approved plan sponsored by BOKF, NA. The plan provider has received an advisory letter from the Internal Revenue Service (IRS) as to the plan's qualified status on June 30, 2020. The plan advisory letter has been relied upon by the Plan. The Plan has been amended since the Plan received the advisory letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan may invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, the participants become fully vested in their employer contribution balances, and the net assets of the Plan will be distributed to the participants of the Plan in accordance with the provisions of ERISA.
