INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Gellert Global Group Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Notes 3 and 4 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section –

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Gellert Global Group Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

GENERAL:

The Plan is a defined contribution 401(k) profit-sharing plan established on January 1, 1976, covering eligible employees of Atalanta Corporation, J.F. Braun & Sons, Inc., Camerican International, Inc., Tipico Products Co., Inc., Gellfam Management Corp. and GHG Holdings LLC. The participating employers in the Plan are collectively referred to as “Gellert Global Group” or “the Company.”

The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (the IRC), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

ELIGIBILITY:

All employees of the Company are subject to the following eligibility requirements:

- Age: 18 years
- Service: 3 months

Upon satisfying the eligibility requirements, employees may participate in the Plan on the first day of the following month.

PLAN TRUSTEE:

The trustee of Plan investments is Bank of America, N.A. (Bank of America or Trustee).

PLAN CUSTODIAN:

Plan investments are held by Bank of America under a custodian contract.

PLAN ADMINISTRATION:

The Plan is administered by Gellert Global Group. Merrill Lynch, Pierce, Fenner & Smith Incorporated (Merrill Lynch), a subsidiary of Bank of America Corporation, is the Plan’s third-party administrator and recordkeeper.

CONTRIBUTIONS:

Participants may direct the Plan to deposit up to 100% of their annual compensation directly into their Plan accounts on a before-tax basis, subject to IRC limitations. The Company makes safe harbor matching contributions at a rate of 100% of the first 3% of salary deferrals, plus 50% of the next 2% of salary deferral, up to 4% of an employee’s eligible compensation. Participants may also designate all or any part of their salary deferral contributions to the Plan as Roth deferrals.

Participants who are age 50 or older before the close of the plan year may elect to make a catch-up contribution, subject to IRC limitations. The Company makes matching contributions on participant catch-up contributions if the participant was unable to receive the maximum match under the Plan formula because of IRC limitations on salary deferral contributions.

The Plan also provides for rollover contributions by participants subject to limitations defined in the Plan agreement. Rollover contributions represent contributions by employees of benefits from other benefit plans they had contributed to prior to joining the Company.

PARTICIPANT ACCOUNTS:

Each participant's account is credited with the participant's contribution, a share of the Plan's matching contribution, investment earnings or losses and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. An election may be made upon retirement, death or termination to be paid in a lump sum or an annuity.

INVESTMENT CHOICES:

Upon enrollment in the Plan and anytime thereafter, a participant may elect direct contributions or investment balances among the various investment options.

VESTING:

Participants are immediately vested in all employee contributions made to their accounts, plus actual earnings thereon and employer safe harbor matching contributions.

PAYMENT OF BENEFITS:

The distribution to which a plan participant is entitled is the participant's vested account balance, including net realized and unrealized investment gains or losses. An election may be made upon termination, retirement, disability or death, to be paid in a lump sum or an annuity.

NOTES RECEIVABLE FROM PARTICIPANTS:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 (reduced in the case of participants' prior loans outstanding) or 50% of the vested account balance from their accounts. The loans are secured by the balance in the participant's account, are withdrawn on a pro rata basis from the investments in the participant's account and bear interest at the prime rate plus 1%. The loan term, as approved by the Plan's Committee, cannot exceed five years, except for a loan for a primary residence, which can be extended. A participant may have up to two loans outstanding at a time. Pro rata repayments of principal and interest, generally through monthly payroll deductions, are credited directly to the borrower's account. Delinquent loans are treated as distributions based on the terms of the Plan document.

ADMINISTRATIVE EXPENSES:

Administrative expenses of the Plan are paid by the Plan or the Plan Sponsor, as provided in the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING:

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting.

USE OF ESTIMATES:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan also invests in investment contracts that are reported at contract value, as defined by the terms of the contract, at the measurement date (see Note 5 for discussion of valuation measurements).

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date, and interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

OTHER INCOME:

The Plan may receive revenue sharing payments from investments in which the Plan's assets are invested. The administrative services agreements between the Plan and the Trustee provides that, to the extent that revenues sharing payments received by the Trustee exceed administrative fees charged to the Plan by the Trustee, the excess will be credited to the Plan's revenue sharing accounts and used to reduce Plan expenses. These credits are included in other income in the statements of changes in net assets available for benefits. During the year ended December 31, 2024, the Company used approximately \$255,000 from these accounts to pay administrative expenses. As of December 31, 2024 and 2023, unallocated amounts in the revenue sharing accounts totaled approximately \$304,000 and \$346,000, respectively.

PAYMENT OF BENEFITS:

Benefits are recorded when paid by the Plan.

NOTES RECEIVABLE FROM PARTICIPANTS:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued and unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024, and 2023. Delinquent loans are treated as distributions based on the terms of the Plan document.

NOTE 3 - FULLY BENEFIT- RESPONSIVE INVESTMENT CONTRACT

The Plan entered into a traditional insurance investment contract with New York Life Insurance Company (New York Life). With traditional investment contracts, the Plan owns only the contract itself and not the underlying assets. The insurance investment contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value was \$5,987,615 and \$6,191,164 as of December 31, 2024 and 2023, respectively.

New York Life Insurance maintains the contributions under the investment contract in a pooled separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contributions to the contract are invested in New York Life's Pooled Separate Account No. 25 (Separate Account). The Separate Account is invested primarily in a diversified and conservative array of fixed income securities and cash-equivalent investments. The investments in the Separate Account are intended to provide a stable crediting rate consistent with preservation of principal. The assets in this account are owned by New York Life and maintained solely for the benefit of participating retirement plans. The Separate Account is not chargeable with any other liabilities arising out of any other business of New York Life.

The insurance investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer and is reviewed periodically for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE 4 - INFORMATION CERTIFIED AND PROVIDED BY PLAN TRUSTEE

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, that was prepared by or derived from information provided by the Trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator by the Trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information, that appears throughout the financial statements and ERISA-required supplemental schedules, related to the following assets at December 31, 2024 and 2023:

NOTE 5 - FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 inputs) and the lowest priority to unobservable inputs (Level 3 inputs). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Fair values are based on the daily price as reported by the fund. The mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 investments.

Common collective trust fund: Stable value fund that is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption from the fund, the issuer reserves the right to defer payments for up to one year in order to ensure that securities liquidations will be carried out in an orderly business manner.

Life insurance contracts: Valued at the cash surrender value of the policies as reported by the insurer, which is deemed reasonable to fair value, and which are classified as Level 3 investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's life insurance contracts, which are reported as Level 3 assets, may be subject to certain liquidity restrictions. No unobservable inputs have been utilized in the valuation of these investments. During 2024, life insurance annuity contracts owned by the Plan and for the benefit of individual participants/annuitants were transferred out of the Plan and into separate accounts owned directly by the annuitants. These amounts are included in benefits paid to participants in the statement of changes in net assets available for benefits.

NOTE 6 - EXEMPT PARTIES-IN-INTEREST TRANSACTIONS

Certain administrative expenses of the Plan were paid by the Company during the year ended December 31, 2024. These transactions qualify as exempt party-in-interest transactions.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investment options in combinations of mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are entitled to the entire amount of their accounts.

NOTE 9 - INCOME TAX STATUS

The Plan Sponsor has adopted a non-standardized pre-approved plan sponsored by Merrill Lynch Pierce Fenner & Smith Inc. (Merrill Lynch). Merrill Lynch has received an opinion letter from the IRS dated June 30, 2020, as to the pre-approved plan's qualified status. The pre-approved plan's opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 - PROHIBITED TRANSACTIONS

During 2024 and 2023, the Plan Sponsor inadvertently failed to deposit approximately \$35,000 and \$127,000, respectively, of participant contributions within the required timeframe as stated by DOL regulations. In 2025, the Plan Sponsor made corrective contributions of lost earnings to the Plan for contributions related to years 2023 and prior. The Plan intends to make corrective contributions of lost earnings for contributions attributable to 2024 in 2025. The corrections were made from Plan Sponsor's assets and not from assets of the Plan.

NOTE 11 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events for potential recognition and or disclosure through October 8, 2025, the date the financial statements were available to be issued.

On April 8, 2025, employees of Gouda Holdings LLC, became eligible to participate in the Plan. The Plan document was amended to waive eligibility requirements for all employees of Gouda Holdings LLC employed as of that date.
