Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Tax Deferred Annuity Plan for The Arc of Central Alabama, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Tax Deferred Annuity Plan for The Arc of Central Alabama, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from the qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in the notes to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Tax Deferred Annuity Plan for The Arc of Central Alabama, Inc. and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Tax Deferred Annuity Plan for The Arc of Central Alabama, Inc.'s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1. PLAN DESCRIPTION

The following description of the Tax Deferred Annuity Plan for The Arc of Central Alabama, Inc. (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Arc of Central Alabama, Inc. (the "Organization") established the Plan to provide employees with a systematic means of savings and investing for the future. The Organization is the sponsor of the Plan, and the trustees are Voya Retirement Insurance and Annuity Company and Lincoln National Life Insurance Company. The Plan is a defined contribution plan subject to the provisions of the *Employee Retirement Income Security Act of 1974 ("ERISA")*.

Eligibility

All permissible employees of the Organization, as defined in accordance with the universal availability requirements are eligible to enroll on their date of hire. Deferrals begin on the first payroll period after enrollment.

Plan Contributions

Eligible employees, who elect to enter into a payroll reduction agreement, must contribute at least \$200 per plan year up to the statutory limit as prescribed by the Internal Revenue Code. The Organization makes discretionary matching contributions, available to all participants, of up to 100% of participant contributions. The matching contribution during the year ended December 31, 2024 was 100% of up to 10% of participant salaries.

The Organization also makes contributions on behalf of former employees at the rate of 8% of the employee's final salary for a period of five years after severance. This contribution is available to all former employees who had 20 years of continuous employment and who provide a one-year notice of retirement.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Organization's matching contributions, and Plan earnings (net of administrative expenses). Allocations are based on the eligible compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

Investment Options

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Organization's contributions into the group fixed annuity with a guaranteed fund as well as to separate accounts that purchase regulated mutual funds at the direction of the participant.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Organization's matching and discretionary contribution portion of their account plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after 6 years of credited service.

Payment of Benefits

Upon retirement, disability, or death, a participant or beneficiary receives the entire amount credited to the participant's account in either a lump sum or, at the participant's election, in annual installments. Upon termination, other than by retirement, disability, or death, a participant becomes eligible to receive only the vested percentage of the current value on their account balances.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$89,890 and \$8,182, respectively. These accounts are used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$66,702 from forfeited nonvested accounts.

Notes Receivable from Participants

Participants may borrow from their account balances with interest charged at an adjustable rate. The interest rate is adjusted down if the Moody's Corporate Bond Yield monthly average for the calendar month two months prior to the first day of each calendar quarter is .5% less than the interest rate of the loan; the loan rate may decrease but will never increase. Loan terms range from 1 to 5 years or up to 20 years for the purchase of a primary residence. The minimum loan is \$1,000 and the maximum loan is the lesser of \$50,000, less the highest outstanding loan balance during the one-year period prior to the new loan application date, or 50% of the present value of the participant's vested account balance. The loans are secured by the balance in the participant's fixed account.

Principal and interest payments are required to be amortized in level payments, not less frequently than quarterly. Participants may have only one loan outstanding at any time under the current contract.

Participant Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans or 403(b) plans.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investments contracts. Contract value is the relevant measure for the portion of the net assets for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions

Amounts paid to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as paid and charged to distributions to participants and beneficiaries on the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Non-investment costs and administrative expenses of the Plan are paid by the Company, which is a party-in-interest. These expenses constitute exempt party-in-interest transactions under ERISA.

Subsequent Events

The Plan evaluates events occurring after the date of the financial statements to determine if recognition in the financial statements or disclosures is appropriate. The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

NOTE 3. INVESTMENT INFORMATION

The Plan's investments are held and administered by the following service providers: Voya Retirement Insurance and Annuity Company and Lincoln National Life Insurance Company. All investment information presented in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the trustees listed above. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the information which appears throughout the financial statements and supplemental schedule related to the following assets:

NOTE 4. GUARANTEED INVESTMENT CONTRACTS

The Plan holds a portfolio of investment contracts that meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this amount would be received by participants if they were to initiate permitted transaction under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The contract issuers are contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3%. Such interest rates are reviewed and adjusted on a quarterly basis.

The Plan's ability to receive amounts due in accordance with full benefit-responsive contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events would include any events except the following: (1) to make a payment due to participant's death, disability, retirement or termination of employment, excluding termination of employment due to Plan termination, business shutdown, or any other program instituted by the employer which would reduce the work force by more than 20%; (2) to make a payment for a participant hardship as allowed by the Plan; (3) to make a payment pursuant to a Qualified Domestic Relations Order; (4) to purchase an annuity option as allowed by the contract. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE 5. FAIR VALUE MEASUREMENTS

Authoritative accounting guidance establishes a framework for measuring fair value and defines fair value as the price that would be received to sell an asset or paid to transfer a liability (an exit price), rather than the price that would be paid to acquire an asset or received to assume a liability (an entry price).

Fair value measurements should reflect the assumptions that market participants would use in pricing an asset or liability, including risks inherent in the valuation technique, the effect of any restrictions on the sale or use of an asset, and the risk of nonperformance.

Required disclosures include stratification of the Plan's assets measured at fair value based on the inputs used to derive those measurements. The hierarchy of inputs is as follows:

- Level 1 – Valuations based on quoted prices for identical assets or liabilities in active markets (including exchanges and over-the-counter markets with sufficient volume).
- Level 2 – Valuations based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, or model-based techniques for which all significant assumptions are observable.
- Level 3 – Valuations derived from model-based techniques that use significant unobservable inputs. These unobservable assumptions reflect the Plan's own estimates of the assumptions that market participants would use in pricing the asset or liability. Examples of techniques include option pricing models, discounted cash flow models, and use of market prices of assets or liabilities that are not directly comparable.

The fair value measurement level is determined based on the lowest level of significant input used in the valuation. Valuation techniques are required to maximize the use of observable inputs and minimize the use of unobservable inputs.

Valuation Methodologies

The following is a description of the valuation methodologies used for assets measured at fair value:

Variable accounts consist of unit investment trust separate accounts that purchase regulated mutual funds at the direction of the participant. These assets are valued at the net asset value of shares held by the plan as reported by the unit investment trust separate accounts (NAV practical expedient).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6. TAX STATUS

The Plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The plan administrator intends to apply for a determination letter on the Plan when the government opens such program. The Plan is required to operate in conformity with the Code to maintain its tax exemption. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

NOTE 8. RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H FORM 5500

There are no reconciling items between the accompanying financial statements and Schedule H of the 2024 Form 5500.

NOTE 9. TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan invests in annuities sponsored by the Plan's trustees, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan for investment management services amounted to \$34,431, and are party-in-interest transactions.

NOTE 10. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
