## Independent Auditors' Report

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**1. Description of Plan**

The following description of the Horton Lees Brogden Lighting Design, Inc. 401(k) Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees of Horton Lees Brogden Design, Inc. (the "Company" or "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

***Contributions***

Each year, participants may contribute a percentage of their annual compensation on a pre-tax or Roth (after-tax) basis up to the applicable dollar amount which is established annually by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the statutorily permitted amount.

Participants may also rollover or transfer amounts representing distributions from other eligible retirement plans.

The Company will make a safe harbor nonelective contribution in an amount of 3% of eligible compensation. The Company may also make an additional profit sharing contribution and a flexible discretionary matching contribution. For the 2024 Plan year, no additional profit sharing contribution or flexible discretionary matching contributions were made.

***Vesting***

Participants are fully vested at all times in their contributions and safe harbor nonelective contributions. Participant's vest in profit sharing contributions and flexible discretionary matching contributions in accordance with the following schedule:

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$0. These accounts will be used to reduce employer contributions or administrative expenses. In 2024, forfeitures of \$1,076 were used to pay administrative expenses and \$4,566 were used to reduce employer contributions.

**1. Description of Plan (continued)**

***Notes Receivable from Participants***

Participants may borrow up to the lesser of \$50,000 or 50 percent of their account balance with a minimum loan of \$1,000. The loans are secured by the balance in the participant's account. All loans bear interest at a commercially reasonable rate of interest. Principal and interest are paid ratably through payroll deductions. The loan must be repaid within a period not to exceed five years from the date the participant receives the loan, unless the loan is for the purchase of the participant's principal residence, in which case the loan must be repaid within the period permitted.

***Expenses***

Certain expenses of maintaining the Plan may be paid by the Company and are excluded from these financial statements. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) the employer contributions, if any, and (b) Plan earnings (losses). Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in their account.

***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**2. Summary of Significant Accounting Policies (continued)**

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value except for the group annuity contract, which is stated at contract value. The mutual funds are valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission and they are required to publish their daily net asset value and to transact at that price. These mutual funds are deemed to be actively traded. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The pooled separate account is reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

***Payment of Benefits***

Benefits are recorded when paid.

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company and Principal Life Insurance Company, qualified institutions.

***Common/Collective Trusts***

The Plan offered various common/collective trusts called the Principal LifeTime Hybrid Collective Investment Funds (“LifeTime Funds”). These LifeTime Funds included: the Principal LifeTime Hybrid 2020 Fund; the Principal LifeTime Hybrid 2025 Fund; the Principal LifeTime Hybrid 2030 Fund; the Principal LifeTime Hybrid 2035 Fund; the Principal LifeTime Hybrid 2040 Fund; the Principal LifeTime Hybrid 2045 Fund; the Principal LifeTime Hybrid 2050 Fund; the Principal LifeTime Hybrid 2055 Fund; the Principal LifeTime Hybrid 2060 Fund; and the Principal LifeTime Hybrid 2065 Fund. The unit value of each of these LifeTime Funds was determined on a daily basis. Units were issued and redeemed at their unit value. Net investment income and realized and unrealized gains and losses on investments were not distributed to participants but were reflected in the unit value. The Plan was not invested in the common/collective trusts at December 31, 2024.

**5. Group Annuity Contract**

The Principal Guaranteed Option (the “PGO”) is a guaranteed general account backed group annuity contract issued by Principal Life Insurance Company. Because the PGO is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the PGO.

A rate of interest is contractually guaranteed by Principal Life Insurance Company and is credited to participant’s account balances. This net crediting rate is after the deduction for fees for administrative and record-keeping services provided to the Plan. The rate is reset on a semiannual basis.

Benefit payments are made at contract value (i.e. no market value adjustments or surrender charge adjustments) for plan benefit events including: retirement, death, disability, termination of employment, loans, withdrawals, or Plan termination. Benefit payments to participants for plan events are made without any surrender charge or early termination charge. There are no restrictions on investment transfers initiated from the PGO to non-competing investment options. Notification of a Plan’s intent to terminate its interest may be revoked within 90 days of the receipt of such notice, after which time, the notice becomes irrevocable.

The credit risk of the issuer, Principal Life Insurance Company, was evaluated by nationally recognized statistical rating agencies as follows: Moody’s Investors Service (A1 as of July 2024), Standard and Poor’s (A+ as of April 2024), A.M. Best Company (A+ as of March 2024), and Fitch (AA- as of June 2024).

**6. Tax Status**

The Plan's prototype plan document preparer has obtained an opinion letter dated June 30, 2020 from the IRS stating that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

**7. Party-in-Interest Transactions**

Certain Plan investments are managed by Principal Trust Company and Principal Life Insurance Company, the trustees of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants on the statements of net assets available for benefits.

Certain employees of the Company, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements.
