## NOTES TO FINANCIAL STATEMENTS

### Anesthesia Associates, P.L.L. Profit Sharing Plan and Trust

#### **1 Description of Plan**

The following description of Anesthesia Associates, P.L.L. Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### ***General:***

The Plan, which began January 1, 1984 is a defined contribution plan covering all eligible employees of Anesthesia Associates, P.L.L. (the “Partnership”) who meet the eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was most recently restated effective January 1, 2022 for regulatory changes.

Effective December 31, 2023, the Plan is terminated. All participants are 100% vested in their accounts and the financial statements are presented on the liquidation basis of accounting from 2023 onwards.

##### ***Eligibility:***

All employees of the Company who have worked one hour of service are eligible to participate in the Plan.

##### ***Contributions:***

Employee Contributions - Participants may elect a portion of their compensation to be contributed to the Plan, up to the maximum allowed under current regulations. In addition, the Plan offers 401(k) Roth Contributions as well as catch up contributions to those who meet the age requirements.

Employer Safe Harbor Contribution - The Company may make on an annual basis a safe harbor non elective contribution to each eligible participant's account. Only non-highly compensated employees will be eligible for the safe harbor contribution.

Employer Discretionary Contributions - The Company may also make additional contributions. Such additional contributions, if any, shall be allocated to each Participant based on an allocation for each participant.

Rollover contributions from other Plans are also accepted.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code as defined in the Plan agreement.

##### ***Participants' Accounts:***

Each participant's account is credited with the participant's elective contributions, employer contributions, earnings and losses thereon.

## NOTES TO FINANCIAL STATEMENTS

### Anesthesia Associates, P.L.L. Profit Sharing Plan and Trust

#### **1 Description of Plan, Continued**

##### ***Vesting:***

All participants are 100% vested in elective deferrals, safe harbor non-elective contributions and rollover contributions made to the Plan.

##### ***Other Plan Provisions:***

Normal retirement age is 65. In-Service distributions are permitted if the participant is working after normal retirement age.

##### ***Payment of Benefits:***

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant may elect any of the following payment options: Single sum payments, and installment payments. Preretirement Survivor Annuity or Qualified joint and Survivor Annuity are only permitted for participants with a balance from a prior Money Purchase Pension Plan. Benefits are recorded when paid.

##### ***Investment Options:***

Upon enrollment in the Plan, a participant may enroll in a self-directed retirement account.

#### **2 Summary of Significant Accounting Policies**

##### ***Basis of Accounting:***

The Plan's transactions are reported on the liquidation basis of accounting.

##### ***Valuation of Investments:***

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

##### ***Use of Estimates:***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

## NOTES TO FINANCIAL STATEMENTS

Anesthesia Associates, P.L.L. Profit Sharing Plan and Trust

### 2 Summary of Significant Accounting Policies, Continued

#### *Administrative Fees:*

Substantially all administrative fees are paid by the Partnership.

#### *Risks and Uncertainties:*

The Plan's investment include investments with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for plan benefits.

#### *Subsequent Events:*

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

### 3 Tax Status

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

### 4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### 4 Fair Value Measurements, Continued

The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets
- \* Quoted prices for identical or similar assets or liabilities in inactive markets
- \* Inputs other than quoted prices that are observable for the asset or liability
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value.

#### ***Mutual Funds:***

The fair value of the mutual funds are based on quoted market prices.

#### ***Self-Directed Brokerage Account:***

Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

## NOTES TO FINANCIAL STATEMENTS

### Anesthesia Associates, P.L.L. Profit Sharing Plan and Trust

#### **1 Description of Plan**

The following description of Anesthesia Associates, P.L.L. Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### ***General:***

The Plan, which began January 1, 1984 is a defined contribution plan covering all eligible employees of Anesthesia Associates, P.L.L. (the “Partnership”) who meet the eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was most recently restated effective January 1, 2022 for regulatory changes.

Effective December 31, 2023, the Plan is terminated. All participants are 100% vested in their accounts and the financial statements are presented on the liquidation basis of accounting from 2023 onwards.

##### ***Eligibility:***

All employees of the Company who have worked one hour of service are eligible to participate in the Plan.

##### ***Contributions:***

Employee Contributions - Participants may elect a portion of their compensation to be contributed to the Plan, up to the maximum allowed under current regulations. In addition, the Plan offers 401(k) Roth Contributions as well as catch up contributions to those who meet the age requirements.

Employer Safe Harbor Contribution - The Company may make on an annual basis a safe harbor non elective contribution to each eligible participant's account. Only non-highly compensated employees will be eligible for the safe harbor contribution.

Employer Discretionary Contributions - The Company may also make additional contributions. Such additional contributions, if any, shall be allocated to each Participant based on an allocation for each participant.

Rollover contributions from other Plans are also accepted.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code as defined in the Plan agreement.

##### ***Participants' Accounts:***

Each participant's account is credited with the participant's elective contributions, employer contributions, earnings and losses thereon.

## NOTES TO FINANCIAL STATEMENTS

### Anesthesia Associates, P.L.L. Profit Sharing Plan and Trust

#### **1 Description of Plan, Continued**

##### ***Vesting:***

All participants are 100% vested in elective deferrals, safe harbor non-elective contributions and rollover contributions made to the Plan.

##### ***Other Plan Provisions:***

Normal retirement age is 65. In-Service distributions are permitted if the participant is working after normal retirement age.

##### ***Payment of Benefits:***

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant may elect any of the following payment options: Single sum payments, and installment payments. Preretirement Survivor Annuity or Qualified joint and Survivor Annuity are only permitted for participants with a balance from a prior Money Purchase Pension Plan. Benefits are recorded when paid.

##### ***Investment Options:***

Upon enrollment in the Plan, a participant may enroll in a self-directed retirement account.

#### **2 Summary of Significant Accounting Policies**

##### ***Basis of Accounting:***

The Plan's transactions are reported on the liquidation basis of accounting.

##### ***Valuation of Investments:***

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

##### ***Use of Estimates:***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

### 2 Summary of Significant Accounting Policies, Continued

#### *Administrative Fees:*

Substantially all administrative fees are paid by the Partnership.

#### *Risks and Uncertainties:*

The Plan's investment include investments with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for plan benefits.

#### *Subsequent Events:*

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

### 3 Tax Status

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

### 4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### 4 Fair Value Measurements, Continued

The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets
- \* Quoted prices for identical or similar assets or liabilities in inactive markets
- \* Inputs other than quoted prices that are observable for the asset or liability
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value.

#### ***Mutual Funds:***

The fair value of the mutual funds are based on quoted market prices.

#### ***Self-Directed Brokerage Account:***

Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.
