Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Goodwill Industries of Northeast Indiana, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Note 1. Plan Description

The Goodwill Industries of Northeast Indiana, Inc. 401(k) Plan (the "Plan") is a defined contribution plan covering eligible employees of Goodwill Industries of Northeast Indiana, Inc. (the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, ("ERISA"). The provisions of the Plan are included in the official Plan document which legally governs the operations of the Plan and is available for more detailed information.

Participant Contributions

To become eligible to participate in the Plan, an employee must have attained 21 years of age and completed one year of service, during which the employee provided 1,000 hours or more of service. The Secure 2.0 Act allows part time employees to enter the Plan January 1, 2024 if they have three consecutive years of at least 500 hours between 2021 and 2023. An employee is eligible to enter the Plan on the first day of each quarter immediately following completion of the age and service requirements. Participants may make voluntary pre-tax or Roth contributions of compensation up to the dollar limits set by the Internal Revenue Code. Participants are automatically enrolled at 2% of compensation unless the participant elects not to participate or modifies the withholding. Employee rollover contributions are also permitted.

Employer Contributions

The Employer may make discretionary matching and profit sharing contributions to the Plan. During 2024, the Employer made matching contributions equal to 50% of each participant's deferred compensation up to 10% of eligible compensation. The Employer did not make any profit sharing contributions in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's contribution, and an allocation of net earnings and is charged with an allocation of administrative expenses and any benefit payments. Allocations of the net earnings are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

The Plan assets are invested in various funds offered by Charles Schwab Trust Bank ("Schwab"). Contributions made during the Plan year are invested in the various funds offered through Schwab. All amounts in participant accounts are participant-directed and allocations can be changed daily.

Note 1. Plan Description (Continued)

Vesting

Participants are immediately vested in their elective (voluntary) contributions and income or loss thereon. Vesting in the Employer's matching and profit sharing contributions plus earnings thereon is based on years of service. A participant becomes partially vested after one year of service. Vesting percentages increase each year thereafter with 100% vesting after five years of service.

Benefit Payments

Normal retirement age under the Plan is 65 years, with the option to withdraw funds at the age of 59 ½. Minimum distributions are required once the participant reaches a certain age. On termination of service or retirement, a participant has the following options regarding his or her value of the vested interest: a) receive a lump-sum payment, b) rollover the balance into another qualified plan, or c) remain in the Plan as an inactive participant. However, if a terminated participant's vested account balance is \$5,000 or less and they have not elected a benefit payment, they will involuntarily receive a lump-sum distribution. If a participant is still a current employee and has not yet reached age 59 ½, the participant (or beneficiary) can only withdraw funds in the event of death or disability. Participants also have the option to receive hardship distributions, subject to certain restrictions, as outlined in the Plan document.

Forfeitures

Participants who terminate employment prior to becoming fully vested must forfeit a percentage of their Employer contribution amount. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$444 and \$0, respectively. These forfeitures may first be used to reduce Plan expenses and may also be used to reduce future Employer contributions. During 2024, there were no forfeitures used to reduce Plan expenses or Employer contributions.

Termination of the Plan

Although the Employer has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 2. Significant Accounting Policies

Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Trustees to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through October 9, 2025, the date the financial statements were available to be issued.

Note 3. Financial Statement Information Certified by Charles Schwab Trust Bank

The Plan Trustees have elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Charles Schwab Trust Bank, and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total cash and investments as shown in the accompanying statements of net assets available for benefits.
- b. Net investment income, as shown in the accompanying statement of changes in net assets available for benefits, including interest and dividend income and net appreciation in fair value of mutual funds.
- c. The supplemental schedule of assets (held at end of year).

Note 4. Fair Value Measurements

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash account: Valued at \$1 per share held at the end of the Plan year.

Mutual funds: Valued at quoted market prices, which represent the net asset values ("NAV") of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Income Tax Status

The Plan, which is a prototype plan, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, were in compliance with the applicable requirements of Section 401(a) of the Internal Revenue Code ("IRC") and therefore not subject to tax. The Plan Trustees believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Trustees have analyzed the tax positions taken by the Plan, and have concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Trustees believe the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 6. Transactions with Parties-in-Interest

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments at December 31, 2024 and 2023, are money market funds. Therefore, these transactions qualify as party-in-interest transactions. Certain administration expenses are paid by the Employer on behalf of the Plan. The Employer also provides certain administrative services at no cost to the Plan.

Note 7. Risks and Uncertainties

The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
