Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of L&B Realty Advisors, LLP Employees' Salary Reduction Thrift Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of L&B Realty Advisors, LLP Employees' Salary Reduction Thrift Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of L&B Realty Advisors, LLP Employees' Salary Reduction Thrift Savings Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following brief description of the L&B Realty Advisors, LLP Employees' Salary Reduction Thrift Savings Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description.

General

The Plan is a defined contribution plan covering certain full-time and part-time employees of L&B Realty Advisors, LLP and subsidiaries and L&B Realty Advisors, Inc. and subsidiaries (collectively, the "Sponsor") who have six months of service and are age twenty-one years or older and are not (1) covered by a collective bargaining agreement unless the agreement provides for participation in the Plan, (2) a non-resident alien with no earned income from the Sponsor, or (3) a leased employee. Additionally, employees of any entity other than L&B Realty Advisors, LLP and entities beneath it on the L&B Group Corporate Structure (with the exception of L&B Real Estate Counsel) are not eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan was established on July 1, 1992.

Plan Administration

The Plan is administered by the Sponsor. The Plan's recordkeeper is the Vanguard Group ("Recordkeeper"). The trustee of the Plan is Vanguard Fiduciary Trust Company ("Trustee"), who also holds all the Plan's assets.

Employee Contributions

Participants may contribute from 1% to 50% of pretax annual compensation, as defined, not to exceed \$23,000, except for participants over the age of 50 who may contribute \$30,500. Participants may also elect to make Roth contributions utilization after-tax contributions. Participants direct the investment of their contributions into various investment options offered by the Plan and are immediately fully vested in their contributions.

Employer Contributions

The Sponsor makes safe harbor matching contributions equal to 100% of the participants' elective deferrals up to 4% of participants' eligible compensation, regardless of the employee's hours of service or employment on the last day of the Plan year. Participants are immediately vested in these safe harbor matching contributions.

Additional non-elective contributions may be contributed at the discretion of the Sponsor's board of directors and are invested in a portfolio of investments as directed by participants. The Sponsor may also elect to match 33.33% of the participants' elective deferrals from 4% to 10% of the participants' eligible contributions. These discretionary matching contributions are unvested until participants obtain three years of service, at which time they become 100% vested.

Participant Accounts

A separate account is maintained for each participant in the Plan. Each participant's account is credited with the participant's contributions, Sponsor's matching contributions, and an allocation of Plan earnings. Allocations are based on participant contributions and Plan earnings.

1. DESCRIPTION OF PLAN (CONTINUED)

Distributions

Upon termination of service due to death, disability, or retirement, a participant or his/her beneficiary may receive the full amount available for distribution from his/her account. Upon termination from the Sponsor or for a hardship, the participant may receive only the vested interest in his/her account. Distributions are paid only in lump-sum amounts.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the highest outstanding loan balance at any time before the date of the loan or 50% of their vested account balance as of the date the loan is issued. Loan terms are up to five years; however, loans used for the purchase of a principal residence of the participant shall provide for periodic repayment of a reasonable period of time that may exceed five years. The loans are collateralized by the balance in the participant's account and bear interest at a fixed rate based on market rates at the time the loan is made and will be repaid through automatic payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 5.25% to 10.5% with various maturities through June 2029.

Administrative Expenses

The Sponsor pays the general and administrative expenses of the Plan. General and administrative expenses paid by the Sponsor are insignificant for the year ended December 31, 2024. Fees charged for loan processing are paid directly by the participant and are included in administrative expenses in the Statement of Changes in Net Assets Available for Benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

Revenue Recognition

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. The net appreciation (depreciation) in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Investment Valuation

The investments are reported at fair value. The Plan's trustee, Vanguard Fiduciary Trust Company, certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Certified Assets

The Plan administrator has obtained certifications from the trustee, Vanguard Fiduciary Trust Company, that the information provided by the trustee related to investments and notes receivable from participants is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan's independent auditors not to perform any audit procedures with respect to all the investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, investments reflected on the schedule of net assets (held at end of year) and related investment income and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Forfeitures

For the Plan year ended December 31, 2024, there were no forfeited non-vested amounts. Under the Plan, any forfeitures are first applied to payment of Plan administration expenses; any remaining forfeitures are then used towards the Sponsor's obligation to make future matching contributions. If participants return to work for the Sponsor before incurring five consecutive one year breaks in service, the participants may then recapture the forfeited benefit.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification 820 (“ASC 820”) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year-end.
- Stable value collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. FEDERAL INCOME TAX STATUS

The Sponsor adopted a non-standardized prototype plan and trust document which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The prototype plan has been amended since the receipt of the favorable opinion letter; however, management believes that the Plan currently is designed and is being operated in compliance with the prototype plan document and the applicable requirements of the IRC and that, therefore; the Plan continues to qualify under Section 401(a) and the related trust continues to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and/or Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however; there are currently no audits for any tax periods in progress.

4. PARTY-IN-INTEREST TRANSACTIONS

Other than the Franklin Small Cap Growth mutual fund, all investments are mutual funds and a common collective trust which are managed by an affiliate of the Trustee. Therefore, these transactions qualify as party-in-interest transactions. Additionally, participant loans qualify as party-in-interest transactions.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of a termination, participants will become 100% vested in the accounts.

6. SUBSEQUENT EVENTS

We have evaluated subsequent events through September 29, 2025, the date that these financial statements were available for issuance. Based on this evaluation, no events or transactions have occurred that would require adjustment to or disclosure in the financial statements, except that effective June 3, 2025, eligible participants are automatically enrolled in the plan at a 4% deferral rate.
