### **1. Description of the Plan**

The following description of the Elkus/Manfredi Architects Ltd. 401(k) Plan (the "Plan") provides only general information. More complete information regarding the Plan's provisions may be found in the Plan document.

#### ***General***

The Plan is a defined contribution plan established by Elkus/Manfredi Architects Ltd. (the "Employer") on January 1, 1994. All employees are eligible to participate in the Plan after attaining 21 years of age and completing three months of service, except leased employees and interns (the "Participants").

Ascensus, LLC (the "Custodian"), as an agent for Ascensus Trust Company, a qualified institution provided asset custodian and recordkeeping services for the Plan. The Plan is subject to the provisions of the Internal Revenue Code (the "IRC") and the Employee Retirement Income Security Act of 1974 ("ERISA"). All investments are participant-directed.

#### ***Plan Administration***

The Employer is the plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. An officer of the Employer serves as the Plan's trustee. The Employer pays certain administration fees on behalf of the Plan. Accordingly, such expenses are not reflected in the accompanying Financial Statements. Individual Participant accounts may be charged with an allocation of administrative expenses, if not paid by the Employer.

#### ***Participant Deferral Contributions***

Participants may defer up to a maximum of 100% of their eligible compensation for the Plan year, as defined, not to exceed a dollar limit established under the IRC. Participants may make pre-tax or Roth contributions to their accounts. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans ("Participant Rollovers").

Employees, upon reaching eligibility to participate in the Plan, are automatically enrolled to defer 6% of their eligible compensation on a pre-tax basis, as defined. A Participant may choose not to defer or may choose a different percentage once enrolled. Automatic enrollment deferrals are invested in the applicable target date retirement fund, as defined, based upon the employee's birth date. The automatic pre-tax deferral election and the default investment option remain in effect until the Participant changes them.

### **1. Description of the Plan (continued)**

#### ***Employer Contributions***

The Employer, at its discretion, may elect to contribute a matching contribution equal to a percentage of a Participant's salary deferrals. A Participant is entitled to discretionary matching contributions once they are enrolled in the Plan and is making deferral contributions. For the year ended December 31, 2024, the Employer elected to make discretionary matching contributions in an amount equal to 25% of the elective participant deferral contributions, up to 6% of their eligible compensation. The total discretionary matching contributions were \$366,147 for the year ended December 31, 2024.

The Employer, at its discretion, may make discretionary non-elective contributions to the Plan as determined by the Employer's Board of Directors. In order to receive an allocation of any discretionary non-elective Employer contributions to the Plan, Participants must be employed by the Employer on the last day of the Plan year and have completed a year of service, as defined. Non-elective Employer contributions made to the Plan are allocated to each Participant's account based on a percentage of eligible compensation, as defined. The Employer elected not to make a discretionary non-elective contribution to the Plan during the year ended December 31, 2024.

#### ***Participant Accounts***

Each Participant's account is credited with the Participant's deferral contributions, their respective Employer contributions, an allocation of the Plan's investment earnings and losses, an allocation of certain administrative expenses, if applicable, and loan fees and/or withdrawal fees, if applicable. Allocations are based on Participant compensation or account balance, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account balance.

#### ***Vesting***

Participants are immediately vested in their voluntary deferral and rollover contributions plus allocated earnings thereon.

Participants' vested interest in Employer contributions, other than qualified non-elective Employer contributions, is based on years of continuous service. Participants begin vesting after one year of service, in 25% increments and are 100% vested after four years of service for the discretionary matching contributions. Participants begin vesting after one year of service years in 20% increments and are 100% vested after five years of service for discretionary non-elective Employer contributions. If employment is terminated due to death, disability, or the Participant reaches normal retirement age, as defined, the participant becomes 100% vested.

### **1. Description of the Plan (continued)**

#### ***Notes Receivable from Participants***

Participants may borrow from their vested accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made, or 50% of their vested account balance. Loan terms range from one to five years (or longer for the purchase of a primary residence). Loans are secured by the vested balance in the Participant's account and bear interest at a fixed rate defined as one percentage point over the prime interest rate. A Participant may only have one loan outstanding at a time. Principal and interest are paid ratably through payroll deductions or by check if the employee is prepaying the loan. If a Participant ceases to make loan repayments and the plan administrator deems the Participant loan to be in default, the Participant loan balance is reduced, and a benefit payment is recorded as soon as a distributable event occurs. The interest rates for outstanding loans ranged from 4.25% to 9.50% at both December 31, 2024 and 2023 and mature at various dates through May 2033.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, voluntary termination, or retirement, a Participant or beneficiary may elect to receive a lump-sum payment equal to the value of the Participant's vested interest in his or her account. The payment can either be a cash distribution subject to income tax withholdings or a tax-free rollover to an Individual Retirement Account ("IRA") or another qualified plan. If the vested account balance is \$5,000 or less and greater than \$1,000 the plan administrator, after notification, may distribute the benefit to the Participant or beneficiary in a lump-sum payment. If the vested balance is \$1,000 or less the plan administrator, after notification, may distribute the benefit to an individual retirement account.

In-service withdrawals from a Participant's account balance are permitted upon reaching age 59½. In-service withdrawals are also permitted due to financial hardship, as defined.

#### ***Forfeiture Account***

A Participant who is no longer employed by the Employer forfeits any non-vested balance after the earliest of five consecutive one year breaks in service or upon distribution of the entire vested portion of the Participant's account. Non-vested forfeited account balances are retained in the Plan and are used to pay administrative expenses or reduce Employer contributions. Unallocated forfeitures amounted to \$17,791 and \$15,640 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, the Plan utilized forfeitures to pay for administrative expenses in the amount of \$23,414.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The accompanying Financial Statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

#### ***Use of Estimates***

The preparation of Financial Statements in conformity with GAAP requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

#### ***Investments, Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

#### ***Fair Value Measurements***

The Plan follows U.S GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Mutual funds: As of December 31, 2024 and 2023, mutual funds amounted to \$52,836,865 and \$48,914,200, respectively, and are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 investments.

#### ***Notes Receivable from Participants***

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from Participants is recorded on the accrual basis of accounting. Related fees are recorded as administrative expenses and are expensed when incurred.

#### ***Payments of Benefits***

Benefit payments to Participants are recorded during the period in which the Participants are paid.

### **3. Investments Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, Schedule H, Part IV, Line 4i, Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and dividend and interest income, interest income on notes receivable from participants, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian.

### **4. Risks and Uncertainties**

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **5. Party-In-Interest Transactions**

Notes receivable from Participants qualify as exempt party-in-interest transactions as defined by ERISA. During the year ended December 31, 2024, the Plan paid administrative expenses of \$74,164 to UBS Financial Services, the Plan's investment advisor, and \$53,396 to the Custodian or affiliates of the Custodian. These transactions qualify as exempt party-in-interest transactions as defined by ERISA.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, Participants will become fully vested in their accounts. Any unallocated assets of the Plan will be allocated to Participant accounts and distributed in such a manner as the Employer may determine.

### **7. Tax Status**

The underlying volume submitter profit sharing plan received an opinion letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, stating that the form of the plan is qualified under Section 401(a) of the IRC, as then designed, and was in compliance with applicable requirements of the IRC. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. It is the Plan's policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of the Plan is considered a tax position. No such uncertain tax positions have been recognized by the Plan as of December 31, 2024 or 2023.

### **8. Subsequent Events**

The Plan administrator has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued, and determined that there have been no subsequent events that would require recognition in, or disclosure in the notes to, the financial statements.
