#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed audits of the accompanying financial statements of Katahdin Valley Health Center Safe Harbor 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### **Opinion on the 2024 Financial Statements**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

## **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

(1) DESCRIPTION OF PLAN

The following description of the Katahdin Valley Health Center Safe Harbor 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for more complete information.

- a. **GENERAL** - The Plan is a defined contribution plan covering current and former employees of Katahdin Valley Health Center (KVHC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b. **ELIGIBILITY** - Employees who have attained one year of service (1,000 hours or more) and are age 18 or older are eligible to participate in the Plan.
- c. **EMPLOYEE ELECTIVE DEFERRAL CONTRIBUTIONS** - Each year, the participants may elect to contribute a percentage of their compensation up to the maximum amount allowable by law (\$23,000 for 2024 and \$22,500 for 2023). A participant who has attained or will attain age 50 by the end of the Plan year may contribute more (\$7,500 for 2024 and \$7,500 for 2023). The Plan also allows employees to make Roth contributions.
- d. **EMPLOYER CONTRIBUTIONS** – KVHC contributes a safe harbor matching contribution for each eligible employee of 100% of salary deferrals up to the first 3% of Plan compensation plus 50% of salary deferrals up to the next 2% of Plan compensation.

Total contributions for each participant cannot exceed \$69,000 and \$66,000 for 2024 and 2023, respectively. Contributions to the Plan are made in a timely manner in accordance with ERISA regulations.

- e. **ROLLOVERS** - The assets of another qualified retirement plan may be transferred directly to the Plan.
- f. **PARTICIPANT ACCOUNTS** - Each participant’s individual account is credited with the participant’s contribution, rollover contributions, and employer safe harbor contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers individual fixed annuity contracts, mutual funds, and Target Date Retirement Funds as options for participants. If an employee fails to make an investment election, contributions will be credited to the Target Date Retirement Fund closest to the year the employee will turn age 65. KVHC’s contributions are allocated based on the participants’ elected investments. Allocation of the Plan’s investment gains or losses is based on the participant’s particular investment mix. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- g. **VESTING** – Participants are immediately 100% vested in all contributions.

NOTES TO FINANCIAL STATEMENTS

(1) DESCRIPTION OF PLAN (cont'd.)

- h. **PAYMENT OF BENEFITS** - Payment of benefits is available upon the participant's retirement, termination of employment, normal retirement at age 65, death or permanent and total disability. If the participant's account does not exceed \$5,000, it will be distributed in a single lump-sum amount. Accounts in excess of \$5,000 can be distributed as a single lump-sum payment or as an individual IRA if available under the applicable funding vehicle. Required minimum distributions (RMD) begin at age 72. If the participant reaches age 72 after December 31, 2022, the RMD begins at age 73.
- i. **IN-SERVICE DISTRIBUTIONS** - A participant who reaches age 59½ may elect to receive all or some of their vested account balance even if they continue working. Rollover contributions may be withdrawn at any time.
- j. **HARDSHIP WITHDRAWALS** - A participant may withdraw from his or her elective contributions account to satisfy an immediate and heavy financial need as defined by the Plan and subject to Internal Revenue Service (IRS) and 401(k) regulations (hardship distribution). In 2024, hardship distributions totaled \$1,499.
- k. **ADMINISTRATIVE EXPENSE** – Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements. Fees related to origination are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.
- l. **FORFEITED ACCOUNTS** – On December 31, 2024 forfeited non-vested accounts totaled \$0. There were no forfeiture amounts utilized during the plan year.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

*Use of Estimates*

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (cont'd.)

*Investment Valuation and Income Recognition*

Investments are reported at fair value except for the individual annuity contracts. Mutual funds are valued at the net asset value of shares held by the Plan at yearend. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. The individual annuity contracts are valued at the adjusted contract value. The contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

*Payment of Benefits*

Benefits are recorded when paid.

*Expenses*

The Plan sponsor pays most of the expenses in maintaining the Plan and they are excluded from these financial statements. Fees related to benefit payments and certain administration expenses are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

*Subsequent Events*

Subsequent events were evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

(3) TAX STATUS

The Plan has adopted a Non-Standardized Pre-Approved Profit-Sharing Plan, which received a favorable advisory letter dated June 30, 2020, stating that the Plan, as then designed, was following the applicable requirements of the Internal Revenue Code (the Code). Although the plan has since been amended, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken by the Plan that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS and the DOL; however, there are currently no audits in progress.

(4) PLAN AMENDMENTS

The Plan was formed in 2010 and restated in its entirety on December 15, 2023. The Plan has implemented certain provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act). These plan changes are permitted as operational relief items for impacted plan participants, as defined by the act, until formal amendment. Plan management is reviewing SECURE Act 2.0, which will require formal amendment to the Plan in the year 2026.

(5) INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS

The following is a summary of certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee and custodian, Mid Atlantic Trust Company and Modern Woodmen of America, respectively.

(6) FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value, except for the individual annuity contracts which are valued at contract value. Fair value is the price that would be received to sell an asset or paid to settle a liability in an orderly transaction between market participants at the measurement date. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Plan administrator determines the Plan's valuation utilizing information provided by the trustee. The Plan believes its valuation methods are appropriate and consistent; however, the use of different valuation methodologies or assumptions could result in a different fair value determination.

A fair value hierarchy is used to prioritize the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of quoted prices for identical or similar assets or liabilities in inactive markets. Level 3 inputs are unobservable and significant to the fair value measurement. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 and Level 2 inputs are not available.

(7) INVESTMENT CONTRACT WITH MODERN WOODMEN OF AMERICA

The individual annuity contracts are fully benefit-responsive investment contracts Modern Woodmen maintains the contributions in a general account which is subject to the claims of creditors and other account policy holders. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment is included in the financial statements at contract value because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the Plan's ability to transact at contract value with Modern Woodmen. Such events include termination of the contract, amendments to the Plan or bankruptcy of the Plan sponsor that may cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any prohibited transaction under ERISA. The Plan administrator does not believe that any such events have occurred.

(8) PLAN TERMINATION

Although it has not expressed any intent to do so, KVHC has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of a termination, participants would become 100% vested in their employer contributions.

(9) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate risk and market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant's account balances and the amount reported in the Statements of Net Assets Available for Benefits.

(10) RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain administrative functions are performed by officers and employees of KVHC. No officer or employee receives compensation from the Plan for these services.

Certain Plan investments are annuity contracts managed by Modern Woodmen, a custodian of the Plan.

### INDEPENDENT AUDITOR'S REPORT

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed audits of the accompanying financial statements of Katahdin Valley Health Center Safe Harbor 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### **Opinion on the 2024 Financial Statements**

## **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matters**

#### *2024 Supplemental Schedule Required by ERISA*

The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) for December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. *Auditor's Report on the 2023 Financial Statements*

The financial statements of the Katahdin Valley Health Center Safe Harbor 401(k) Plan as of December 31, 2023, were audited by predecessor auditors. In accordance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated September 16, 2024 indicated that in their opinion (a) the amounts and disclosure in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(c). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agree to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(c).

NOTES TO FINANCIAL STATEMENTS

(1) DESCRIPTION OF PLAN

The following description of the Katahdin Valley Health Center Safe Harbor 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for more complete information.

- a. **GENERAL** - The Plan is a defined contribution plan covering current and former employees of Katahdin Valley Health Center (KVHC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b. **ELIGIBILITY** - Employees who have attained one year of service (1,000 hours or more) and are age 18 or older are eligible to participate in the Plan.
- c. **EMPLOYEE ELECTIVE DEFERRAL CONTRIBUTIONS** - Each year, the participants may elect to contribute a percentage of their compensation up to the maximum amount allowable by law (\$23,000 for 2024 and \$22,500 for 2023). A participant who has attained or will attain age 50 by the end of the Plan year may contribute more (\$7,500 for 2024 and \$7,500 for 2023). The Plan also allows employees to make Roth contributions.
- d. **EMPLOYER CONTRIBUTIONS** – KVHC contributes a safe harbor matching contribution for each eligible employee of 100% of salary deferrals up to the first 3% of Plan compensation plus 50% of salary deferrals up to the next 2% of Plan compensation.

Total contributions for each participant cannot exceed \$69,000 and \$66,000 for 2024 and 2023, respectively. Contributions to the Plan are made in a timely manner in accordance with ERISA regulations.

- e. **ROLLOVERS** - The assets of another qualified retirement plan may be transferred directly to the Plan.
- f. **PARTICIPANT ACCOUNTS** - Each participant’s individual account is credited with the participant’s contribution, rollover contributions, and employer safe harbor contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers individual fixed annuity contracts, mutual funds, and Target Date Retirement Funds as options for participants. If an employee fails to make an investment election, contributions will be credited to the Target Date Retirement Fund closest to the year the employee will turn age 65. KVHC’s contributions are allocated based on the participants’ elected investments. Allocation of the Plan’s investment gains or losses is based on the participant’s particular investment mix. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- g. **VESTING** – Participants are immediately 100% vested in all contributions.

NOTES TO FINANCIAL STATEMENTS

(1) DESCRIPTION OF PLAN (cont'd.)

- h. **PAYMENT OF BENEFITS** - Payment of benefits is available upon the participant's retirement, termination of employment, normal retirement at age 65, death or permanent and total disability. If the participant's account does not exceed \$5,000, it will be distributed in a single lump-sum amount. Accounts in excess of \$5,000 can be distributed as a single lump-sum payment or as an individual IRA if available under the applicable funding vehicle. Required minimum distributions (RMD) begin at age 72. If the participant reaches age 72 after December 31, 2022, the RMD begins at age 73.
- i. **IN-SERVICE DISTRIBUTIONS** - A participant who reaches age 59½ may elect to receive all or some of their vested account balance even if they continue working. Rollover contributions may be withdrawn at any time.
- j. **HARDSHIP WITHDRAWALS** - A participant may withdraw from his or her elective contributions account to satisfy an immediate and heavy financial need as defined by the Plan and subject to Internal Revenue Service (IRS) and 401(k) regulations (hardship distribution). In 2024, hardship distributions totaled \$1,499.
- k. **ADMINISTRATIVE EXPENSE** – Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements. Fees related to origination are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.
- l. **FORFEITED ACCOUNTS** – On December 31, 2024 forfeited non-vested accounts totaled \$0. There were no forfeiture amounts utilized during the plan year.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

*Use of Estimates*

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTES TO FINANCIAL STATEMENTS

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (cont'd.)

*Investment Valuation and Income Recognition*

Investments are reported at fair value except for the individual annuity contracts. Mutual funds are valued at the net asset value of shares held by the Plan at yearend. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. The individual annuity contracts are valued at the adjusted contract value. The contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

*Payment of Benefits*

Benefits are recorded when paid.

*Expenses*

The Plan sponsor pays most of the expenses in maintaining the Plan and they are excluded from these financial statements. Fees related to benefit payments and certain administration expenses are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

*Subsequent Events*

Subsequent events were evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

(3) TAX STATUS

The Plan has adopted a Non-Standardized Pre-Approved Profit-Sharing Plan, which received a favorable advisory letter dated June 30, 2020, stating that the Plan, as then designed, was following the applicable requirements of the Internal Revenue Code (the Code). Although the plan has since been amended, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken by the Plan that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS and the DOL; however, there are currently no audits in progress.

(4) PLAN AMENDMENTS

The Plan was formed in 2010 and restated in its entirety on December 15, 2023. The Plan has implemented certain provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act). These plan changes are permitted as operational relief items for impacted plan participants, as defined by the act, until formal amendment. Plan management is reviewing SECURE Act 2.0, which will require formal amendment to the Plan in the year 2026.

(5) INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS

The following is a summary of certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee and custodian, Mid Atlantic Trust Company and Modern Woodmen of America, respectively.

(6) FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value, except for the individual annuity contracts which are valued at contract value. Fair value is the price that would be received to sell an asset or paid to settle a liability in an orderly transaction between market participants at the measurement date. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Plan administrator determines the Plan's valuation utilizing information provided by the trustee. The Plan believes its valuation methods are appropriate and consistent; however, the use of different valuation methodologies or assumptions could result in a different fair value determination.

A fair value hierarchy is used to prioritize the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of quoted prices for identical or similar assets or liabilities in inactive markets. Level 3 inputs are unobservable and significant to the fair value measurement. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 and Level 2 inputs are not available.

(7) INVESTMENT CONTRACT WITH MODERN WOODMEN OF AMERICA

The individual annuity contracts are fully benefit-responsive investment contracts Modern Woodmen maintains the contributions in a general account which is subject to the claims of creditors and other account policy holders. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment is included in the financial statements at contract value because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the Plan's ability to transact at contract value with Modern Woodmen. Such events include termination of the contract, amendments to the Plan or bankruptcy of the Plan sponsor that may cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any prohibited transaction under ERISA. The Plan administrator does not believe that any such events have occurred.

(8) PLAN TERMINATION

Although it has not expressed any intent to do so, KVHC has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of a termination, participants would become 100% vested in their employer contributions.

(9) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate risk and market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant's account balances and the amount reported in the Statements of Net Assets Available for Benefits.

(10) RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain administrative functions are performed by officers and employees of KVHC. No officer or employee receives compensation from the Plan for these services.

Certain Plan investments are annuity contracts managed by Modern Woodmen, a custodian of the Plan.
