## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Gulf Equipment Corporation 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Gulf Equipment Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 of the financial statements, is complete and accurate.

## **1. DESCRIPTION OF PLAN**

The following description of the Gulf Equipment Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan was established on January 1, 2000, and is a defined contribution plan for the employees of Gulf Equipment Corporation and its affiliates (the Company). To become eligible to participate in the Plan, the employee must be full-time, age 21 or older and have completed one year of service. The Plan was amended, effective January 1, 2018, for automatic enrollment at a 5% "default" contribution rate unless the participant elects not to participate in the Plan or unless a different contribution rate is chosen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Contributions**

Each year, participants are allowed to contribute up to the maximum allowed by law of pretax annual compensation, as defined by the Plan. Participants may also rollover amounts from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company annually contributes a safe harbor match to eligible participants equal to 100% of a participant's elective deferrals, which do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals, which exceeds 3% of the participant's compensation but does not exceed 5% of the participant's compensation. The Company, at the sole discretion of its Board, may also make a profit-sharing contribution to the Plan. No profit-sharing contributions were made in 2024 or 2023. Contributions are subject to certain limitations.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (1) the Company's contribution and (2) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant deferral contributions, compensation or account balances, as applicable and pursuant to the terms of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their voluntary contributions and the Company's safe harbor contribution, plus any earnings thereon. Vesting in the Company's discretionary, non-safe harbor matching contribution and profit-sharing contribution, plus any earnings thereon, is based upon the number of years of continuous service. A participant vests 20%, 40%, 60%, 80% and 100% after two, three, four, five and six years of credited service, respectively.

### **Payment of Benefits**

Upon termination of service due to death, disability or retirement, a participant (or the participant's beneficiary) may elect to receive an amount equal to the value of the participant's vested interest in either a lump-sum distribution or annual equal installments over a five-year period.

For termination of service for any other reason, a participant is entitled to receive the value of the vested interest in a lump-sum distribution.

**Participant Loans**

Participant loans are not allowed.

**Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$25,792 and \$10,265, respectively. Non-vested forfeited accounts may be used to offset future employer contributions or administrative expenses.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value, except for the Mass Mutual SF Guaranteed, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Because of the inherent uncertainties in estimating market value, it is reasonably possible that the estimates used will change within the near term. Contract value represents contributions plus credited interest, less participant withdrawals and fees. In the statement of changes in net assets available for benefits, the Plan presents the net appreciation in the fair value of its investments, which consists of the realized gains or losses on investments sold during the year and the unrealized appreciation on investments held at year-end.

The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, Reliance Trust Company and Empower Retirement, LLC, the trustees of the Plan and Empower Retirement, LLC, the custodian of the group annuity contract (collectively referred to as the Certifying Entities).

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

Management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**3. INFORMATION CERTIFIED BY CERTIFYING ENTITIES**

All investment information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplementary schedule, was prepared by or derived from information provided by the Certifying Entities of the Plan and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Certifying Entities that the following information is complete and accurate.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1    Observable inputs such as quoted prices in active markets;
- Level 2    Inputs, other than quoted prices in active markets, which are observable either directly or indirectly; and
- Level 3    Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**5. GROUP ANNUITY CONTRACT WITH MASS MUTUAL**

The Plan maintains an investment in the Mass Mutual SF Guaranteed, which is a separate account insured by a general account guarantee to preserve principal and pay a stated rate of return. The general account guarantee protects the separate account from daily fluctuations in the bond market.

As described in Note 2, because the SF Guaranteed is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the SF Guaranteed. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value. Such events include the following: amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The SF Guaranteed does not permit Mass Mutual to terminate the agreement prior to the scheduled maturity date.

## **6. TAX STATUS**

The Plan has adopted a prototype "standardized" plan, and the prototype sponsor has received an opinion letter dated June 30, 2020, from the Internal Revenue Service indicating that the Plan is a qualified plan meeting the requirements of applicable sections of the IRC. Accordingly, Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

The Plan's custodian, Empower Retirement, LLC, receives compensation from the funds in connection with the Plan's investments in these funds. Transactions in such investments qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing rather than a direct payment.

**8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company contributions.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


