**(1) DESCRIPTION OF PLAN**

The following description of the ENT and Allergy of Delaware, LLC 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

In July, 2025, the Plan merged into the LifeSight Pooled Employer Plan ("PEP"). The PEP is sponsored by a WTW, a Pooled Plan Provider.

***General***

The Plan was established on January 1, 2011 and is a defined contribution plan covering all employees of the Company who have attained age 21 and completed 1 year service (1,000 hours) and are not members of a collective bargaining unit, nonresident aliens, or employees as a result of an asset or stock acquisition, merger, or similar transaction. Employees who have met the eligibility requirements can enter the Plan on January 1 or July 1, coincident with or next following satisfaction of the eligibility requirements. The Plan is structured to comply with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

***Contributions***

Each year, participants are eligible to make elective deferrals up to 100% of pretax annual compensation, as defined in the Plan, up to the maximum permitted by law. Elective deferrals include pretax 401(k) contributions and after-tax Roth contributions. Participants who have attained age 50 before the end of a plan year are eligible to make catch-up contributions during the plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes a safe harbor nonelective contribution of 3% of compensation to all eligible employees. The Company may also make profit sharing contributions using a discretionary formula as determined by the Company from year to year. Qualifying participants must be employed on the last day of the plan year to be eligible to receive profit sharing contributions. During the year ended December 31, 2024, the Company made profit-sharing and safe-harbor contributions of \$578,053 and \$390,660, respectively, to the Plan. A majority of the 2023 employer contribution receivable was not deposited in the Plan until January, 2025. All contributions are subject to limitations to comply with the nondiscrimination and other requirements of the Internal Revenue Code (IRC).

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in the Company's safe harbor nonelective contributions. Participants become 20% vested in the Company's profit-sharing contribution after two years of service and in increments of 20% for every year thereafter. Participants are fully vested after six years of service. An employee who dies or becomes disabled becomes fully vested in their account.

***Benefit Payments***

On separation of service due to retirement, disability, or termination, a participant may receive a lump-sum amount equal to the vested value of his or her account, or may elect to receive payment on an installment basis if the account balance is at least \$5,000.

For terminated participants with an balance less than \$5,000, the participant will receive the value of the vested interest in his or her account as a lump sum distribution.

Participants may withdraw all or any part of their account resulting from rollover contributions. Participants age 59½ or older may withdraw all or any part of their vested account. Upon the death of the participant, the participant's beneficiary is entitled to the balance of the participant's account.

***Hardship Withdrawals***

A participant may elect to receive a hardship distribution not to exceed the value of his or her contributions and, if applicable, the amounts contributed representing distributions from other qualified defined benefit or contribution plans, plus actual earnings thereon.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,702 and \$23,952, respectively. Forfeitures may be used to allocate amongst the plan participants or pay plan expenses. During the year ended December 31, 2024, \$17,221 of forfeitures were used to pay plan expenses.

**(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

***Payment of Benefits***

Benefits are recorded when paid.

***Investment Valuation and Income***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

**(4) FAIR VALUE MEASUREMENTS**

Accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives priority to unadjusted quoted prices in an active market for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access

Level 2      Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value as of December 31, 2024 and 2023:

**(5) PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would become 100% vested in their employer contributions. As described in Note 1, the Plan merged into a pooled employer plan in 2025.

**(6) PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of mutual funds managed by Vanguard, recordkeeper and third-party administrator of the Plan; therefore, any transactions with Vanguard constitute party-in-interest transactions.

**(7) TAX STATUS**

The Plan uses a volume submitter plan document sponsored by Limestone Pension Associates, LLC. The Internal Revenue Service has determined and informed Limestone Pension Associates, LLC, in a letter dated March 31, 2014, that the volume submitter plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

**(8) RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(9) DELINQUENT PARTICIPANT CONTRIBUTIONS**

Certain participant contributions were not remitted to the Plan within the time frame specified by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company during the 2023 and 2022 Plan years. Late remittances amounted to \$26,580 and \$26,207 for the years ended December 31, 2023 and 2022, respectively. \$8,327 of the 2023 late remittances have been corrected.

For the contributions not timely remitted, the Company will calculate and remit to the Plan an amount representing the earnings that the contributions would have earned if they had been deposited timely.
