Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of DermCare Management, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the DermCare Management, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering employees of DermCare Management, LLC (the "Company") who have attained the age of 21 and completed 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

B. Contributions

Participants may elect to defer up to 100% of eligible annual compensation, as defined in the Plan, subject to Internal Revenue Code (the "Code") limitations. Participants may also contribute amounts distributed from other qualified plans. The Company may make a discretionary matching contribution to the Plan. For 2024, the Company made a safe harbor matching contribution equal to 100% of each eligible participant's salary deferrals that do not exceed 1% of compensation plus 50% of salary deferrals between 1% and 6% of compensation. Eligible employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled in the Plan at a deferral rate of 3% as soon as the eligibility requirements are satisfied. The deferral rate of auto-enrolled participants who do not make an alternative election increases 1% annually to a maximum deferral percentage of 10%.

C. Participant Accounts

Separate accounts are maintained for each participant. Participants direct their investments into the investment options offered by the Plan. Each participant's account is credited with the participant's contributions, rollover contributions, the Company's contributions, and an allocation of plan earnings. Allocations of plan earnings are based on participant account balances.

D. Vesting

Participants are vested immediately in their contributions, rollovers, and actual earnings thereon. Vesting in the Company contribution portion of the participant's account is based on years of credited service. A participant is 100% vested after two years of credited service.

E. Notes Receivable from Participants

Active participants may obtain loans from their account for a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment period for such loans cannot exceed five years unless the proceeds are used to purchase the participant's principal residence. Loans are secured by the participants' account balances and bear interest at prevailing market rates. Notes receivable from participants at December 31, 2024 carry an interest rate of 5.75%.

F. Forfeitures

Any portion of a participant's account that is not vested shall be forfeited upon distribution of the vested portion. Forfeitures may be used to reduce administrative expenses of the Plan or to reduce Company contributions. During 2024, there were \$136,873 of forfeitures; \$140,731 of forfeitures were used to reduce administrative expenses or Company contributions.

G. Payment of Benefits

A participant's benefits will be distributed at retirement, death, disability or termination of employment. The participant or beneficiary may elect to receive such benefits in installments or a lump-sum payment equal to the value of the vested interest in his or her account. In-service distributions are allowed after age 59 ½ or in cases of financial hardship. Benefits are recorded when paid.

H. Administrative Expenses

Most administrative expenses are paid by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

C. Fair Value Measurements

Accounting guidance establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are based on quoted prices for similar instruments and model based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

The Level 2 investment consists of a money market fund valued using matrices of trades in similar securities. The pooled separate accounts are reported at net asset value. Shares may be redeemed anytime; there are no restrictions on redemption and no unfunded commitments to purchase additional shares.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

Investments are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the risk associated with investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Plan was designed under a volume submitter program, which has received a favorable opinion letter issued by the Internal Revenue Service stating that it is acceptable under Section 401(a) of the Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting guidance requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - FIXED INCOME GUARANTEED OPTION

The Plan maintains a fully benefit-responsive group annuity contract with Voya Retirement Insurance and Annuity Company (“Voya”) through the Voya Fixed Account (“Unallocated Insurance Contract”). Contributions to the Unallocated Insurance Contract are maintained in an insurance Company general account and credited for interest and charged for participant withdrawals and administrative expenses. Voya is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The Unallocated Insurance Contract meets fully benefit-responsive investment contract criteria and is reported at contract value.

The crediting rate is based on a formula established by Voya but may not be less than 1.0% percent. The crediting rate is reviewed monthly for resetting. The crediting rate was 1.50% for 2024 and 2023.

The Plan’s ability to receive amounts due is dependent on Voya’s ability to meet its financial obligations. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the Unallocated Insurance Contract. The plan administrator does not believe that any events limiting the Plan’s ability to transact at contract value are probable of occurring.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of the participants affected by a partial or complete termination of the Plan are nonforfeitable and will be determined as of the termination date, which will be treated as the valuation date.

NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedules, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the custodian of the Plan.

NOTE 7 - RELATED PARTY TRANSACTIONS

Certain plan investments are issued and managed by the custodian or its affiliates. Transactions related to these investments qualify as party in interest transactions; however, they are exempt from the prohibitions under ERISA.

NOTE 8 - PLAN AMENDMENTS

On December 1, 2023, the Plan was amended to discontinue the loan program.

Effective January 1, 2024, the Plan was amended to update the computation period of the Qualified ADP Safe Harbor Matching from each plan year to each payroll period and to update entry requirement for the Qualified ADP Safe Harbor Matching Contribution Component.

NOTE 9 - NONEXEMPT TRANSACTIONS

As disclosed in the accompanying supplemental schedule of delinquent participant contributions, the Plan failed to remit certain contributions withheld from employees within the maximum time period permitted under Department of Labor regulations. Failure to timely remit amounts withheld from participants' pay is a prohibited transaction under Department of Labor regulations. In 2025, the Plan fully restored earnings to the accounts of affected participants from the loss date to the recovery date.

NOTE 10 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 3, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that require recognition or additional disclosures in these financial statements.
