Independent Auditor's Report

To: The Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed an audit of the accompanying financial statements of Stellar Health Management 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Basis for Opinion

I conducted my audit in accordance with auditing standards generally accepted in the United States of America. NOTE 1 DESCRIPTION OF PLAN

The following description of the Stellar Health Management 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective July 1, 1992. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective December 17, 2024. The Plan covers all employees of Stellar Health Management, LLC and related employers (the Company). The Plan excludes employees covered by a collective bargaining agreement, employees who are non-resident aliens and individuals who become employees as a result of a Code Section 410(b)(6)(C) transaction before expiration of the transition period. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On February 27, 2024, the retirement plan balances for Greenbrier Operations, LLC and Birchwood Terrace Rehab & Healthcare were transferred into the plan in the amount of \$1,529,008 as detailed on the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.

Eligibility

Employees are eligible to participate in the salary reduction arrangement in the Plan and Company contributions after attaining age 18. Employees are allowed to enroll into the Plan immediately upon starting employment with the Company.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code. Eligible participants are permitted to elect and have a dollar amount or percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Participants age 50 or older are allowed to make catch-up contributions.

The Company may, at its discretion, elect to make a qualified matching contribution or profit sharing contribution to the Plan. There were no Company matching or profit sharing contributions for the year ended December 31, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans or conduit IRA's. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company matching and profit sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after five years of credited service. A participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The Plan allows participants to borrow funds from the Plan based on certain conditions. Notes are repaid through payroll deductions. Note terms are up to five years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may exceed five years. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator.

Benefit Payments

Upon termination of service, death, disability, or retirement (age 65), the participant will receive the value of the vested interest in his or her account in the form of a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. After a hardship withdrawal, a participant cannot make contributions to the Plan for 6 months. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent.

Forfeited Accounts

Forfeited non-vested accounts are used to reduce future employer contributions and pay administrative expenses of the plan. There were \$213 and \$21 of forfeitures used to pay administrative expenses for each of the years ended December 31, 2024 and 2023, respectively. There were no forfeited non-vested account balances as of December 31, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments in the mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Investments in the common collective trust fund are valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

Benefit Payments

Benefit payments are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued. There were no additional material subsequent events that required recognition or additional disclosures in these financial statements.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Principal Life Insurance Company, as agent for Principal Global Investors Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of notes receivable from participants and investment information reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Statements of Changes in Net Assets Available for Benefits for the years then ended, and the Supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to fair value measurement.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100% vested in their accounts.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated March 31, 2014, received from the Internal Revenue Service on the prototype plan indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTIES-IN-INTEREST TRANSACTIONS

Principal Life Insurance Company and Intact Actuarial Services, Inc., performs contract administration services for the Plan. Fees paid directly to Principal Life Insurance Company and Intact Actuarial Services, Inc. amounted to \$61,334 and \$7,184 respectively for 2024. Park Avenue Securities and Wilshire Advisors, LLC provides investment advisory services for the Plan. No fees were paid directly to Park Avenue Securities and Wilshire Advisors, LLC respectively for 2024.

Ascensus, Inc., and UBS Financial Services, Inc., performs recordkeeping and consulting services for the Plan. Fees paid directly to Ascensus, Inc. amounted to \$56,838 for 2023. No fees were paid directly to UBS Financial Services, Inc. for 2023. Retirement Resources Investment Group provides investment services for the Plan. Fees paid directly to Retirement Resources Investment Group amounted to \$23,955 for 2023.

NOTE 9 DELINQUENT PARTICIPANT CONTRIBUTIONS

During 2024, the Company failed to remit \$40,316 of participant contributions and loan repayments within a timely manner after the deferrals were withheld from participant gross compensation as required by the Department of Labor. Failure to remit or untimely remittance of participant contributions constitutes a prohibited transaction under the Department of Labor regulations. The Company corrected the delinquent participant contributions and loan repayments subsequent to the December 31, 2024 year end including making the affected participants whole.
