## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator

### Opinion

We have audited the accompanying financial statements of CMA/Flodyne/Hydradyne, Inc. ## 1. NATURE OF PLAN

CMA/Flodyne/Hydradyne, Inc. ("the company") established the CMA/Flodyne/Hydradyne, Inc. Employee Stock Ownership Plan ("the ESOP" or "the plan") effective January 1, 2022. The plan owns 100% of the outstanding shares of the company's common stock. The plan purchased the company's common stock from the company in 2022 using proceeds received from a loan from the company (see Note 7).

The financial statements of the plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated assets and liabilities ("allocated") and (b) assets and liabilities not yet allocated to employees ("unallocated"). The unallocated shares are held as collateral for the note payable due to the company.

The company is obligated to make contributions to the plan at least equal to the amount necessary to enable the plan to make its scheduled annual debt obligation payments to the company. As the plan makes debt obligation payments, a pro rata portion of the shares of the company's common stock purchased with the proceeds of the loan is allocated to participant accounts based on the ratio of participant eligible compensation paid for the year to total plan eligible compensation paid for the year.

The company is also obligated to make periodic contributions or loans to the plan sufficient for the plan to fund its annual benefit payments due to participants ("repurchase obligations"). At the discretion of the company's board of directors, the repurchase obligations can be funded via a) the company repurchasing these shares directly from the participants ("stock redemption"); b) the company funding the ESOP to allow the ESOP to repurchase these shares by making contributions to the ESOP ("re-cycling"); or c) the company repurchasing these shares directly from the participants and reissuing the repurchased shares back to the ESOP in exchange for a note payable due to the company ("stock redeem and re-leveraging"). In a stock redemption event, the shares are retained by the company after processing the benefit payments and held in treasury. In a re-cycling event, the shares retained by the plan after processing the benefit payments are reallocated among the remaining plan participants on an annual basis based on the ratio of participant eligible compensation paid for the year to total plan eligible compensation paid for the year. In a stock redeem and re-leveraging event, the shares obtained by the plan after processing the benefit payments are considered repurchased and held in trust by the plan (unallocated shares) as collateral for the related outstanding note payable. The company's board of directors have elected to fund all repurchase obligations to date since the plan's inception via recycling transactions.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - The plan follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Key parties of the plan** - The company is the employer, plan sponsor and plan administrator. ESOP Partners, Inc. is the third party administrator that maintains participant records and tax counsel that performs various compliance tests. First International Bank & Trust is the plan trustee.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates. The most sensitive estimate is the plan's estimate of the fair value of the company's common stock, the plan's primary investment, as described under the investments section.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through September 11, 2025, which is the date the financial statements were available to be issued.

**Risks and uncertainties** - Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with the plan's investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participant investment account balances and the amounts reported in the statements of net assets (deficit) available for benefits.

**Fair value measurements** - The plan's investments are nonparticipant directed and recorded at fair value. Separate investment accounts are maintained for each participant. Annual net appreciation (depreciation) on investments is allocated to the participants' investment accounts based on the ratio of individual allocated account balances to total allocated account balances. Annual net appreciation (depreciation) in fair value of investments held is reflected in the statement of changes in net assets (deficit) available for benefits. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the investments and valuation methodology used to measure fair value.

*The company's common stock* - Valued by an independent appraisal, based upon a combination of the income, asset and market valuation techniques. The appraiser took into account the company's financial information and also performed an industry and economic analysis (significant unobservable inputs). The independent appraisal determined a fair market value of \$14.38 and \$8.65 per share as of December 31, 2024 and 2023.

### 3. PLAN DESCRIPTION

The following description of the plan provides only general information. Participants should refer to the plan agreement for more complete information.

**General** - The plan was established on January 1, 2022 as a defined contribution plan. The plan is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - The plan covers substantially all employees of the company. Employees are eligible once they have reached age 21 and have been credited with at least 1,000 hours of service during the 12 consecutive months following date of hire or any plan year after the date of hire. For eligibility purposes, employees are credited any service time earned prior to the plan's inception based on service time earned under the CMA/Flodyne/Hydradyne, Inc. 401(k) Plan. Individuals enter the plan on the first day of the quarter immediately following completing the eligibility requirements.

**Vesting** - Participants become 20% vested in their account balances, which include all allocated investments, after two years of service and vest an additional 20% for each additional year of service. Service time with the company prior to the plan's inception is included in determining years of service for vesting purposes. Upon death, disability, attainment of age 65 while employed or termination of the plan, a participant becomes 100% vested.

**Distributions** - Benefit payments are recorded when paid. The company's common stock is not readily tradable on an established market and includes a put option. The put option provides each participant the right to require the company or the ESOP to repurchase the common stock at the fair value as determined by the latest independent appraisals. The purpose of the put option is to ensure that participants ultimately receive distributions in the form of cash. Distributions from the plan can be made as follows:

- a. Traditional benefit payments may commence upon attaining age 65 while still employed with at least ten years of service, termination of employment, death or disability. Subject to certain requirements as described in the plan document, and at the discretion of the company's board of directors, benefits will be paid in the form of a lump-sum distribution or in annual installments over a period of time. Scheduled installment payments may be accelerated or reduced in any given year at the discretion of the company's board of directors and could be dependent on the company's financial liquidity status.
- b. Diversification payments may be made to participants who complete ten years of service and attain age 55. Such eligible participants enter a "qualified election period" in which the participant may diversify their accounts. The "qualified election period" is a six year period beginning when the noted requirements are met. Participants will be allowed to diversify up to 25% of their account out of the company's common stock during the first five years and up to 50% of their account in the sixth year. Diversification will first apply for the plan year ending December 31, 2032.

**Forfeitures** - Forfeitures of nonvested account balances are reallocated on an annual basis to the remaining eligible participant accounts based on the ratio of participant eligible compensation paid in the plan year to total plan eligible compensation paid in the plan year. Forfeited nonvested accounts allocated to participant accounts, which consist of forfeited allocated shares of the company's stock, were \$7,000 in 2024.

**Administrative fees** - Certain administrative fees and other expenses of the plan are paid by the company and not included in these financial statements. Participants are charged individually for the processing of their benefit payments. Such fees are presented as other expense in the accompanying statement of changes in net assets (deficit) available for benefits.

**Voting rights** - Generally, the plan trustee will vote the shares of the company's common stock held by the plan, including shares allocated to participant accounts. Participants have the right to vote the shares of the company's common stock allocated to their account in situations requiring a vote of the company's stockholders with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all the assets of the trade or business or similarly significant corporate transactions, as determined by the company's board of directors. With respect to unallocated shares, or allocated shares for which the plan trustee does not receive direction from the participants, the plan trustee shall, in its sole discretion, vote the shares relating to the approval or disapproval of the aforementioned corporate matters.

## 4. TAX STATUS

The plan is operating under a Reinhart Boerner Van Deuren SC non-standardized pre-approved ESOP plan that received a favorable opinion letter on June 30, 2020. The letter from the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan; however, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

## 5. TERMINATION OF PLAN

The company reserves the right to terminate the plan at any time, subject to plan provisions. Upon termination of the plan, the plan sponsor would direct the plan to pay any liabilities and expenses of the ESOP and to sell the shares of the company's common stock that are held as collateral to the extent it determines such sale to be necessary in order to repay the related outstanding note payable. Subsequently, the interest of each participant in the plan would be distributed to such participant at the time prescribed by the plan terms and the IRC.

## 6. PARTY-IN-INTEREST

The plan holds shares of the company's common stock as its primary investment and, therefore, transactions between the plan and the company qualify as party-in-interest transactions. Interest expense recorded by the plan due to the company (see Note 7) was \$424,149 in 2024. In addition, the plan has a number of service providers. Any transactions between these providers, the company and the plan qualify as party-in-interest transactions.

All such party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

## 7. NOTE PAYABLE

The note payable due to the company bears interest at 3.43% and is secured by the unallocated shares of the company's common stock. Prepayments can be made at any time and are applied first to accrued but unpaid interest and then to payments of principal. Future scheduled annual principal and interest payments of \$631,737 are due through December 2056.
