## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of  
the Da/Pro Rubber, Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Da/Pro Rubber, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Da/Pro Rubber, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

**Note 1 - Description of the Plan**

The following description of the Da/Pro Rubber, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or summary plan description for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan established November 1, 1998, and subsequently restated. All employees of Da/Pro Rubber, Inc. (the “Company”) who have completed one year of service and are age 21 or older are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Changes**

Effective November 15, 2024, the Plan was amended to begin allowing Roth elective deferrals and hardship distributions. The amendment also increased the amount participants may contribute to the Plan from 15 percent of regular compensation to 90 percent and removed the \$200 limit on employer matching contributions. The Plan entry date was changed from semi-annually to the first of the month after meeting eligibility, and the eligibility period was changed from 1 year of service to 6 months of service. Lastly, the amendment removed partial payments as an allowable voluntary distribution type.

**Contributions**

The Plan allows participants to contribute up to 90 percent of regular compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified benefit plans (rollover contributions). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company matches 10 percent of participant contributions, subject to a maximum of \$200 annually, as defined in the Plan. The Plan also provides for Company profit sharing contributions of a discretionary amount subject to certain limitations, as defined in the Plan. No discretionary contributions were made during the years ended December 31, 2024 and 2023. All investments of contributions are participant-directed.

Employer and employee contributions receivable at December 31, 2024 and 2023, reflect amounts collected in late 2024 and 2023, respectively, but not remitted to the trust until early 2025 and 2024, respectively.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company matching contributions, an allocation of Plan earnings, and Company discretionary contributions, if any, and is charged with any benefit payments. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from their vested account.

### **Vesting**

Participants are immediately vested in their own contributions plus actual earnings or losses thereon. Participants begin vesting in Company contributions plus actual earnings or losses thereon ratably after two years of service and become fully vested after six years of service.

### **Forfeitures**

Upon termination of employment, participants forfeit their non-vested balances. Forfeitures may be used to reduce employer matching contributions or to cover certain administrative expenses. Plan provisions provide that forfeitures should be used within the year forfeited or the year after. Any remaining amounts should be allocated back to participants as an additional Company contribution. Unallocated forfeitures at December 31, 2024 and 2023 amounted to \$0. No forfeitures were used to reduce employer matching contributions or to cover administrative expenses during the 2024 Plan year.

### **Notes Receivable from Participants**

A participant may borrow up to the lesser of \$50,000 or 50 percent of the participant's vested account balance, subject to certain requirements in the Plan document. The loans are secured by the borrower's Plan account balance. Principal and interest is paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. At December 31, 2024 and 2023, outstanding loans totaled \$151,691 and \$121,523, respectively. Outstanding loans at December 31, 2024, bore interest at rates ranging from 3.25% to 8.5%.

### **Payment of Benefits**

On termination of service, a participant may receive a lump-sum amount equal to the vested value of his or her account, or upon death, disability, or retirement, elect to receive annual installments over a certain period as defined in the Plan document. Benefits are recorded when paid. There were no distributions requested in 2024, but not paid until 2025.

### **Administrative Expenses**

The Company may pay costs associated with managing the Plan. However, for the year ended December 31, 2024, the Plan paid all administrative costs. Total fees incurred by the Plan for the 2024 Plan year amounted to \$37,723.

### **Plan Amendments and Termination**

The Company may amend the Plan at any time, including amendments to conform to the Internal Revenue Code, Treasury Regulations and Rulings thereunder. Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time upon prior written notice to the Trustee and may direct the Trustee to liquidate the shares of participants in the trust fund subject to the provisions of ERISA. Upon termination or permanent suspension of contributions, the accounts of all participants affected thereby shall become nonforfeitable and shall be distributed.

## **Note 2 - Summary of Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan's management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date, and interest income is recorded on the accrual basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

### **Payment of Benefits**

Benefits are recorded when paid. Corrective distributions payable generally represent the distribution of certain assets to employees in order for the Plan to comply with nondiscrimination rules.

**Note 3 - Investments**

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$907,608. Capital gains of \$33,455 were reinvested during the 2024 Plan year. Interest and dividends earned on investments totaled \$74,306 over the same period.

**Note 4 - Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted observable quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Basis of Fair Value Measurement**

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
  
- Level 2      Inputs to the valuation methodology include observable inputs other than quoted active market prices, including quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, and inputs derived principally from or corroborated by observable market data by correlation or other means;
  
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

***Fair Value Measurements (Continued)***

Common collective trust: The common collective trust fund held by the Plan has a similar structure to a mutual fund and is valued based on the readily determinable quoted market price that the fund publishes daily. While the underlying assets are actively traded on the exchange, the common collective trust fund is not, and thus is classified as level 2.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables segregate all financial assets and liabilities as of December 31, 2024, and 2023, that are measured at fair value on a recurring basis (at least annually) into the most appropriate level within the fair value hierarchy based on the inputs used to determine the fair value at the measurement dates:

**Note 5 - Tax Status**

The Plan has received a determination letter from the Internal Revenue Service dated June 29, 1993, stating that the written form of the underlying Merrill Lynch special prototype plan document is qualified under Section 401(a) of the Internal Revenue Code

***Tax Status (Continued)***

(the “Code”) and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan has been amended since receiving the determination letter, however, the Plan Administrator believes the Plan is currently designed, and being operated, in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Delinquent Participant Contributions**

As reported on Form 5500, Schedule H, Line 4a - Schedule of Delinquent Participant Contributions, certain participant contributions were not remitted to the Plan within the time frame specified by the Department of Labor’s Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company. Late remittances amounted to \$34,949 for the 2024 Plan year. The Company is in the process of participating in the DOL’s Voluntary Fiduciary Corrective Program (VFCP) to determine the related interest (lost earnings) to be remitted to the Plan on behalf of the affected participants. Interest is not expected to be material to the financial statements.

**Note 7 - Information Certified by the Trustee**

The Ascensus Trust Company (formerly known as Frontier Trust Services Company) (the “Trustee”) is the trustee of the Plan for the years ended December 31, 2024 and 2023. Ascensus also served as the recordkeeper of the Plan for the same periods.

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 8 - Corrective Distributions Payable**

Per Internal Revenue Service (“IRS”) regulations, the Plan must perform compliance testing comparing the contributions made by and for highly compensated employees (“HCEs”) (as defined by the IRS) to those made by and for non-highly compensated employees (as defined by the IRS) to ensure the Plan does not disproportionately benefit the HCEs. For the year ended December 31, 2023, the Plan passed the Actual Deferral Percentage (“ADP”) test after recharacterization of certain participant contributions as catch-up contributions; however, one participant exceeded Plan contribution limits (15% of compensation on an annual basis) resulting in a corrective distribution payable of \$5,131 at December 31, 2023. The remaining payable balance at December 31, 2024, was \$2,968.
