INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of
Williams Hart & Boundas, LLP 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Williams Hart & Boundas, LLP 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



DECEMBER 31, 2024 AND 2023

NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Williams Hart & Boundas, LLP 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan provisions.

General

The Williams Hart & Boundas, LLP 401(k) Plan, as amended and restated April 18, 2023, was established January 1, 1995, as a defined contribution plan covering all eligible employees of Williams Hart & Boundas, LLP (the "Plan Sponsor" or the "Company") except non-resident aliens and employees covered by a collective bargaining, and residents of Puerto Rico. The Plan is a qualified plan as defined by Section 401(a) of the Internal Revenue Code and contains a provision for salary reduction contributions under Section 401(k) of the Internal Revenue Code. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of the Company are eligible to participate in the Plan following the completion of three consecutive months of service (at least 250 hours of service) with the Company, provided the employee has attained age 21. Upon eligibility, employees are allowed to enter the Plan on the 1st day of the month following the month the employee became eligible.

Contributions

Unless a participant affirmatively elects otherwise, the participant will be automatically enrolled to contribute 2% of their eligible compensation. The percentage will increase by 1% on the first day of each plan year thereafter up to a maximum of 6% unless the participant elects a different percentage.

Employees may elect to contribute up to 100% of their pretax annual compensation, as defined by the Plan, subject to Internal Revenue Service limitations. The contribution limit applies to any calendar year and is adjusted annually by the Internal Revenue Service. Participants who have attained the age of 50 before the end of the plan year may make additional pre-tax catch-up contributions. The Plan allows for rollover contributions from other qualified retirement plans. The Plan is participant directed. Participants may change their contribution rates at the beginning of each payroll period and investment options at any time.

The Company contributes 50% of participant deferrals up to a maximum of 5% of a participant's eligible annual compensation. Employees of the Company are eligible to receive discretionary employer contributions following the completion of three consecutive months of service for the discretionary matching and complete one year of service and be employed on the last day of the plan year with the Company to be eligible for the discretionary profit-sharing contribution, provided the employee has attained the age of 21.

NOTE 1: DESCRIPTION OF THE PLAN *(Continued)*

Participant Accounts

Each participant's account is credited with the participant's contributions and the Companies' contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative fees that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Benefits paid to participants under the Plan are limited to the vested balance in each participant's account.

Vesting and Payment of Benefits

Participants are always fully vested in their participant, rollover, and qualified non-elective contributions accounts and the appreciation or depreciation thereon. A participant shall be immediately vested upon death, retirement, or termination of employment due to permanent disability. The Company contributions vest according to the following schedule:

2	20%

6	100%

The normal retirement age under the Plan is the later of age 65. Participants who have attained the age of 59 ½ may receive distributions during employment. Hardship distributions are also available to employees in limited circumstances. Distributions are required for participants over 70 ½ to meet the minimum distribution requirements of Internal Revenue Code regulations. Except for minimum distribution requirements, payments to retirees, employees or separated employees are paid in either a lump sum or installment plan paid over a specified period. Separating participants may elect to rollover their account into another plan, as permitted by Internal Revenue Service regulations. Termination due to death, disability or retirement will allow a participant to elect to receive a lump sum amount equal to the value of the participant's vested account balance, in the form of a cash distribution, a direct rollover distribution, or a combination of both. For termination due to other reasons, a participant may receive the value of the account as a lump sum or can take a partial distribution.

NOTE 1: DESCRIPTION OF THE PLAN *(Continued)*

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance in the Plan. Interest rates on loans are stated at a reasonable rate. Loans are repaid in level installments through payroll deductions for periods ranging up to five years, and in certain situations may exceed five years. Loans are secured by the participant's vested account balance to the extent of the principal amount of the loan plus accrued interest. Principal and interest is paid ratably through payroll deductions. Participants may not have more than one loan outstanding at a time.

Forfeitures

Forfeitures of unvested balances are used to reduce the Company contributions (if any) to the Plan, reallocate to participants and to pay Plan expenses. In 2024, the employer contributions were reduced by \$12,228 from forfeited unvested balances. If the Company does not use forfeitures to reduce employer contributions or plan expenses, they may be allocated to eligible participants. Unused forfeitures for December 31, 2024 and 2023 were \$20,292 and \$4,077, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, each participant's account balance becomes 100% vested.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted by the United States of America ("GAAP")

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of additions and expense during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements. Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued and unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. At December 31, 2024 and 2023, no allowance was considered necessary by management.

Administrative fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative fees. Other investment-related expenses are included in net appreciation of investments.

Benefit Payments

Distributions to participants are recorded when paid.

NOTE 3: TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 4: PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024, the Plan paid its trustee \$3,515 in administration fees that are included in administrative expenses. The Plan believes the fees charged by its custodians' investments and its administrative fees are not significantly different than those that would be charged by other companies engaged in managing pension assets.

NOTE 5: ADMINISTRATION AND INVESTMENTS

As of December 31, 2024 and 2024, and for the year ended December 31, 2024, the Plan's investments were administered by John Hancock Trust Company (subsequently referred to as "John Hancock"), the trustee of the plan. Among other duties, John Hancock receives contributions, invests and reinvests the Plan's assets, collects income and makes distributions from the Plan's assets as directed by the Board of Directors of the Plan Sponsor.

The Plan pays for John Hancock's administration costs and the fees of other outside advisors. The Plan does not compensate the Plan Sponsor for its internal costs related to the administration of the Plan.

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, John Hancock has certified to the completeness and accuracy of all investments and note receivables from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 6: RISKS AND UNCERTAINTIES

Plan participants make choices regarding their investments securities, and are exposed to risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that reductions in value can occur in the near term and that such changes could materially affect participant account balances reported in the statement of net assets available for benefits.

NOTE 7: UNCERTAIN TAX POSITIONS

The Plan did not have unrecognized tax benefits as of December 31, 2024 and 2023 and does not expect this to change significantly over the next twelve months. The Plan will recognize interest and penalties accrued on any unrecognized tax benefits as a component of income tax expense. As of December 31, 2024 and 2023, the Plan has not accrued interest or penalties related to uncertain tax positions.

NOTE 8: FAIR VALUE MEASUREMENTS

ASC 820-10 provides standards and disclosures for assets and liabilities that are measured and reported at fair value. As defined in ASC 820-10, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). ASC 820-10 requires disclosure that establishes a framework for measuring fair value and expands disclosure about fair value measurements. The statement requires fair value measurements be classified and disclosed in one of the following categories:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2: Measured based upon inputs that are observable, either directly or indirectly, for the asset or liability other than quoted market prices included in Level 1. These inputs include: a) quoted prices for similar asset or liabilities in active markets b) quoted prices for identical or similar assets or liabilities in markets that are not active c) inputs other than quoted market prices that are observable and d) inputs that are derived primarily from or corroborated by observable market data by correlation or other means.

Level 3: Measured based on unobservable inputs for the asset or liability for which there is little, if any, market activity for the asset or liability at the measurement date. This input includes management's own assumptions about the assumptions that market participants would use in pricing the asset or liability. The inputs are developed based on the best information available in the circumstances, which might include management's own data.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds:

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund:

This class consists of commingled funds that primarily invest in diversified fixed income funds and separately managed bond accounts. The collective trust allows for daily redemption and investments and does not have a participant level holding period. There are no unfunded commitments for investments in the collective trust fund. The collective trust fund represents investments in the John Hancock Stable Value Fund.
