## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
of The Grand Healthcare System 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of The Grand Healthcare System 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Grand Healthcare System 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1 - Description of the Plan

The Grand Healthcare System 401(k) Plan (the "Plan") is a multiple-employer contributory defined-contribution plan. The sponsor of the plan is Strauss Ventures, LLC d/b/a The Grand Healthcare System. Employers in the Plan are as follows:

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan, which was adopted and established effective July 1, 2017, is a defined contribution plan which covers substantially all eligible employees of the participating employers at their date of hire with the ability to enroll on the first date of each month, and provides for a deferred compensation arrangement as described in Section 401(k) of the Internal Revenue Code (the "Code"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

## Notes to Financial Statements Years Ended December 31, 2024 and 2023

### Note 1 - Description of the Plan (continued)

#### Contributions

Each year, participants may contribute to the Plan a portion of their pretax annual compensation as defined in the Plan, subject to limitations as defined in the Code. The Plan's contributions are discretionary and determined annually by the Plan's management. There are two contribution formulas; (1) a discretionary matching contribution equal to a percentage of the amount of the salary reduction the participant has elected to defer and (2) a discretionary contribution equal to the percentage of the eligible participant's compensation plus a percentage of each eligible participant's compensation in excess of the Social Security wage base with defined limitations.

For the years ended December 31, 2024 and 2023, the Sponsor made voluntary matching contributions of \$515,210 and \$482,284, respectively.

#### Investment Options

The Plan offers its participants various investment options. Upon enrollment in the Plan, each participant may direct employee contributions in 1% increments in any of the investment options. Participants may change their investment options daily.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Sponsor's contributions, and allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations of the Plan's earnings are based on individual participant's account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Sponsor's contributions to the Plan is based on years of continuous service. A participant becomes fully vested according to the following schedule:

Participants are fully vested at all times in their voluntary contribution amounts. Participants are fully vested in the total value of their account if they are working for the Employers upon reaching retirement age, death or disability.

### Note 1 - Description of the Plan (continued)

#### Forfeitures

Participants who terminate employment before they vest will forfeit their interest in their employer contribution accounts. Forfeitures may be applied to pay Plan expenses or may be used at the discretion of the Sponsor to reduce the Sponsor's discretionary matching contribution. At December 31, 2024 and 2023, non-vested forfeited accounts had a balance of \$117,390 and \$73,628, respectively. During 2024 and 2023, there were \$40,795 and \$35,366, respectively, of new forfeitures and \$2,677 and \$1,532, respectively, was offset to expenses. In addition, during 2024 and 2023, \$0 and \$780, respectively, of forfeitures was used to reduce the Sponsor's discretionary matching contribution.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

#### Payment of Benefits

Upon termination of service, a participant is entitled to receive the value of his or her account in a lump sum or other payment methods.

#### Plan Termination

Although the participating employers have not expressed any intention to terminate the Plan, they may do so at any time subject to the provisions of ERISA. In the event the Plan is terminated, participants would become 100 percent vested in their accounts.

### Note 2 - Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an assets or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for a discussion of fair value measurement.

Purchases and sales of investments are recorded on the trade date basis. Dividends are recorded on the ex-dividend date and reinvested into the respective fund. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Several of the investment fund options are subject to investment fees based upon a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's performance and thus are not separately disclosed in the accompanying financial statements. All other administrative expenses related to the plan are paid by the Plan.

### **Date of Management's Review**

In preparing these financial statements, the Company has evaluated events and transactions through October 10, 2025, which is the date the financial statements were available to be issued.

### **Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
  - Quoted prices for similar assets or liabilities in active markets.

- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 5 - Income Tax Status**

The Plan has adopted a non-standardized pre-approved profit sharing plan with CODA and is relying on an advisory letter received from Fidelity Management & Research Co. dated June 30, 2020 stating that the Internal Revenue Service has determined that the non-standardized pre-approved plan adopted by the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the advisory letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more than likely would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Party-in-Interest**

Certain plan investments are managed by Fidelity Management Trust Company, the trustee of the Plan. These transactions are considered to be party-in-interest transactions.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 – Non-discrimination Testing**

The Plan is subject to certain IRS non-discrimination testing requirements each Plan year. At December 31, 2024 and 2023, the Plan was not in compliance with the IRS. There was no material nondiscrimination testing liability in 2024 and 2023.

**Note 9 – Delinquent Contributions**

In 2024, the sponsor failed to remit participant contributions in a timely manner. The sponsor identified 10 instances for a total of \$11,908 in 2024, in which participant contributions were remitted to the Plan in violation of the Department of Labor (DOL) regulations. The Sponsor estimated the amount of corrective payments due to the plan and determined that the amount was immaterial.
