#### ***Opinion***

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Master Security Company, LLC Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan and Trust were established April 1, 2014 to provide health and other benefits to eligible participants. The Plan is subject to the provisions of the ERISA, as amended.

**Eligibility**

Employees are eligible to participate in the Plan on the first day of the month following one month of continuous employment.

Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Plan management makes contributions to the Plan on their behalf. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

**Contributions**

The Company makes monthly contributions for participating employees covered under the Plan. For employees covered under contracts issued by Federal, State, municipal or other contracting authorities which require the payment of specified fringe dollar amounts, the Company contributes to the Plan based upon an hourly funding formula. Employer contributions are recognized as income in the month the employees worked. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis. In addition to deductibles and copayments, participants may contribute specified amounts to extend coverage to their eligible dependents.

**Benefits**

The Plan provides medical, dental, prescription, vision, death and accidental death and dismemberment benefits for eligible participants and their beneficiaries. The Plan provided these benefits through various annual contracts with insurance companies. Premiums for these insured benefits were paid to the insurance company directly from the assets of the Plan. The Plan also provides some dental benefits on a self-funded basis.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Concentration of Credit Risk**

The Plan's cash balances are held at one financial institution located in California. Accounts at this institution are insured by a government agency up to \$250,000. At times the balances in these accounts may exceed the insured limit.

**Contributions Receivable**

Employer contributions due but not paid at year-end are recorded as contributions receivable. There was no allowance for uncollectible accounts as of December 31, 2024 and 2023.

**Payment of Benefits**

Premiums paid by the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Benefits are recorded when paid. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of plan's benefit obligations.

**Insurance Premiums Payable**

Insurance premiums payable are based upon the actual premiums due for December 31, 2024 and 2023, but paid by the Plan after year-end.

**Benefit Claims Incurred But Not Reported**

The obligation for dental benefit claims incurred but not reported is an estimate for self-funded benefits incurred on or prior to December 31, 2024 and 2023, but reported to and paid by the Plan after year-end. The estimates is based on certain assumption applying to claims lag and historical claims data.

**Administrative Expenses**

All administrative expenses may be paid out of the Plan unless paid by the Company. The Plan pays for substantially all administrative expenses, which consist of administration fees, accounting fees, and other miscellaneous expenses.

**Income Taxes**

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes. The Plan is required to pay federal and state taxes on unrelated business income as defined by Internal Revenue Code Section 512(e)(3)(E). Unrelated business income consists of the investment income earned on the excess of the net assets available for benefits over the required reserve balance allowable under the Internal Revenue Code. The Plan had no investment income during the Plan year ended December 31, 2024.

**Subsequent Events**

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

**NOTE 3 TAX STATUS**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 PLAN TERMINATION**

Effective September 30, 2024, the Service Contract Act (SCA) contract for which this Plan was established to cover health and welfare benefits for these SCA employees expired and was not renewed. In addition, contributions to the Plan were discontinued after September 30, 2024, as no longer required. The Plan is in the process of funding remaining benefits to the participants and winding down activities of the Plan. Any additional contributions needed to fund current benefit obligations will be paid by the Plan sponsor. It is the intention of the Plan sponsor to terminate the Plan and Trust when winddown activities are completed.
