## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator  
CJL Engineering 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of CJL Engineering 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from John Hancock Life Insurance Company, a qualified institution, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

### NOTES TO FINANCIAL STATEMENTS

#### 1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of CJL Engineering 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

*General* - The Plan, established effective January 1, 1993, is a defined contribution plan which covers substantially all employees of Dynamic Design Engineering, Inc. d/b/a CJL Engineering (the "Sponsor") who have attained the age of 18. Employees are eligible to enter the plan on the first day of the month following the date on which they complete three months of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

*Basis of Accounting* - The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

*Use of Estimates* - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of changes in assets during the reporting periods. Actual results could differ from the estimates.

*Cash Equivalents* - The Plan considers all highly liquid debt securities with original maturities of three months or less to be cash equivalents.

*Investment Valuation and Income Recognition* - Investments in pooled separate accounts are carried at their fair values based on published quotations or, in the absence of readily ascertainable market values, at such values as the custodian determines. The Plan presents net appreciation (depreciation) in the fair value of its investments, which consists of unrealized appreciation and depreciation as well as realized gains and losses. The unrealized appreciation (depreciation) of investments is determined by the change in current fair value from the beginning of the year (if held for the entire year) to the end of the year, or from the date of purchase to the end of the year. The realized gains (losses) are determined by the change in value from the date of purchase to the date of sale.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned.

*Contributions* - Participants may elect to contribute to the Plan up to the limit established by the Internal Revenue Code. The Plan contains an auto-enrollment provision for new participants, under which 3% of participant compensation is deferred into the Plan; however, affirmative elections may be made to contribute less or more than the 3%. The Plan also accepts rollover contributions from other qualified plans.

Under safe harbor provisions, the Plan provides for employer nonelective contributions of not less than 3% of participant compensation as defined in the plan document. For each of the years ended December 31, 2024 and 2023, employer nonelective contributions were 3% of participant compensation and were reflected as employer contributions receivable at each respective year-end. The employer contributions for the years ended December 31, 2024 and 2023 were made in January 2025 and February 2024, respectively.

The Plan also provides for discretionary employer profit sharing contributions. There was not an employer profit sharing contribution for the year ended December 31, 2024 or 2023.

*Participant Accounts* - Each participant's account is credited with the participant's contribution, employer contributions and investment income. Investment income is allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Investment Options* - Participants may direct their contributions as well as their share of employer contributions and any related earnings into various investment options. The Plan is invested in various pooled separate accounts and a group annuity contract maintained by John Hancock Life Insurance Company.

*Fair Value Measurements* - U.S. GAAP has established a framework for measuring fair value of financial assets. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs are not quoted prices in active markets but they are observable either directly or indirectly.
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

At December 31, 2024 and 2023, the pooled separate accounts are valued at net asset value (NAV). The NAV is estimated to approximate fair value because the pooled separate accounts can be traded on a daily basis at NAV, and because NAV is based on the closing prices of the underlying investments as reported in their respective active markets (level 1 measurement).

The method described above may produce fair value calculations for the pooled separate accounts that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with that of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

The Plan's fully benefit-responsive group annuity contract is reported at contract value, which is the relevant measurement attribute because contract value is the amount participants would receive if they were to initiate permitted transactions of the Plan (see Note 2).

*Notes Receivable from Participants* - Participants are able to borrow up to 50% of their vested account balance up to \$50,000. The amount of the loan is required to be at least \$1,000. Loans are generally required to be repaid over a five-year period with payments to be made not less frequently than quarterly. Loans are charged a fixed, commercially reasonable rate of interest. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. At December 31, 2024 and 2023, the interest rates on outstanding loans ranged from 4.25% to 9.5%.

*Benefits* - Upon termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. The form of payment is a lump-sum distribution. The Plan also permits in-service distributions for participants age 59.5 years and above who are still employed by the Sponsor.

*Vesting* - Participants are immediately vested in their voluntary contributions, rollover contributions and employer nonelective contributions, plus investment income thereon. Vesting of employer matching contributions (made in prior years) and profit sharing contributions, plus investment income thereon, is according to the following schedule:

2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

*Forfeitures* - When a participant withdraws from the Plan prior to becoming fully vested, the nonvested portion of the participant's account is utilized to reduce future employer contributions. Forfeitures were not significant during the year ended December 31, 2024 or 2023. The balance of cash equivalents at December 31, 2024 and 2023 represents the available forfeitures.

*Administrative Expenses* - Contract administration fees are paid by the Plan to John Hancock Life Insurance Company, while other administrative expenses are assumed by the Sponsor as provided by the plan agreement.

*Subsequent Events* - Management has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

## **2. GROUP ANNUITY CONTRACT**

The Plan holds a fully benefit-responsive group annuity contract, the John Hancock Stable Value Fund, which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. John Hancock Life Insurance Company is contractually obligated to repay the principal and a specified interest rate that is guaranteed.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by John Hancock Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with John Hancock Life Insurance Company. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The group annuity contract does not permit John Hancock Life Insurance Company to terminate the agreement prior to the scheduled maturity date.

### **3. CERTIFIED FINANCIAL INFORMATION**

John Hancock Life Insurance Company, the custodian, has certified that the following data included in the accompanying financial statements is complete and accurate.

- Investments and notes receivable from participants, as shown in the statements of assets available for benefits at December 31, 2024 and 2023.
- Investment income, as shown in the statements of changes in assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets held for investment purposes at December 31, 2024, as shown on the accompanying schedule.

### **4. PLAN TERMINATION**

The Sponsor anticipates and believes that the Plan will continue without interruption but reserves the right to discontinue the Plan at its discretion. In the event that such discontinuance results in the termination of the Plan, all employer amounts credited to participant accounts become 100% vested. The net assets of the Plan will be distributed by the custodian in accordance with the trust agreement in a uniform and nondiscriminatory manner.

### **5. INCOME TAX STATUS**

The Plan is based on a standardized, pre-approved plan sponsored by John Hancock Life Insurance Company. The Internal Revenue Service has stated in a letter dated June 30, 2020 that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management believes that there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to tax examinations for years before December 31, 2021.

### **6. RELATED PARTIES AND PARTIES-IN-INTEREST**

John Hancock Life Insurance Company serves as custodian of the Plan and also provides access to the pooled separate accounts and the John Hancock Stable Value Fund as investment options and, accordingly, is considered a party-in-interest.

Neither the Sponsor nor the employees of the Sponsor involved in administering the Plan receive any compensation from the Plan.
