**Note 1 - Plan Description**

First Class Air Support Inc. is an adopting employer in TPC Qualified Plans LLC Retirement Savings Plan (the "TPC Plan"), which is intended to be a multiple-employer retirement plan. The adopting employers and plan sponsors of the TPC Plan do not have a preexisting relationship, and, therefore, the TPC Plan is considered to be an open multiple-employer plan. Based on the Department of Labor (DOL) Advisory Opinion 2012-04A, each adopting employer of the TPC Plan is treated as a separate single-employer plan. The following description of TPC Qualified Plans LLC Retirement Savings Plan - First Class Air Support Inc. (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering substantially all eligible employees of First Class Air Support, LLC and Cargo Repair, LLC (collectively, the "Company"). Effective January 1, 2024, employees of Aviation Inflatables, LLC and Survival Products, LLC were eligible to participate in the Plan. Effective January 1, 2025, employees of Air Cargo Equipment, LLC; Cobalt Aero Services, LLC; and Innodyne Systems, LLC were eligible to participate in the Plan. All employees who have attained the age of 18 and have completed at least three months of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

The Plan provides for employee salary deferral contributions subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2023 that related to the Aviation Inflatables, LLC plan that was merged in, as disclosed in Note 6, were paid after the time frame required by the Department of Labor. The Company remitted a portion of these contributions to the Aviation Inflatables, LLC plan during 2023 and remitted the remaining contributions and related lost earnings to the Plan in July 2025.

The Plan provides for employer matching contributions of 100 percent of the participant's contribution up to 3 percent of the employee's deferred compensation and 50 percent of the participant's contribution that exceeds 3 percent of the employee's deferred compensation up to 5 percent of the employee's deferred compensation.

The Company may make annual profit-sharing contributions. Participants who have completed 1,000 hours of service and are employed at year end unless due to retirement, disability, or death will be eligible to receive an allocation of the company profit-sharing contribution. There was no profit-sharing contribution for the year ended December 31, 2024.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

***Vesting***

Participants are immediately 100 percent vested in employee salary and rollover contributions, employer matching contributions, and any income or loss thereon. Vesting in the Company's profit-sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of service.

The Company's profit-sharing contributions, if any, vest according to the following schedule:

***Benefit Payments***

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount or installments equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

***Party-in-interest Transactions***

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation***

The Plan's investments are stated at fair value, based on quoted market values.

See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Administrative Expenses***

Various administrative costs are paid by the Company.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 9, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Mid Atlantic Trust Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

**Note 4 - Tax Status**

The TPC Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code (IRC). Although the TPC Plan has been amended since receiving the determination letter, management believes that the TPC Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 5 - Fair Value Measurements (Continued)**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan measures mutual funds and the money market fund at fair value on a recurring basis. The fair value of mutual funds and the money market fund is based primarily on Level 1 inputs, as described above.

**Note 6 - Plan Merger**

Effective January 2024, the Aviation Inflatables, LLC plan, a plan sponsored by the Company, was merged with the Plan. Accordingly, assets and participant accounts totaling \$1,155,969 were transferred into the Plan effective January 1, 2024.

**Note 7 - Nonexempt Transactions**

In 2024, the Company received a payment from the Plan totaling \$626 that resulted in an inadvertent loan. As such, this transaction is considered a nonexempt transaction under ERISA and DOL guidelines. The Company expects to repay the Plan and pay the required excise taxes in 2025.

**Note 8 - Subsequent Events**

Subsequent to year end, the Air Cargo Equipment Inc. 401(k) Plan and Cobalt Aero Services LLC 401(k) Plan were merged into the Plan. Accordingly, assets and participant balances of approximately \$1,780,000 were transferred into the Plan.
