## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of D & S Electrical Contractors, Inc. Profit Sharing Plan and Trust, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of D & S Electrical Contractors, Inc. Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## **Note 1. Description of the Plan**

The following description of the D & S Electrical Contractors, Inc. Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

### **General**

The Plan is a defined-contribution plan sponsored by D&S Electrical Contractors, Inc. (Company) for the benefit of its employees that performed work subject to state of Washington prevailing wage laws and other employees who have one year of service, with at least 1,000 hours, and are at least age 21. Employees are eligible upon hire if performing services under prevailing wage contracts. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Capital Bank and Trust Company (Capital Bank) serves as the Plan trustee. American Funds, a division of Capital Bank, serves as the custodian of the Plan. Future Plan by Ascensus (Ascensus) serves as the Plan recordkeeper.

### **Contributions**

The Plan does not permit employee contributions. Rollover contributions are allowed. The Company may make a prevailing wage contribution on behalf of each participant who performed services subject to the *Service Contract Act*, *Davis-Bacon Act* or similar Federal, State, or Municipal Prevailing Wage statutes. The prevailing wage contribution is an amount equal to the balance of the fringe benefit payment for health and welfare for each participant (after deducting the cost of cash differential payments for the participant) based on the hourly contribution rate for the participant's employment classification. The amount contributed was 13% of eligible compensation for December 31, 2024 and 2023 for all employees working on prevailing wage projects or non-prevailing wage projects.

The Company may make employer profit-sharing contributions as determined by the Company's Board of Directors for those eligible employees not subject to prevailing wage contributions. Profit-sharing contributions of \$195,000 and \$175,000 were determined for the years ended December 31, 2024 and 2023, respectively, and deposited the subsequent year. Contributions are subject to certain limitations.

### **Participant Investment Account Options**

Investment account options available include various mutual funds. Each participant has the option of directing his contributions into any of the separate mutual funds and may change the allocation daily.

### **Participant Accounts**

Each participant's account are credited with the Company's contribution and Plan earnings and are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that could be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in all prevailing wage contributions plus earnings thereon. Vesting in the Company's profit-sharing contribution portion of the participants' accounts, plus earnings thereon, is based on years of credited service. A participant is fully vested after six years of credited service; vesting 20% each year after one year of service.

***Payment of Benefits***

Upon termination of service, a participant can elect to receive a lump-sum amount equal to the value of his account or a joint and survivor annuity. Withdrawals other than for termination are permitted only if normal retirement age (age 65) has been reached.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$101 and \$97, respectively. These accounts will be used to pay administrative expenses or reallocated as additional employer contributions. No forfeitures were used to reduce employer contributions during 2024 and 2023.

***Notes Receivable From Participants***

Participant loans are not allowed by the Plan.

***Plan Termination***

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions, plus earnings thereon.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Plan Tax Status***

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan sponsored by Ascensus LLC. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter, as the nonstandardized prototype document has received favorable opinion letters from the IRS. The Plan has been amended since the prototype received the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 2 or Level 3 investments held by the Plan.

**Note 5. Party-in-Interest Transactions**

Party-in-interest transactions included those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan invested in certain funds of the Plan custodian. The Plan paid \$3,003 and \$575 of administrative fees to Capital Bank during the years ended December 31, 2024 and 2023, respectively. The Plan paid administrative fees of \$11,615 and \$4,129 to Future Plan by Ascensus during the years ended December 31, 2024 and 2023, respectively. The Plan paid other professional fees of \$15,713 and \$10,120 during the years ended December 31, 2024 and 2023.

The Plan maintains a revenue sharing account in which credits of approximately \$34,000 and \$27,000 were used to pay Edward Jones for investment advisory fees during the years ended December 31, 2024 and 2023, respectively. There were \$55,933 and \$47,313 of credits received in the Plan expense account during 2024 and 2023 that are used to offset administrative expenses. There was approximately \$34,083 and \$59,843 of Plan expense account credits available for use as of December 31, 2024 and 2023, respectively.

The Company provides certain administrative services at no cost to the Plan.

**Note 6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7. Subsequent Events**

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.
